### III-B. QUASI-JUDICIAL PUBLIC HEARINGS

-  2. **SE-01-10** – A Special Exception request by Lauralee G. Westine, Agent for AT&T Mobility, LLC, pursuant to Chapter 26, Article 16, Section 16.8, of the City Code of Ordinances to modify a previously approved Special Exception for a 110 foot high wireless communication facility with a minimum of three (3) carriers to allow a replacement 150 foot high wireless communication facility be constructed to facilitate up to six (6) carriers, a use that is permitted by Special Exception approval within the Public

(P) zoning district, per Chapter 26, Article 3, Section 3.12.(g), specifically addressed as 1625 Aqui Esta Drive, Punta Gorda, FL 33950. 
