# City Manager

• Citizens Academy – Applications are now being accepted for the upcoming 2020 Citizen Academy. • Alert Punta Gorda – The City of Punta Gorda has implemented Alert Punta Gorda, a new public safety emergency alert and community notification system. Alert Punta Gorda will allow the Punta Gorda Police Department and Punta Gorda Fire Department to contact the community in emergency situations that require the public's immediate attention and to make non-

emergency community notifications. Residents are encouraged to sign up by visiting **www.AlertPuntaGorda.com** and creating an account. Once the account is created you can choose whether you want to want to receive alerts through a home or business phone call, mobile phone call, email, text message, or through the Everbridge mobile phone app (available through the Apple App Store or Google Play). You will automatically be signed up to receive emergency alerts and can sign up



to receive non-emergency alerts based on your preferences. You can change your contact information and notification preferences at any time or can stop receiving alerts simply be removing your information from your account. We encourage all of our residents to sign up to ensure that you receive important information in a timely manner.

• International City Managers Association (ICMA) Conference – The Journey to the Future (JTTF) event co-chaired by TEAM Punta Gorda, CEO, Nancy Johnson and City Communications Manager, Melissa Reichert, was held in January of 2019 to prepare residents for participation in the PLAN Punta Gorda Citywide Master Plan process. This event is being recognized by ICMA as a best practice in engaging everyone in community visioning. Information about the process used, organizations involved, and impact of engaging the community in creating a vision for the future will be shared with City Managers and key staff representing municipalities across the country and internationally at the ICMA conference.

• City of Punta Gorda Water Customers – Dropcountr (the vendor for the City's water portal) will be sending out an email that customers will receive stating:

This is a free tool that allows you to track your water use, compare it to similar households, receive leak alerts, and access direct customer support. You can learn more about this program here. The Dropcountr app will help residents keep track of their water use, avoid leaks and water damage, connect with utility alerts and receive direct customer support. Not to mention, Dropcountr users reduce their water consumption by 7-9%, on average, leading to significant water and wallet savings. ## **Urban Design**

- Staff attended the regularly scheduled meeting of Charlotte County-Punta Gorda Metropolitan Planning Organization (MPO) Bicycle/Pedestrian Advisory Committee (BPAC). Discussions included:
  - ✓ Proposed SUN Trail realignment in order to better position the BPAC to receive grant funding from the State.
  - ✓ Status report of the MPO's Long Range Transportation Plan.
  - ✓ Individual reports from the State Bicycle/Pedestrian Coordinator, Charlotte County, City of Punta Gorda, and Charlotte County Sheriff's Office.

The next scheduled meeting of the BPAC is December 5, 2019.

• The Florida Department of Transportation (FDOT) held a public meeting in Punta Gorda this week to help create a Corridor Vision Plan for US 41 (Tamiami Trail) in Charlotte County. The goal for this effort is to formulate a Corridor Vision Plan that will be reflective of where your community would like to be and how FDOT, as a partner, can better understand your needs. If you missed this meeting and would like your voice to be heard FDOT is hosting another public input meeting this coming Tuesday Oct. 22 at the First Alliance Church - Family Life Center at 20444 Midway Blvd Port Charlotte from 5:30 p.m. to 7:30 p.m.

### **Engineering**

- Ponce de Leon Park Boardwalk: Staff met with the contractor to assess pilings. A statement of work is being prepared prior to authorize the start of work.
- Taylor/Marion Streets Bollards: Bollard installation and electrical work continues.
- Alligator Creek pedestrian bridges along US 41 NB-FDOT Right of Way: Work continues with preparing rebar and forms for proposed cap construction. The work area, north and south of the north fork Alligator Creek Bridge parallel to US 41 NB, remains closed to pedestrians and cyclists until further notice.
- Citywide Drainage Swale Regrading: The contract has completed work at 513 properties totaling 385,400 square feet of grading/sodding. Work was completed this week between 405-449 Scarlet Sage and 448-454 Scarlet Sage. The contractor will be working on cleanup and punch list items in Burnt Store Meadows and has anticipates work to begin in Burnt Store Isles the week of Oct. 28.
- Veterans Park Phase II: Site demolition and digging for footers continues.

### **Canal Maintenance**

• Repairs: Crews filled 26 depressions and performed 5 seawall cap and seam patches.

• **Buckley's Pass:** Seawall panel installation is complete. Helical anchors and waler boards are being installed. activity happening in the City, they should call the police department's non-emergency number at (941) 639-4111 or 911 in an emergency.



  - A safe meeting place outside, in front of the home, where everyone will meet after they exit the house



• Groundwater Reverse Osmosis Water Treatment Plant: Week 69 work continues on the interior of the RO Plant Process Building.

# **Water Treatment Plant Operations**

- 36.7 MG of water was delivered to the distribution system with a 5.2 MG daily average
- Peace River Manasota Regional Water Supply Authority Emergency Interconnect Receiving water at a rate of .5 million gallons per day, started Sept. 30.
- Rainfall in Oct. 2018 .05" Oct. 2019 2.12"
- Hardness is a measurement of calcium and magnesium ions naturally occurring in the raw water.
  Current Condition "hard" Grains of Hardness 15 ppm Total hardness 256 ppm
- TDS for Oct. 17 Current 440 ppm, Low 257 ppm, High 440 ppm, 10 Year Avg. 343 ppm
- Reservoir Oct. 17– Current 5.10', Record Low 5.04', Record High 6.34', 54 Year Avg. 5.34'




• Lawn watering is limited to twice per week (if needed) from 6 p.m. to 8 a.m. by property address. Hand watering and micro-irrigation of plants (other than lawns) can be done on any day and at any time using a shut-off nozzle on their hose, so water isn't wasted.

# Current Board & Committee Vacancies (Volunteer Appointment Information Form)

- Code Enforcement Board (One alternate vacancy) Meets the fourth Wednesday at 9 a.m. in City Council Chambers. Must be City resident. Seven-member board with two alternate members. Three-year terms maximum of three terms. Hears and decides alleged violations of the City Code of Ordinances.
- Police Officers' Pension Board (One regular vacancy) Meets quarterly and as called in Council Chambers. Five members two City residents at large, two police officers and one member appointed by appointed by the Board. Four-year terms no maximum. Charged with management of the Police Officers' Pension Fund.
- Punta Gorda Isles Canal Advisory Committee (One regular vacancy) Meets the third Monday at 1:30 p.m. in City Council Chambers. Must be a resident of Punta Gorda Isles. Seven-member board. Three-year terms maximum of three terms. Makes recommendations to City Council on effective maintenance of existing canals, waterways and navigable channels within the district, together with the maintenance and reconstruction of seawalls. Holds public hearings and makes final decision on petitions for special permit to the provisions of Section 6-6(c) of the City Code of Ordinances.
- Historic Preservation Advisory Board (Three vacancies) Meets the 4th Thursday at 9 a.m. in City Council Chambers. Must be City resident. Seven-member board with two alternate members. Three-year terms maximum of three terms. Identifies for the City Council historically significant structures and sites that should be considered for designation as a "Local Historic Landmark" or be nominated for listing on the Florida Master Site File and the National Register of Historic Places. Makes recommendations of the policies for the protection of historically significant structures and sites. Makes recommendations to staff with regard to certificates of appropriateness for any demolition, variance, sign or relocation of structures. Promotes public awareness of historic archaeological preservation and its community benefits.
- Board of Zoning Appeals (One alternate) Meets the 4th Tuesday at 4 p.m. in City Council Chambers. City residency required. Seven-member board with two alternate members. Three-year terms maximum of three terms. Financial disclosure required. Makes recommendations to City Council on variances to City Code.
