

WEEKLY HIGHLIGHTS REPORT OCTOBER 25, 2019

City Manager

- Water Quality As was highlighted in the Oct. 4, and Oct. 11, Weekly Highlights Report and noticed in the Charlotte Sun on Oct. 7, water customers were notified of a finding of out of range TTHM's in the water supply. The City of Punta Gorda Utilities Department has resampled water at the site multiple times and an independent lab has found the samples to be in compliance. The water is safe to drink.
- Citywide Master Plan At their Nov. 6 meeting City Council will consider a resolution accepting the 2019 Plan as prepared by Dover Kohl & Partners. If accepted, Council will also consider a request to have Dover Kohl produce Comprehensive Plan changes and revised Land Development Regulations based on recommendations included in the Master Plan. A couple of years ago City staff presented to City Council consideration of form based codes in the downtown area to include discussion of height, architecture, setbacks, landscaping, open space and other amenities. Rather than direct staff to develop revised land development regulations based on form codes at that time, City Council undertook a proposal process and secured the services of a planning firm (Dover Kohl) to prepare a new Citywide Master Plan. Included in the Plan are the following recommendations that Dover Kohl feels should be in the immediate horizon for implementation:
 - o Revise the Comprehensive Plan to permit zoning/land development changes that will allow reasonable intensity, density and predictability.
 - Consider the adoption of a form-based code in key areas and along key corridors. The
 regulations within this code should conform to the qualities and intent of the Future
 Character Areas detailed in the Master Plan.
 - Evaluate and revise Downtown's overlay districts to ensure they are compatible with the Citywide Master Plan goals and with any zoning and regulatory changes.
 - o Adopt the Investment Sector Map to inform public and private investment priorities, as well as stable areas that should be preserved.
 - Ensure the local historic district designations do not impose additional development barriers to key development opportunity sites.
 - Study and adopt an intensity bonus program which grants additional bonus development in exchange for a pre-delivered set of community benefits such as affordable housing, cultural and arts-related space, and public open space.

While the City's urban design staff possess the technical expertise to undertake revisions to the Comprehensive Plan and Land Development Regulations, current workload and ability to maintain current level of service hinders staff's ability to produce the above scope of work in a timely manner. Thank you to all who have participated in and continue to be involved in PLAN Punta Gorda Citywide Master Plan. This has been a planning process that has had valued participation from residents, business representatives and many organizations throughout the community. The level of resident engagement in the community is one of the many things that make Punta Gorda a great place to be.

• International City Managers Association (ICMA) Conference – The story of Journey to the Future community engagement was shared with City Managers and key staff from across the country and internationally this past week. Other key conference areas of focus were crisis management, fostering innovation, creating healthy communities, crowd sourcing and non-cash employee benefits. The learnings from this conference can be integrated into future planning for the City of Punta Gorda.



- Citizens Academy Applications are now being accepted for the upcoming 2020 Citizen Academy. This is a free, eight session courses of interactive classes designed to provide insight into City government and to develop future leaders through well informed and civically engaged residents. Public Works

Engineering

- Taylor/Marion Streets Bollards Bollard installation and electrical wok are complete.
- Alligator Creek pedestrian bridges along US 41 NB-FDOT Right of Way Cap formwork continues. Tentatively the beams are scheduled for placement on Nov. 7, 2019. Contractors Work Area is north and south of the north fork Alligator Creek Bridge parallel to US41 NB remains closed to pedestrians and cyclists until further notice.
- Citywide Drainage Swale Regrading –The contract has completed work at 513 properties totaling 385,400 square feet of grading/sodding. Work was completed this week between 405-449 Scarlet Sage and 448-454 Scarlet Sage. The contractor will be working on cleanup and punch list items in Burnt Store Meadows and has anticipates work to begin in Burnt Store Isles the week of Oct. 28.



- Veterans Park Phase II Stevens and Layton Inc. has completed installation of wall foundations and has begun construction of the mural, plaque and seating walls. The project is still set for a mid-December 2019 completion.
- Taylor Street Streetscape Bricking Contractor will begin work on Oct. 28.

Canal Maintenance

- Repairs Crews filled 26 depressions and performed 5 seawall cap and seam patches.
- **Buckley's Pass** Helical anchor installation is complete and anchor testing is in progress. Waler boards have been installed on the east and west seawalls. Waler boards are being installed on the south seawall section. Backfill is being placed behind the west seawall. The pilings that will line the channel have been delivered to the staging site. Current Board & Committee Vacancies (Volunteer Appointment Information Form)

- Code Enforcement Board (One alternate vacancy) Meets the fourth Wednesday at 9 a.m. in City Council Chambers. Must be City resident. Seven-member board with two alternate members. Three-year terms maximum of three terms. Hears and decides alleged violations of the City Code of Ordinances.
- Police Officers' Pension Board (One regular vacancy) Meets quarterly and as called in Council Chambers. Five members two City residents at large, two police officers and one member appointed by appointed by the Board. Four-year terms no maximum. Charged with management of the Police Officers' Pension Fund.

- Punta Gorda Isles Canal Advisory Committee (One regular vacancy) Meets the third Monday at 1:30 p.m. in City Council Chambers. Must be a resident of Punta Gorda Isles. Seven-member board. Three-year terms maximum of three terms. Makes recommendations to City Council on effective maintenance of existing canals, waterways and navigable channels within the district, together with the maintenance and reconstruction of seawalls. Holds public hearings and makes final decision on petitions for special permit to the provisions of Section 6-6(c) of the City Code of Ordinances.
- Historic Preservation Advisory Board (Three vacancies) Meets the 4th Thursday at 9 a.m. in City Council Chambers. Must be City resident. Seven-member board with two alternate members. Three-year terms maximum of three terms. Identifies for the City Council historically significant structures and sites that should be considered for designation as a "Local Historic Landmark" or be nominated for listing on the Florida Master Site File and the National Register of Historic Places. Makes recommendations of the policies for the protection of historically significant structures and sites. Makes recommendations to staff with regard to certificates of appropriateness for any demolition, variance, sign or relocation of structures. Promotes public awareness of historic archaeological preservation and its community benefits.
- Board of Zoning Appeals (One alternate) Meets the 4th Tuesday at 4 p.m. in City Council Chambers. City residency required. Seven-member board with two alternate members. Threeyear terms - maximum of three terms. Financial disclosure required. Makes recommendations to City Council on variances to City Code.
