

WEEKLY HIGHLIGHTS REPORT NOVEMBER 27, 2019

City Manager

- Holiday Closure City government offices will be closed on Nov. 28 and Nov. 29 in observance of the Thanksgiving holiday. There will be NO CHANGE in residential or commercial sanitation services for City of Punta Gorda customers as a result of the holiday closure
- Punta Gorda Community Redevelopment Agency is seeking one member to fill a position expiring on Dec. 31. Appointee must be a Charlotte County resident and shall serve for a four-year term. The purpose of the Agency is to implement the policies, projects & programs contained in the Punta Gorda Downtown Redevelopment Plan. - **Pickleball at Gilchrist Park** Just a reminder that there are four Pickleball Courts available for play in Gilchrist Park. The courts open at 8 a.m. and close at 8 p.m. No temporary nets are allowed to be used on the courts. Back in Jan. of this year City Council approved a four-step, noise abatement plan for pickleball play in Gilchrist Park.
 - ✓ Once PicklePlexTM opened its first sixteen courts on the campus of Florida Southwestern State College (FSW), the number of courts in Gilchrist Park were reduced from eight to four.
 - ✓ The City prohibited parking on the grass on the north side of Retta from Gilchrist to Bayfront Center.
 - ✓ Bids were received and approved for sound barrier material that was installed at the pickleball courts.
 - ✓ A committee was formed and produced a report that looks at more long-term solutions to the issue including possible relocation of pickleball play to another suitable site in the City. The report can be accessed at www.ci.punta-gorda.fl.us/home/showdocument?id=10205.

- Citywide Master Plan At its Dec. 4 meeting, City Council will review a draft scope of work to be given to Dover Kohl, in order for the planning firm to develop a project cost for comprehensive plan amendments, land development code changes and development of a form based code identified in the Master Plan. The Comprehensive Plan depicts a long-range plan that sets forth a vision for the City and lays out a path to achieve that vision. Form based codes speak to the predictable built results and a high-quality public realm by using physical form (rather than separation of uses) as the organizing principle for the code. The Comprehensive Plan and revised Codes must be consistent with each other. Therefore, Comprehensive Plan changes may be necessary prior to development of some of the form based code.
- **FEMA Map Update** FEMA will be hosting a Public Open House at the Charlotte Harbor Event and Conference Center between 4 p.m. and 7 p.m. on Dec. 12 to answer questions from any impacted individuals. Urban Design

• US41NB Pedestrian Bridge – Many questions have been received from residents about the work going on to create a pedestrian bridge to cross the Alligator Creek. The history of the forward movement on the bridge starts in 2016 when the City of Punta Gorda had, as it had done for many previous years, requested Federal Transportation funding for a bicycle and pedestrian bridge over the north fork of Alligator Creek to connect the northern portion of the US 41 multiuse recreational trail (MURT) to those portions of the MURT that are south of the creek. This continued request was to provide additional connectivity in the City's bicycle and pedestrian network and provide enhanced level of safety to all roadway users crossing the north fork of Alligator Creek on US 41. In 2016/2017 funds from the State of Florida SUN trails (http://floridasuntrail.com/) program became available for this project.

In June 2017 the City engaged the services of Agenor & Campbell Structural Engineers of Clearwater Florida to provide design engineering services for this proposed bridge. This bridge design contract including permitting, mitigation (Mangrove) and testing (hazardous materials) cost the City \$235,227.02 of this figure \$215,000 was reimbursed to the City via the SUN trails grant (State funds). Agenor & Campbell was selected by the City thru a competitive procurement process as specified by Florida Statute, local ordinance, and policy. One of the many considerations in this selection process was the skills, experience, and proven success of the firm in producing designs for similar projects. Agenor & Campbell had recently completed bicycle/pedestrian bridge designs for a path in Sarasota County along US 41 crossing over similar tidally influenced creeks to our Alligator Creek. These projects in addition to their similarity in physical conditions were also similar in terms of the regulatory approval processes involved. Thru the bridge design process there are many considerations and analysis that drive the final design including a Bridge Hydraulics Report, Drainage Report, and Geotechnical (soils & sub-soil conditions) Testing. The technical analysis results in the creation of the Bridge Development Report.

The Bridge Development Report recommended that due to various factors including the flow maintenance requirements on Alligator Creek, other environmental concerns, and project cost, was to design a single span 100 foot pre-stressed concrete bridge using standard Florida-I 45 beams. It is also important to note that in addition to the City, the bridge design required review and approval from the Florida Department of Transportation (FDOT), Florida Department of Environmental Protection (FDEP), and the Army Corps of Engineers (ACOE). FDOTs approval was required as they provided the grant funds; the bridge facility is within the public right-of-way that FDOT maintains; and any bridge in on a Florida public right of way must meeting FDOT standards for bridge design and construction. FDEP interest is both within the realm of the SUN trails network a designated statewide system of shared use non-motorized paths, and in the permitting process for Mangrove mitigation required by this project. The ACOE interest was in the protection of the wetlands of the United States and ensuring that any wetland loss was appropriately mitigated in accordance with Federal standards.

Construction wise the budget for this project including required design engineer construction services, construction, engineering & inspection (CEI) services, material testing, utilities work, and contingency funds totaling \$1,121,340. Of this construction budget \$782,000 is grant funding from the SUN Trails (FDOT) program with the remainder coming from local expenditures from the 1% sales tax (\$139,340) and transportation impact fees (\$200,000). Including design and construction the grand total for this project is \$1,356,567.02 with \$997,000 coming back to the City from the State of Florida in the form of SUN trails grants.

Staff prepared the draft scope of services for the necessary proposed comprehensive plan changes and land development rewrites identified in the accepted 2019 Plan Punta Gorda City Wide Master Plan. Under the current Master Service Agreement with Dover, Kohl & Partners, the City of Punta Gorda is requesting planning services to assist in the development and preparation of a Unified Land Development Code (ULDC) that will align with the changes to the City's 2040 Comprehensive Plan.

Each street will be open to local traffic only. Detours and impact to traffic are to be anticipated. Hours of operation will be between 7 a.m. and 5 p.m. When driving in the area, motorists are

encouraged to drive with extreme caution and be alert

for workers in the rights-of-way.

Alligator Creek Pedestrian Bridge (US 41 NB **FDOT Right-of-Way)** – The concrete bridge deck has been poured. Lane closures are to be anticipated while work continues. The contractors work zone encompasses the multi-use trail and over Alligator Creek parallel to US41 NB. The multi-use trail remains closed to pedestrians and cyclists until further notice.



- Citywide Drainage Swale Regrading To date JRL Underground has completed work at 543 properties totaling 411,100 square feet of grading/sodding. Work is underway in Burnt Store Isles and started along Macedonia Drive on Nov. 26.
- **Intersection ADA Improvements** The demolition and concrete work is complete at Virginia Ave and Taylor St. The ADA mat placement will be scheduled the week of Dec. 2 Dec. 6.
- **Veterans Park Phase II** Electrical work is underway and gazebo painting has begun. Seating wall and column caps have been delivered to the job site.
- **Taylor Street Streetscape** The project is substantially completed as of Nov. 27. The eight benches for the four seating areas have been ordered and should be delivered in early Jan. City staff will be replacing the six street lights next week.

Canal Maintenance

- Crews filled 16 depressions and performed two seawall cap and seam patch.
- Crews trimmed trees and mowed the BSI locks and removed debris from canal.

Buckley's Pass Additional Harbor Access

• Seawall work is complete and dredging has started. Boaters should use caution when operating in the area.

Police Department

• Alert Punta Gorda – The City has implemented a new public safety emergency alert and community notification system. Alert Punta Gorda will allow the Punta Gorda Police Department and Punta Gorda Fire Department to contact the community in emergency situations that require the public's immediate attention and to make community notifications. • **Employment Scams** – We have recently received several reports of employment scams. One of these scams works by the victim being "hired" by the scammer as a secret shopper. The scammer

will send the victim a check and advise them to cash the check at their bank and make a purchase of gift cards at a store during their evaluation. The scammer will usually advise the victim that they can keep the gift cards and any remaining money as payment for their services, but that they must send a photo of the gift cards and receipts along with their evaluation of the store. The scammer will then use all of the funds on the gifts cards and the victim will discover that the check was fraudulent, leaving the victim out all of the money. Please remember,



legitimate employment opportunities never involve an employer sending a check that needs to be cashed by the employee in order to perform their job. If anyone you do not know sends you a check for any reason, always make sure the check clears the bank prior to spending any of the money.

• **9PM Routine** – Locking car doors at night could have prevented nearly all vehicle burglaries in the City of Punta Gorda in the past year. Most criminals are only interested in easy access and will not force entry into a vehicle unless valuables are clearly visible. Follow the 9PM Routine and check to make sure your valuables have been removed from your vehicles and your vehicle doors are locked each night before bed to help prevent crime in our city!

Fire Department


 Holiday Decorating – With the holidays fast approaching, now is the time to start thinking about staying safe when decorating this holiday season. U.S. fire departments respond to an estimated 860 home structure fires per year that began with decorations. This does not include Christmas trees, which increases that number by



approximately 210 per year. People should think about sifting through and tossing out old holiday decorations. Some items over time may become major fire hazards, and extension cords that may be frayed or damaged should be replaced as these pose a serious risk of fire. This should also be done with holiday lighting. If the cords are damaged, light bulbs are missing or loose, they should also be replaced. Safety continues into the actual decorating process. If you are hanging lights, avoid damaging cords by using clips instead of nails and check for a UL rating. If lights say "90-day use", they are meant to be used only for a 90-day period. Also note whether your lights or other electrical decorations are meant for indoor or outdoor use. Use them in the appropriate locations. When choosing new holiday decorations make sure they are flame resistant or flame retardant and keep decorations away from doors and windows. Current Board & Committee Vacancies (Volunteer Appointment Information Form)

- Code Enforcement Board (One alternate vacancy) Meets the fourth Wednesday at 9 a.m. in City Council Chambers. Must be City resident. Seven-member board with two alternate members. Three-year terms maximum of three terms. Hears and decides alleged violations of the City Code of Ordinances.
- Board of Zoning Appeals (One regular and one alternate) Meets the 4th Tuesday at 4 p.m. in City Council Chambers. City residency required. Seven-member board with two alternate members. Three-year terms maximum of three terms. Financial disclosure required. Makes recommendations to City Council on variances to City Code.
- Building Board (One regular vacancy) Meets the fourth Tuesday at 9 a.m. in City Council Chambers City residency not required. Seven member board with two alternate members. Three-year terms maximum of three terms. Four members must be involved with the building industry and three members must be consumer advocates who are not, nor ever have been, involved with building industry. Makes recommendations to City Council on the minimum qualifying requirements for obtaining Certificates of Competency in the various construction trades and the fees for same. Periodically reviews and holds public hearings on all building, electrical, plumbing, housing, gas, fire prevention and other related codes. Reviews enforcement of all codes relating to construction standards and acts as condemnation board in matters of violation of minimum standards. Hears alleged complaints against contractors.
- Punta Gorda Isles Canal Advisory Committee (one regular vacancy) Meets the third Monday at 1:30 p.m. in City Council Chambers. Must be a resident of Punta Gorda Isles. Seven member board. Three year terms maximum of three terms. Makes recommendations to City Council on effective maintenance of existing canals, waterways and navigable channels within the district, together with the maintenance and reconstruction of seawalls. Holds public hearings and makes final decision on petitions for special permit to the provisions of Section 6-6(c) of the City Code of Ordinances
