

# WEEKLY HIGHLIGHTS REPORT APRIL 10, 2020

### **City Manager**

- Council Meeting City Council will meet on April 15 at 9 a.m. at the City Hall. Items of action and or discussion include; City Manager recruitment, Peace River Wildlife Center Henry Street lease, Burnt Store Isles speed limit signs, Community Redevelopment Authority debt refinancing, and Gill St Parking. The following provisions will be in place at the meeting; The City's Emergency Management Director shall determine and enforce social distancing as recommended by any federal, state or local agency and deemed necessary by the Emergency Management Director under the then existing circumstances. Actions may include but are not limited to;
  - ✓ Reduced room capacity
  - ✓ Minimum seat spacing
  - ✓ Restricted access to council chambers and the lobby area
  - ✓ Disinfection of podiums, microphones, or other surfaces
  - ✓ Removal of any person(s) exhibiting symptoms of illness.
  - ✓ Members of the public not able to attend in person due to the foregoing limitations will be instructed as to how to watch meetings by means of live-streaming. Due to emergency attendance limitations, City Council will accept written comments on any scheduled agenda item received by the City Manager in advance of the meeting. Submissions will be read into the record by a city staff member. Written comments must clearly identify the related agenda item and include the submitter's full name. Written comments may also be provided on any matter, but such comments must be received by the City Manager prior to the start of the meeting. All written comments must be limited in length so that they may be read into the record in approximately three (3) minutes. • Parks Usage Update – Please keep in mind that City park areas are not available for sitting in lawn chairs, on benches, tables and seawalls, in accordance with State guidelines. Active recreational activities such as walking, biking or running are allowed with appropriate social distancing. Since April 3, our police officers have had to request 318 park patrons to vacate the premises since they were not engaging in what are deemed essential recreational activities. Again, people are not allowed to lounge, picnic or sit in lawn chairs in the park until further notice because of the COVID-19 situation. Park amenities such as playgrounds, gazebos, pavilions, sports courts and benches also remain off limits. Please do your part to model appropriate social and physical distancing behaviors if using the Harborwalk and Linear Parks.

- **FY 2021 Budget** The community conversation aimed to garner input into development of FY 2021 budget priorities scheduled for April 7 has been cancelled due to COVID-19 social distancing and meeting protocols. However, the City is still seeking public input into budget priorities. - **Buckley's Pass Signage** Here is the current situation as to signage. The Florida Wildlife Commission must approve any speed sign changes. Charlotte County Public Works has the

responsibility of placing signs on Alligator Creek. The SLOW SPEED signs on Alligator Creek were moved inland (upstream) after the Buckley's Pass permit was issued. The SLOW SPEED signs used to be downstream of Buckley's Pass and that is what is now being requested by residents. The signs were moved by the County at the direction of FWC about the time when the County dredged Alligator Creek. The City of Punta Gorda is responsible for the Buckley Pass signage. The City was told that FWC would



review signage needs once Buckley Pass was finished. Now that the pass is opened, Charlotte County has agreed to pursue the signage matter with FWC. The current speed situation is this. On Alligator Creek, the minimum wake sign is a ways INLAND from the Buckley Pass - Alligator Creek intersection. Therefore boats currently using Buckley Pass may encounter boats on plane in Alligator Creek as the current signage allows that. In addition, there are no SLOW SPEED signs as you enter Buckley Pass because when the project was permitted, the SLOW SPEED signs on Alligator Creek had not yet been moved upstream so Buckley's Pass was intended to be SLOW SPEED. A temporary, "informational" slow speed sign has been installed at Buckley's Pass. The sign is located on the left side of Buckley's Pass at the intersection of Alligator Creek and is facing the creek.

## **Code Compliance**

• Relief for Businesses – In order to provide relief to the City's local businesses, Code Compliance staff is issuing no-charge business event banner permits for up to 30 days. Normally a business event banner permit is valid for 5 days and limited to 12 permits per year. The City is striving to be proactive by allowing the local businesses notify customers that they are open. This permit is <u>not</u> limited to restaurants, it is for all open businesses, which are considered essential per the Governor's order. ## **Lot Mowing Program**

 Barring any changes in the Stay at Home Order, the City will begin a new mowing cycle on Monday April 13, 2020. At that time crews will begin mowing the following areas: Colony Point (Colony Point Dr., W. Marion Ave., Socorro Dr., and Coronado Dr.).
PGI (Magdalina Drive, Via Vento, W Henry Street, Appian Drive, and Columbian Drive).

### **Urban Design**

- Dover Kohl & Partners and City staff conducted technical stakeholder interviews with City Councilmembers and the Chairs and Vice Chairs of the Planning Commission and the Historic Preservation Advisory Board. These interviews were conducted via video conference.
- City staff met with several members of Florida Department of Transportation Staff via video conference to discuss future possible configurations for US 17 (E Marion & E Olympia) and US 41 (Tamiami & Cross) thru Downtown Punta Gorda. These discussions are in related to future planning.

## **Engineering**

- **ADA Interior Signage and Wayfinding -** The signs for the Public Works and Utilities Campus are being manufactured. Installation is anticipated to be completed by mid-May.
- **Boca Grande Drainage Improvements** Properties are currently in the acquisition phase for pond usage which will determine design completion.
- City wide Drainage Swale regrading To date JRL Underground has completed work at 709 properties totaling 529,300 square feet of grading/sodding. Work completed during the week of April 6 included 3600-3629 Kassandra Dr. and will then move to 3236-3254 Tripoli Blvd. Work is underway at 506-518 St. Girons Ct., 3823 St. Girons Ct. and 3853-3865 Bordeaux Dr.
- Harborwalk (Gilchrist Gazebo to Berry) Preconstruction tele-conference April 9, to discuss schedule and items related to the project.
- Madrid Sidewalk Construction Concrete sidewalk, curb and grade work continues. The work area is from the western drive of the Burnt Store Publix Plaza to US 41 SB. This project is scheduled to complete by the end of May 2020.
- **Sullivan Street renovation** The bid opening is scheduled on April 20.



## **Canal Maintenance**

- **Bonefish Bayou Dredging** Dredging in the Bonefish Bayou is completed and the contractor is hauling spoil material to the staging site on Colony Point.
- **Burnt Store Isles Perimeter Canal Dredge** Dredging in the Burnt Store Isles Perimeter Canal is completed.
- **Mangrove Trimming** Annual mangrove trimming is underway. Work has commenced in Burnt Store Isles.
- **Seawall Replacement Projects** The seawall replacement contractor has completed nine seawall replacement projects. There are seven projects under construction in PGI and three under construction in BSI. There is two completed seawall replacement project in BSI. A seawall replacement project is not considered complete until the sod has been placed.
  - > Crews filled depressions at 25 locations.
  - > Crews performed five seawall cap and seam patches

Buckley's Pass – Buckley's Pass is complete and open to boaters. Boaters with deep draft vessels should use caution when operating through Alligator Creek until the captains "know" the local conditions. Alligator Creek was dredged by the County a few years ago to the same depth as Buckley's Pass. The staging lots are being restored.
