### Need:

The Americans with Disabilities Act (ADA) of 1990 is a Federal Civil Rights Legislation which mandates non-discrimination to persons with disabilities. The ADA, Title II prohibits discrimination by public entities on the basis of disability. Therefore, it is important that the City of Punta Gorda comply with all applicable laws and regulations, including those protecting persons with disabilities. In order to accomplish this, the City has developed a Transition Plan by conducting a self-evaluation of the accessibility by persons with disabilities on its facilities; identifying issues of accessibility that need to be addressed; upgrading its program for improvement of those facilities and to comply with ADA mandated standards.

#### Purpose:

To ensure that all individuals are provided reasonable access to all City facilities, programs, services and activities, and to identify and create a **plan** to mitigate deficiencies within all City facilities, programs, services and activities that may pose an obstacle to those individuals that have a disability.

#### Objective:

To remain eligible for federal grant funding, the City is required to have in place an American with Disabilities Act (ADA) Transition Plan that includes a schedule of implementation.
