• Face Covering Ordinance – Given the fact that the population of Punta Gorda is the second oldest demographic in the United States, residents are at significant risk if they contract the coronavirus and develop COVID-19; and given that the Center for Disease Control recommends the wearing of masks in places where social distancing is not possible, the decision was made to keep



the City of Punta face covering ordinance in place with a moratorium on enforcement of the penalties for not wearing a mask. This will remains as a requirement of law in the City of Punta Gorda, while bringing the Ordinance into compliance with the Governor's mandate.

Keep in mind that the Ordinance has exemptions including;

- Children under the age of two (2) years;
- Persons observing social distancing;
- Persons for whom a face covering would cause impairment due to an existing health condition or for whom compliance with the mandatory requirements imposed herein would conflict with the Americans with Disabilities Act;
- Persons communicating with an individual who is hearing impaired who needs to see the mouth of the person speaking to facilitate communication;
- Persons while working in a business or profession who do not have interactions with other persons;
- Persons while working in a business or profession where use of a face covering would prevent them from performing the duties of the business or profession;
- Persons exercising, while maintaining social distancing;
- Persons while eating or drinking, provided they are maintaining social distancing. It is the
 intent of this provision that a face covering must be worn while traversing an Indoor
 Public Place for ingress and egress, when walking to and from restroom facilities, and
 while standing when unable to maintain social distancing;
- Public safety, fire and other life safety or health care personnel, as their personal
 protective equipment requirements will be governed by their respective agencies or
 employers;
- Persons who are engaged in obtaining a service involving the nose or face for which temporary removal of a face covering is necessary to perform the service;
- Persons engaged in an activity where some other form of face covering is required pursuant to the regulations of the U.S. Occupational Safety and Health Administration

A business or organization can create their own rule requiring masks. If a patron refuses to follow the rule the business owner or manager can call the Punta Gorda Police Department and request to have the patron trespassed.

- City Council Meeting City Council will meet on Oct. 7 at 9 a.m. at Historic City Hall. Some of the agenda items of interest included:
 - ➤ Discussion regarding Cooper Street Multi-Use Recreational Trail design aand construction. On Oct. 16, City Council awarded a contract for professional engineering services to design the Cooper Street Multi-Use Recreational Trail (MURT) and design plans are currently at 60% completion. During the 1% Local Option Sales Tax project discussion held April 1, City Council allocated \$991,000 in Tier 2 for construction. City staff is seeking direction on whether or not to move forward with the design as it may be several years before funding becomes available for this project.

- ➤ Discussion of exceptions related to residential noise regulations. The Punta Gorda Code contains provisions which limit building construction and certain property maintenance activities to specified hours in residential neighborhoods. Due to increased complaints about noise, there has been a request for City Council to review these regulations.
- ➤ Discussion regarding Gilchrist Park Phase B. If built as designed the improvements would include Retta Esplanade diagonal parking, intersection treatments, parking lots at Gilchrist Street and the playground area, walkway connections and landscaping and require an additional investment of approximately \$957,000. Four other options for parking reconfiguration and cost estimates will also be discussed.

Urban Design

• The Planning Corner Comprehensive Plan Elements Update –

Most communities across the United States have some sort of vision plan. This vision plan defines how a community sees itself in the future and loosely defines how it can get there. The City of Punta Gorda's vision plan is <u>Plan Punta Gorda 2019 Citywide Master Plan</u> The City also has a Comprehensive Plan. Beginning in the mid-1980's the State of Florida required every City and County have a <u>Comprehensive Plan</u>. The initial <u>Florida Statue</u> that mandated the Comprehensive Plan



requirement was known as the Growth Management Act. The intent of this Act was to develop an integrated planning system at all levels of government, local, regional, and state. As such these local Comprehensive Plans are required to meet certain minimum standards, have a basic common structure, and be updated regularly. The Florida Department of Economic Opportunity (FDEO) is the State agency tasked with reviewing local Comprehensive Plan updates and coordinating the State's planning activities. In addition to FDEO local government Comprehensive Plan updates are reviewed by other state agencies and local/regional governments including the following:

- Florida Department of Environmental Protection (FDEP)
 - o Lead state agency for environmental management & stewardship
- Florida Department of State
 - Lead state agency for corporations, cultural affairs, elections, historical resources, and library& information services
- Florida Department of Transportation (FDOT)
 - O State agency responsible for the construction and maintenance of the state's transportation network
- Regional Planning Council (regional government)
 - o Florida is composed of 10 regional planning council areas
 - o The councils are designed to foster regional cooperation for planning, emergency management and other interests of specific regional interest
 - o Punta Gorda is within the Southwest Florida Regional Planning Council area
- Water Management District (regional government)
 - o Florida is composed of 5 water management districts with each district area defined by a major watershed area of the state
 - Punta Gorda is within the <u>Southwest Florida Water Management District</u> (SWFWMD often pronounced as "swift-mud")
- County government
 - o Charlotte County
 - o Punta Gorda is the only incorporated City in Charlotte County

All of these agencies, regional, and local governments have say in the City of Punta Gorda's Comprehensive Plan update, through their responsibility to review and comment on the plan. However, the most important plan reviewer is the Community, which through our elected officials on City Council have the ultimate review and approval authority for our Comprehensive Plan updates. The first drafts of these updates will be published to the City's website and the Plan Punta Gorda website this week and next.

Public Works

Canal Maintenance

- **FY 2020/2021 Seawall Replacement Program** The list of properties scheduled to have their seawalls replaced in fiscal year 2020/2021 has been posted to the Canal Maintenance Website. Notices have already been sent to residents that will have worked performed on their seawalls starting in Oct. 2020. Residents can expect to receive a notice in the mail approximately six weeks prior to construction. It is highly recommended that property owners contact the contractor to discuss how to prepare the property for construction. Contact information is provided in the notice.
 - ➤ As we begin the next Seawall Replacement Work Program, property owners may be curious about the process and what to expect. There is a series of informational videos on the Public Works Canal Maintenance website http://www.ci.puntagorda.fl.us/government/public-works/canal-maintenance/canal-maintenance-video-series that will inform you "How to prepare your Property for Seawall Replacement"; "Seawall Replacement Process"; and "Manufacturing of Seawall Panels".  - > Crews filled depressions at 22 locations.
 - > Crews performed 16 seawall cap and seam patches (163' linear ft.).
 - ➤ The contractor completed mangrove trimming along the Burnt Store Isles perimeter canal.

Engineering

- ADA Improvements City Hall Annex The second floor men's room is complete. The third floor men's restroom and the 3rd floor break room construction continue. This work is tentatively scheduled to be completed by mid-November.
- Harborwalk (Gilchrist Gazebo to Berry St.) A Substantial Completion walk-through was held Wednesday, Sept. 30. A punch-list was developed to complete the project. This section of the park is open to pedestrians and cyclists. Final completion for project



documentation, completion of punchlist items and turn over to the City is Oct. 30.



- FDOT US 41 Carmalita Street to Marion Ave. within City of Punta Gorda The Florida Department of Transportation's contractor, Highway Safety Devices, continues work to install new signals on US 41 from Carmalita St. to Marion Ave. The construction will take place Monday through Friday during daytime and nighttime/overnight hours, weather permitting. Lane closures may occur during daytime hours from 9 a.m. to 4 p.m. For complete details, contact information and map http://www.ci.punta-gorda.fl.us/government/public-works/engineering.
- Shreve St. MURT Lighting Staff continues coordination efforts with concrete, electrical and directional drilling contractors for this project between History Park and the Airport/Pompano intersection.
- Sullivan Street Renovation to Historic Bricks Placement, grading and rolling of crushed concrete base rock continues. Demolition of select existing curb is complete. Concrete curb placement is to be scheduled. The Sullivan Street renovation will require this section to be closed to all traffic until Nov. 2020. Travelers are requested to use extreme caution while workers are present in the right of way and allow additional time for travel while work is performed. Temporary delays are to be anticipated. Police Department


- Vehicle Burglaries Did you know that nearly every vehicle burglary that occurred in Punta

Hurricane Matthew and Hurricane Michael were both late season storms that causing significant storm surge and damage in Florida in October. Fortuntately, November has only seen three known U.S. hurricane landfalls since 1861.

- **Board of Zoning Appeals** (Two alternates) Meets the 4th Tuesday at 4 p.m. in City Council Chambers. City residency required. Seven member board with two alternate members. Three year terms maximum of three terms. Financial disclosure required. Makes recommendations to City Council on variances to City Code.
- **Building Board** (One alternate) Meets the 4th Tuesday at 9 a.m. in City Council Chambers City residency not required. Seven member board with two alternate members. Three year terms maximum of three terms. Four members must be involved with the building industry and three members must be consumer advocates who are not, nor ever have been, involved with building industry. Makes recommendations to City Council on the minimum qualifying requirements for obtaining Certificates of Competency in the various construction trades and the fees for same. Periodically reviews and holds public hearings on all building, electrical, plumbing, housing, gas, fire prevention and other related codes. Reviews enforcement of all codes relating to construction standards and acts as condemnation board in matters of violation of minimum standards. Hears alleged complaints against contractors.
- **General Employees Pension Board** Meets quarterly and as called in Council Chambers. Five members two City residents, two general employees and one at-large as appointed by the Board. Four year terms no maximum. Financial disclosure required. Charged with management of the General Employees' Pension Fund.
