# **City Manager**

• From the Desk of the City Manager Greg Murray – I'll start this column with a thank you to voters of Charlotte County. By passing the 1% Sales Tax you have given City and County staff a multitude of new and continuing projects to work on, and we are up for the challenge. We look forward to showing the results of these projects to our residents. As you may recall, City Council put together a Sales Tax Committee that represented a cross section of stakeholders to vet and rank each of the projects. City Council then carefully considered the suggestions of the committee and finalized the list, allocating dollars as tier one or tier two. If sales tax collections come in higher than expected, the tier two projects will receive funding.



Prioritization of the sales tax projects in terms of what year they are started or continued is done by City Council. The Council can change the order of the projects if circumstances warrant, but they don't change the actual project list once it has been voted on by residents of Charlotte County. The list of 2021 projects includes a mix of continuing and new initiatives. The Historic City Hall preservation project receives an allocation to move the project forward. Much needed improvements in lighting, sidewalk connections, and drainage are slated to occur in the Historic District. Two key safety projects, the Henry Street crosswalk and Henry Street sidewalk, are a priority to enhance the walkability of the neighborhood. Americans with Disability Act projects will receive funding throughout the city, with improvements to trail access specifically at Nature Park being a primary focus in fiscal year (FY) 2021. Work will continue on Boca Grande/Corto Andra area of Punta Gorda on drainage conditions. This has been a multi-year project that is expected to be completed by the end of FY2022. Dollars are allocated to start the West Henry Campus project that will house the Peace River Wildlife Center and connect all the downtown attractions.

The other projects on the docket over the next six years will also greatly improve the safety of our residents, preserve historic assets, and benefit quality of life. The public safety building will get an addition to better serve the needs of both police and fire. US 17 and Shreve Street Complete Streets projects will add additional sidewalks and other safety features. An assessment and renovation of the Freeman House and improvements to the Bayfront Activity Center will help preserve these assets into the future.

At this point I should probably wrap up this column and get to the real work of making these projects happen, but not before I congratulate Lynne Matthews our new Mayor, Debby Carey our new Vice-Mayor, and Jaha Cummings on their unopposed election wins for their respective districts. Their dedication to the residents of Punta Gorda is admirable and they too have a full slate of work in front of them. Once again thank you. Great things happen when they are in alignment with the vision and values of the community.

- City Council Meeting City Council will meet on Nov. 18 at 9 a.m. in the Historic City Hall Council Chambers. A few items of interest include:
  - ➤ The first reading of an ordinance to prevent left turns from Cooper Street onto E. Mckenzie during school drop off and pick up times to improve safety for motorists and pedestrians traversing the area.
  - A proposed ordinance to adopt new rates, fee and charges association with provision of water and wastewater services with the Punta Gorda Utility Service Area.
  - ➤ A request for inkind services from First Macedonia Church for maintenance of way during their weekly food distribution.
  - ➤ Approval of contract change for Harborwalk Phase II to make the following modifications to previously completed construction documents:
    - ✓ Remove the alteration/reconfiguration of the basketball court (Only item to remain is the replacement of six poles/backboards court has been resurfaced)
    - ✓ Removal of diagonal parking between Dolly St. and Berry St.
    - ✓ Removal of diagonal parking west of Berry St.
    - ✓ Removal/re-design of parking lot between Chasteen St. and Dolly St. to create additional "green space"

- **Dredging Ponce Inlet** The week of Nov. 16 thru Nov. 30 (weather and equipment operation permitting), the Ponce De Leon Inlet is scheduled to be dredged. The contractor will off load dredge material at the vacant lot at the southerly end of Colony Point; then the material will be transported to another location by dump trucks. - Spoil Site Hauling Beginning Mon., Nov. 16 a contractor will be hauling fill material from the City Spoil site located on Colony Point Dr. Dump trucks will be hauling material to Placida, Charlotte County. The trucking route will be traveling along Colony Point Dr. to W. Marion Ave. to U.S. 41 (Tamiami Tr.). Hauling is expected to be completed by Fri., Dec. 11. - Seawall Replacement Projects The seawall replacement contractor has two projects under construction in Punta Gorda Isles. There are 26 seawall replacement projects scheduled for Punta Gorda Isles. There is one seawall replacement project currently underway in Burnt Store Isles. Four seawall replacement projects are scheduled for Burnt Store Isles later this fiscal year.
  - > Crews filled depressions at 24 locations.
  - > Crews performed one seawall cap patch/seam patch (8' linear feet).
  - > Crews manufactured 18 (12.5' ft. each) seawall panels.

- Americans with Disabilities Act Improvements City Hall Annex Construction is near completion. The project is scheduled to be completed the first week in Dec.
- Florida Department of Transportation US 41 Carmalita St. to Marion Ave. within City of Punta Gorda FDOT contractor, Highway Safety Devices, continues work to install new signals on US 41 from Carmalita St. to Marion Ave. The construction will take place Monday through Friday during daytime and nighttime/overnight hours, weather permitting. - Laishley Park Americans with Disabilities Act Ramp Handrail installation commenced. Project is anticipated to be complete the week of Nov. 16 (weather permitting).

- Ponce De Leon Park Seawall Repairs The contractor cleaned and pressure washed approximately 75% of the seawall to prepare for cap repairs and sealing work. Work will continue as weather and conditions allow this week. During construction the beach area as well as the seawall between the beach and fishing pier will be closed. The contractor will accommodate the public by leaving sections of the beach area open when possible. Construction is anticipated to be completed in Mar. 2021.

• From the Desk of Chief Briggs – This week the City of Punta Gorda experienced several days of localized flooding due to the rain that Tropical Storm Eta brought to the area. A contributing factor to the flooding was the flood waters inability to drain due to extremely high tides associated with storm surge. We can use the experience this week as a reminder that we all need to be diligent in our preparation for the Hurricane season. While for most of us the localized flooding may only been an inconvenience but for many who live or operate a business in the flood prone areas it can prove to be very damaging. Please use good discretion and try to avoid traveling over water covered roads. The impact of Tropical Storm Eta gave opportunity for a collaborated effort by all City departments, additionally it provided several opportunities to coordinate and share resources from other local agencies. Currently we are conducting City wide clean-up and damage assessments to determine any damage that may have resulted from the storm.



- The City flushes fire hydrants throughout the service area when required for the following:
  - ➤ Routine maintenance and testing
  - Adhere to strict regulations from regulatory agencies.
  - ➤ Help find weaknesses in the water system
  - > Improvement of water quality
  - > Taste and Odor issues
  - ➤ Water Sampling

The time involved in flushing can vary from a few minutes to serval hours depending on the circumstances.

### **Current Board and Committee Vacancies (Volunteer Appointment Information Form)**

- **Board of Zoning Appeals** (Two alternates) Meets the fourth Tuesday at 4 p.m. in City Council Chambers. City residency required. Seven member board with two alternate members. Three year terms maximum of three terms. Financial disclosure required. Makes recommendations to City Council on variances to City Code.
- **General Employees Pension Board** Meets quarterly and as called. Five members two City residents, two general employees and one at-large as appointed by the Board. Four year terms no maximum. Financial disclosure required. Charged with management of the General Employees' Pension Fund.
- Building Board (One alternate) Meets the fourth Tuesday at 9 a.m. in City Council Chambers City residency not required. Seven member board with two alternate members. Three year terms maximum of three terms. Four members must be involved with the building industry and three members must be consumer advocates who are not, nor ever have been, involved with building industry. Makes recommendations to City Council on the minimum qualifying requirements for obtaining Certificates of Competency in the various construction trades and the fees for same. Periodically reviews and holds public hearings on all building, electrical, plumbing, housing, gas, fire prevention and other related codes. Reviews enforcement of all codes relating to construction standards and acts as condemnation board in matters of violation of minimum standards. Hears alleged complaints against contractors.
- **Utility Advisory Board** Meets the fourth Monday at 9 a.m. in City Council Chambers. Must be City resident. Seven-member board. Three-year terms maximum of two terms. Makes recommendations to City Council with regard to, but not limited to, revisions to the utility construction standards, alleged billing discrepancies and review of utility specifications.
