

# WEEKLY HIGHLIGHTS REPORT NOVEMBER 25, 2020

## **City Manager**

- **Happy Thanksgiving** City government offices will be closed on Nov. 26 and Nov. 27 in observance of the Thanksgiving holiday. There will be NO CHANGE in residential or commercial sanitation services for City of Punta Gorda customers as a result of the holiday closure.
- From the Desk of the City Manager Greg Murray –City Council Meeting One of the primary roles of government is to protect the safety and well-being of its citizens. 2020 has presented us with many challenges, bringing this responsibility into the spotlight. We have had the opportunity to not only focus on traditional health and safety needs but also to respond to a global pandemic. Our usual focus on safety includes things such as the expansion of police and fire services. It is



also a commitment to water quality, with a focus on bringing online the new reverse osmosis water plant. Analyzing sanitation services and planning for additional capacity to serve residents needs into the future is also a piece of the role of government. Adding crosswalks and accessibility to allow safe pedestrian travel in our streets also falls into this category. In addition, this year we have had COVID-19 to deal with.

While we had always considered the Florida Department of Health Charlotte County (FDOHCC) a partner, never before did we rely on the department and advice of Administrator Dr. Pepe on such a regular basis. The FDOHCC has given us the tools to monitor the health of our residents through dashboards. Dr. Pepe has shared the messages surrounding the COVID-19 at City Council meetings. This has included critical information to make decisions regarding keeping our community safe. As most are aware, one of the decisions made in the City of Punta Gorda is to require facial coverings in indoor places that do not allow for social or physical distancing. Positive tests in Charlotte County range from 36 to 56 cases per day. This makes the virus still a very real threat to the residents of Punta Gorda. Please do your part in protecting your health and the health of others including washing your hands frequently, practicing physical and social distancing, avoiding touching eyes, nose, and mouth, cleaning and disinfecting high touch surfaces and wearing a face covering in public places. Remember, everyone catches it from someone. Help us protect others we may encounter.

The FDOHCC has also asked the City to remind residents about prevention of influenza. Fortunately, many of the same practices that help to stop the spread of COVID-19 also work for the flu. Dr. Pepe provides the following advice "Frequently washing your hands, staying home while sick, and receiving a flu shot are the best ways to protect against and prevent the spread of the influenza virus." Healthcare providers and pharmacies in Punta Gorda have supplies of the flu vaccine available and remind residents that once vaccinated it takes about two weeks to offer protection.

A final health advisory reminder from the FDOHCC is that there have been cases of mosquito borne illness in our county. Standing water is one of the biggest factors in mosquitos multiplying. Drain accumulated water from items that are stored outside. Empty and clean birdbaths and outside pet bowls at least once or twice a week. Also, cover skin with clothing or repellent to prevent bites.

While the challenges ahead of us are many, the City of Punta Gorda works hard to protect the health and safety of our residents every day. We are fortunate to have a citizenry that is connected, involved, and concerned for their city and each other. It's more than a city, it is a true community. This community will face these and any other challenges by working together and standing strong.

  - ➤ Consider proposals from Harbor Social to close a portion of Sullivan St. from W. Marion Ave. to the alley adjacent to the Women's Club for events in Jan., Feb., Mar., Apr., May and a separate Super Bowl event on Feb. 7 from Sun. at 8 a.m. to Monday at 8 a.m.
  - ➤ City of Punta Gorda Comprehensive Plan 2040 continued Council discussion.
  - ➤ Park and Recreation Master Plan status update focusing on Level of Service (LOS) determinations.
  - A presentation of sign code survey results from the Aug. 28 to Sept. 30 general survey completed by 877 respondents.

• The Planning Corner – Level of Service – This week's topic continues the Level of Service (LOS) discussion and its effect on the park system. Based on the existing park system and identifying needs, establishing a LOS standard helps guide development of the park system over the next 10 to 20 years. It is the nucleus of the Park and Recreation Master Plan. At the Nov. 23 Planning Commission meeting, Urban Design Staff made a presentation regarding the two different types of LOS as part of the monthly update of the City of Punta Gorda Parks and Recreation Master Plan. • **Dredging Ponce Inlet** –The Ponce De Leon Inlet is scheduled to be dredged thru Nov. 30 (weather and equipment operation permitting). The contractor will off load dredge material at the vacant lot at the southerly end of Colony Point; then the material will be transported to another location by dump trucks. • **Seawall Replacement Projects** – The seawall replacement contractor has three projects under construction in Punta Gorda Isles. There are 26 seawall replacement projects scheduled for Punta Gorda Isles. There is one seawall replacement project currently underway in Burnt Store Isles.

Four seawall replacement projects are scheduled for Burnt Store Isles later this fiscal year.

## **Engineering**

- Americans with Disabilities Act (ADA) Improvements City Hall Annex – Construction is near completion. The project is scheduled to be completed in Dec.
- Gilchrist Park Pier Deck Replacement The Purchase Order has been issued to the contractor. A pre-construction date is to be determined upon delivery schedule.
- Laishley Park ADA Ramp Handrail installation continues.
- Ponce De Leon Park Seawall Repairs Work continues on the tie back repairs and epoxy coating of the seawall cap. During construction the beach area as well as the seawall between the beach and fishing pier will be closed. The contractor will accommodate the public by leaving sections of the beach area open when possible. Construction is anticipated to be completed in Mar. 2021.





## **Fire Department**

- Hosting a Thanksgiving Gathering Celebrating virtually or with the people you live with is the safest choice this Thanksgiving. If having guests to your home, be sure that people follow the steps that everyone can take to make Thanksgiving safer. These steps include:
  - ➤ Have a small <u>outdoor meal</u> with family and friends who live in your community. Limit the number of guests.
  - ➤ Have conversations with guests ahead of time to set expectations for celebrating together.
  - Clean and disinfect frequently touched surfaces and items between use.
  - If celebrating indoors, bring in fresh air by opening windows and doors, if possible. You can use a window fan in one of the open windows to blow air out of the window. This will pull fresh air in through the other open windows.
  - > Limit the number of people in food preparation areas.
  - > Have guests bring their own food and drink.
  - > If sharing food, have one person serve food and use single-use options, like plastic utensils.

## **Current Board and Committee Vacancies** (Volunteer Appointment Information Form)

- **Board of Zoning Appeals** (Two alternates) Meets the fourth Tuesday at 4 p.m. in City Council Chambers. City residency required. Seven member board with two alternate members. Three year terms maximum of three terms. Financial disclosure required. Makes recommendations to City Council on variances to City Code.
- Building Board (One alternate) Meets the fourth Tuesday at 9 a.m. in City Council Chambers City residency not required. Seven member board with two alternate members. Three year terms maximum of three terms. Four members must be involved with the building industry and three members must be consumer advocates who are not, nor ever have been, involved with building industry. Makes recommendations to City Council on the minimum qualifying requirements for obtaining Certificates of Competency in the various construction trades and the fees for same. Periodically reviews and holds public hearings on all building, electrical, plumbing, housing, gas, fire prevention and other related codes. Reviews enforcement of all codes relating to construction standards and acts as condemnation board in matters of violation of minimum standards. Hears alleged complaints against contractors.

- General Employees Pension Board Meets quarterly and as called. Five members two City residents, two general employees and one at-large as appointed by the Board. Four year terms no maximum. Financial disclosure required. Charged with management of the General Employees' Pension Fund.
- **Utility Advisory Board** Meets the fourth Monday at 9 a.m. in City Council Chambers. Must be City resident. Seven-member board. Three-year terms maximum of two terms. Makes recommendations to City Council with regard to, but not limited to, revisions to the utility construction standards, alleged billing discrepancies and review of utility specifications.
