### **APPROVAL OF MINUTES**

- A. December 10, 2019

# **REPORTS**

- A. Finance Reports December 2019
- Ms. Cathy Miller, Canal Maintenance Supervisor, confirmed there were no questions regarding the December 2019 reports detailed in the agenda material.
- B. Budget Utilization Report December 2019
- Ms. Miller verified there were no questions regarding the December 2019 reports.
- C. Seawall Replacement Status Reports December 2019
- Ms. Miller reported a project at St. Girons Drive would commence this week, noting the property owners were notified of the change in schedule.
- D. Permits Authorized by City Staff December 2019
- Ms. Miller announced five permits had been issued in December 2019.
- E. BSI Capital Improvement Status December 2019

He then stated the engineer had

He concluded staff was working on the master permit agreement which would encompass the scope of the BSI Corner Widening Project.

- Mr. Disher reported the Buckley's Pass (additional harbor access) Project was moving forward as expected, noting the City's YouTube channel containing video footage of the Project had received over 20,000 views.
