City Manager

• City Manager Column – Last week a long serving member of our Public Works team, Mark Gering, our City Engineer retired. Mark has been the City Engineer for almost 14 years and was an instrumental part of many projects including the massive Irma seawall redesign and construction. As we celebrate Mark transitioning into retirement to enjoy more time with family and take on new challenges, it provides a great opportunity to share more about department. The Public Works Department is made up of seven divisions responsible for providing services in the areas of maintenance, construction, operations and engineering support for the City's infrastructure. I'll provide a snap shot of the scope of what this 60 person department is responsible for.



Our Engineering Division provides technical support to all City departments. They design, serve as project management, and inspect construction of Capital Improvement Projects, infrastructure improvements and maintenance projects. They also review and present proposed canal construction applications for special permits to Punta Gorda Isles (PGI) and Burnt Store Isles (BSI) Canal Maintenance Districts, and information to City Council as part of the decision making process.

City streets, storm sewers, swales, and sidewalks within the right-of-ways are maintained by the Right of Way Division. They service 115.4 miles of improved streets and 230.80 miles of stormwater drainage systems.

The Sanitation Division collects refuse and yard waste from approximately 12,150 residential accounts and performs approximately 660 services on commercial accounts. A 48-gallon cart "single stream" curbside recycling program is in place for all residential units.

The BSI Canal Maintenance District and PGI Canal Maintenance District are responsible for a total of 109 miles of seawall maintenance and 55 miles of canal, dredging, and mangrove trimming/alteration within the district canal system.

The Facilities Maintenance Division provides routine maintenance for all city buildings. The division also provides project management for city building rehabilitation or replacement and provides new electrical installation and maintenance for buildings and street/park decorator lights.

The Parks and Grounds Division is responsible for maintaining approximately 122 acres of city parks and their amenities. The division designs, installs, and repairs all irrigation systems throughout city parks, grounds, and 300 cul-de-sacs. They maintain city playgrounds, courts, nature trails, boardwalks and beautification sites. Normal operations also include holiday decorating, herbicide spraying, tree-trimming and fertilizing. Removal of the holiday decorations alone, takes a crew of six approximately 29 days to inspect the decorations, make repairs and replace burnt out light bulbs and get the decorations safely stored for next year.

The bottom line is if you call the Public Works Department at (941) 575-5050 you will be warmly greeted by Jennifer Daumann or Jenna Blackway and your inquiry will be routed to the appropriate division for action. This is just one of the departments that work as part of the team to preserve and enhance Punta Gorda's identity as a vibrant waterfront community, unique in character and history; and as a desirable place to live, work and visit.

Code

- Permits required Staff would like to remind our residents and contractors that a Right-of-Way
 (ROW) permit is required prior to restoring or re-sodding any right-of-way, for all properties,
 developed or vacant. ROW permit applications must be submitted by a licensed contractor. The
 ROW permit will initiate a line and grade inspection to ensure that proper drainage is maintained
 as the property is restored.
- **Signs in the Residential Zoning Districts** At the Jan. 6 City Council meeting, Council reaffirmed that there will be no enforcement of the sign regulations for signs on residential lots in the Right of Way or otherwise until such time as the sign ordinance is amended and adopted. This includes political signs/flags.

• Gulf Coast Partnership (GCP) – Staff is assisting the GCP in reviewing Emergency Solutions Grant proposals for projects/programs in Charlotte County. The Coronavirus Aid, Relief, and Economic Security Act of 2020 (CARES Act) provided for a supplemental appropriation of Homeless Assistance Grants under the Emergency Solutions Grant Program. Eligible activities, such as homelessness prevention, rapid rehousing and street outreach, address the priorities and any published supplemental requirements of the CARES Act in order to prepare for, prevent the spread of and respond to the coronavirus. Stakeholders will review the proposals on Feb. 12.

• Florida Gulf Coast University (FGCU) – This week, Urban Design staff spoke in two Florida Gulf Coast University (FGCU) public relations courses, Principles of Public Relations and Advanced Public Relations Writing. Anticipating a career in an industry providing strategic communication for the business and nonprofit sectors, FGCU students in Public Relations experience an immersive course of instruction focused on developing solid oral and written communication skills. Students in the program have recently expressed their interest in governmental public relations. With Urban Design's new efforts to strengthen its communication with the public (ex. the Parks and Recreation Master Plan Update Videos), staff provided insight as to how proper communication is important in all aspects of government, including planning.

Public Works

Canal Maintenance

- Seawall Assessment City staff continues the Annual Seawall Assessment during low tide periods through Feb. City staff will be inspecting seawalls from the waterside while traversing canals in a boat. Residents may see City staff in a boat close to their seawalls while inspecting the condition of seawalls.
- Seawall Replacement Projects The seawall replacement contractor has six projects under construction and four projects completed in Punta Gorda Isles. There are 26 seawall replacement projects scheduled for Punta Gorda Isles. There are two seawall replacement projects currently under construction and two projects completed in Burnt Store Isles. Four seawall replacement projects are scheduled for Burnt Store Isles this fiscal year. A seawall project is not considered complete until the sod has been placed.
 - > Crews filled depressions at 24 locations.
 - > Crews patched/repaired 233' linear feet of seawall cap and seams.
 - > Crews completed maintenance, mowing-weed eating-trimming palms, at Sancho Panza Point and Burnt Store Isles lock channel.

Engineering

- City Wide Drainage Swale Regrading Work on the swale regrading program with JRL Underground Inc. is underway in the Burnt Store Isles subdivision. Work is nearing completion at the corner of South Crete Drive and Tripoli Boulevard and along Bordeaux Drive. Work is then scheduled on San Sebastian Court.
- Palm Avenue between Chasteen Street to McGregor Street Road Closure Utility staff has completed the sewer main. Water services are under construction and they are waiting for DEP water line clearance for the tie in at each end of the street. Once utility work is completed road base installation will take place. The entire project is anticipated through April (weather permitting). - **Ponce De Leon Park Seawall Repairs** Construction of the sidewalk between the fishing pier and the south end of the beach parking lot is complete. The beach parking lot is open. Work on the handrails along this new sidewalk is underway and is projected to be completed by Feb. 15.

Police

- The Volunteers in Policing (VIP) program VIP team members contributed a total of 840 hours of volunteer time to the City of Punta Gorda during the month of Jan. 2021. Our volunteers are an absolutely vital part of this police department and we appreciate them greatly! Fire Department


Obstetrics and Gynecology **Emergency Training (OB/GYN)** Field Training Officer (FTO) Alex Davenport conducted OB/GYN emergencies training this week. Topics included medical emergencies during pregnancy, pregnancy and trauma, breach births, and post birth emergencies. The Punta Gorda Fire Department paramedics carry delivery kits on all apparatus in the event a citizen or other civilian passing through



town finds them self in an immanent delivery situation. The fire department continues to host one fire related training and one Emergency Medical Services related training each month led by FTO's. Throughout the rest of the month Lieutenants at each station conduct trainings with their crews to ensure we are always ready to respond to any emergency.

Current Board and Committee Vacancies (Volunteer Appointment Information Form)

- **Board of Zoning Appeals** (Two alternates) meets the fourth Tuesday at 4 p.m. in City Council Chambers. City residency required. Seven member board with two alternate members. Three year terms, maximum of three terms. Financial disclosure required. Makes recommendations to City Council on variances to City Code.
- **Building Board** (One alternate) meets the fourth Tuesday at 9 a.m. in City Council Chambers City residency not required. Seven member board with two alternate members. Three year terms, maximum of three terms. Four members must be involved with the building industry and three members must be consumer advocates who are not, nor ever have been, involved with building industry. Makes recommendations to City Council on the minimum qualifying requirements for obtaining Certificates of Competency in the various construction trades and the fees for same. Periodically reviews and holds public hearings on all building, electrical, plumbing, housing, gas, fire prevention and other related codes. Reviews enforcement of all codes relating to construction standards and acts as condemnation board in matters of violation of minimum standards. Hears alleged complaints against contractors.

- **Utility Advisory Board** Meets the fourth Monday at 9 a.m. in City Council Chambers. Must be City resident. Seven-member board. Three-year terms, maximum of two terms. Makes recommendations to City Council with regard to, but not limited to, revisions to the utility construction standards, alleged billing discrepancies and review of utility specifications.
- **Historic Preservation Advisory Board** (Two regular) Meets the fourth Thursday at 9:00 a.m. in City Council Chambers. Must be City resident. Seven member board with two alternate members. Two members must reside within the Historic District. Three year terms, maximum of three terms. Identifies for the City Council historically significant structures and sites that should be considered for designation as a "Local Historic Landmark" or be nominated for listing on the Florida Master Site File and the National Register of Historic Places. Makes recommendations of the policies for the protection of historically significant structures and sites. Makes recommendations to staff with regard to certificates of appropriateness for any demolition, variance, sign or relocation of structures. Promotes public awareness of historic preservation.
