City Manager

city Manager Column – This past June, Heartland Forward named the Punta Gorda metropolitan area that encompasses all of Charlotte County, the seventh best entrepreneurial ecosystem in the nation. This designation confirmed what many entrepreneurs have come to appreciate about doing business here. Business owners are well networked, have access to finance capital, and are able to attract the talent needed to operate successfully. It also doesn't hurt that the area is a natural paradise and has no income, inheritance, or estate taxes. These are key factors that draw business owners from established economic hubs.

As of this week, the city has 1029 active business licenses within the city limits of Punta Gorda. To assist with marketing the business community the City of Punta Gorda has launched a new program entitled "Promote Punta Gorda." This is a small



business spotlight to focus on the businesses that are at the heart of Florida's Harborside Hometown. Promote Punta Gorda will feature the many business owners and their offerings. It also will highlight the many benefits to buying local. Small business owners within the city limits of Punta Gorda are eligible to have their business featured on the City's social media channels and in the Weekly Highlights Report.

Another offering unique to the City of Punta Gorda is the opportunity for prospective business owners to participate in a Design Studio. This pre-application meeting, led by Urban Design staff, assists the applicant in deciding if their new proposed development meets guidelines in accordance with the Land Development Regulations prior to submitting any development application. Design Studio meetings in Mar. will take place on Mar. 11 and Mar. 25 from 1 p.m. until 4 p.m.

The City continues to invest in infrastructure improvements that benefit both residents and businesses, such as the reverse osmosis water plant and future wastewater treatment plant expansion. The quality of our amenities also makes Punta Gorda unique and attractive to business owners. Our businesses benefit from continual investment in improvements such as at Ponce Park, upgraded splash pad amenities slated for Laishley Park, and the maintenance of the Herald Court Centre parking garage providing free parking for business customers.

Small business is a critical economic driver for the city. Not only do small businesses create jobs, they also foster community pride and create a unique sense of place. • Punta Gorda in Bloom – The Punta Gorda in Bloom project continues on Taylor Street. Volunteers met on Monday to plant the latest addition to the Taylor Street plantscape. With the exception of the meter and some irrigation needs, the project is being funded by Alan Schulman, Watchdog Sump Pumps. Together with TEAM Punta Gorda and chaired by Richard Polk, the group has installed pole planters at Hector House Plaza, pole planters and planter boxes at the County Courthouse, and planted pots in groups along the sidewalk. A group of 40 plus volunteers will maintain these plantings throughout the year.

If you plan on biking around the City of Punta Gorda (or anywhere in Florida), please be sure to follow the Bicycle Etiquette and Florida Law:

Obey traffic signals and signs

Ride with the flow of traffic

➤ Riding against the flow of traffic is illegal and dangerous

Use of lights is required from dusk until dawn

- Law requires a white front light and red rear light
- ➤ Battery powered Christmas or other colored lights on bicycle frame or wheels can enhance visibility and fun too

Yield the right-of-way when entering a roadway

Yield to pedestrians in crosswalk

Remember that:

- ➤ People riding bicycles are allowed on all roadways in Florida except where specifically prohibited
 - People riding bicycles have the right to occupy the travel lane if the travel lane is not wide enough for the safe passage of both a vehicle and a bicycle
 - A vehicle passing a bicycle must give a minimum of 3 feet of clearance to the person on the bicycle
- ➤ Bicycles are permitted on sidewalks
 - Be sure to yield to pedestrians and other slower users
 - Be sure to signal by ringing a bell or calling out "Passing on your [right or left]" when passing
- ➤ Helmets are required for any rider under 16 years old

Code

- **Permits required** Staff would like to remind our residents and contractors that a Right-of-Way (ROW) permit is required prior to restoring or re-sodding any right-of-way, for all properties, developed or vacant. ROW permit applications must be submitted by a licensed contractor. The ROW permit will initiate a line and grade inspection to ensure that proper drainage is maintained as the property is restored.
- **Signs in the Right-of-way** (**ROW**) Code Compliance has resume the enforcement and removal of all signs placed *in a public ROW*, in all zoning districts, regardless of content, with the exception of approved special event signage.

Public Works

Canal Maintenance

- Seawall Replacement Projects The seawall replacement contractor has six projects under construction and seven projects completed in Punta Gorda Isles. There are 26 seawall replacement projects scheduled for Punta Gorda Isles. All seawall replacement projects in Burnt Store Isles have been completed. A seawall project is not considered complete until the sod has been placed.
 - > Crews filled depressions at 26 locations.
 - > Crews patched/repaired 326' linear feet of seawall.
 - > Crews removed one piling from the canal.

Engineering

- Adrienne Street Pier Awaiting the delivery of materials. The pier is currently closed to the Public and will remain so until the work is complete.
- City of Punta Gorda Municipal Separate Storm Sewer System (MS4) Audit As part of the City's National Pollution Discharge Elimination System (NPDES) permit the year two Annual Report has been completed and deemed satisfactory by the Florida Department of Environmental Protection.
- **City Wide Drainage Swale Regrading** Work was completed along Segovia Drive. Work is underway along Santander Drive and Portofino Drive.
- Palm Avenue between Chasteen Street to McGregor Street Road Closure Construction continues on Palm Avenue from the Chasteen St. intersection to McGregor Boulevard. The project has been phased starting with the road closure between the project limits, historic street brick removal and staging. The bricks removal and staging are complete. The Utilities Department has removed and replaced underground water/service and sewer lines receiving Department of Environmental Protection quality drinking water approval on Feb. 26. The next steps of the project are excavation, road bed stabilization, curb and ADA ramp replacements, asphalt base, final sand- in and bricking replacement. Travelers are advised to use extreme caution and be alert while workers are present in the right-of-way. Please allow additional time for travel for detours and while work is performed. Temporary delays are to be anticipated.

Police

- **Help Reduce Crime** Punta Gorda has seen multiple vehicle burglaries and several stolen vehicles already in 2021. All of these crimes involved vehicles that were left unlocked at night and those that were stolen had keys that had been left in the vehicles. These crimes are being committed by criminal groups from outside our area. These groups are not interested in breaking into vehicles and are only targeting vehicles that are unlocked and have keys left in them. Please help us reduce crime in our community by removing valuables and locking your vehicle every night!
- **Police Officer Testing** The police department is currently accepting applications for the position of Police Officer. Testing will be held on Apr. 19 with oral board interviews scheduled on Apr. 20 and Apr. 21. Currently we are only accepting applications from candidates who are currently certified, Equivalency of Training (EOT) eligible, current law enforcement academy students, or those with prior experience in a law enforcement related field.
- **Public Safety Dispatcher Testing** The Punta Gorda Police Department is currently accepting applications for the position of Public Safety Dispatcher. Testing will be held on Apr. 26.

- Internship Program The police department is currently accepting internship applications for the Summer & Fall Semesters of 2021. Our internship program is open to college students and high school seniors interested in gaining educational experience in law enforcement, criminal justice, and small government administration. 

Current Board and Committee Vacancies (Volunteer Appointment Information Form)

- **Board of Zoning Appeals** (Two alternates) Meets the fourth Tuesday at 4 p.m. in City Council Chambers. City residency required. Seven member board with two alternate members. Three year terms, maximum of three terms. Financial disclosure required. Makes recommendations to City Council on variances to City Code.
- Building Board (One alternate) Meets the fourth Tuesday at 9 a.m. in City Council Chambers City residency not required. Seven member board with two alternate members. Three year terms, maximum of three terms. Four members must be involved with the building industry and three members must be consumer advocates who are not, nor ever have been, involved with building industry. Makes recommendations to City Council on the minimum qualifying requirements for obtaining Certificates of Competency in the various construction trades and the fees for same. Periodically reviews and holds public hearings on all building, electrical, plumbing, housing, gas, fire prevention and other related codes. Reviews enforcement of all codes relating to construction standards and acts as condemnation board in matters of violation of minimum standards. Hears alleged complaints against contractors.

- **Utility Advisory Board** Meets the fourth Monday at 9 a.m. in City Council Chambers. Must be City resident. Seven-member board. Three-year terms, maximum of two terms. Makes recommendations to City Council with regard to, but not limited to, revisions to the utility construction standards, alleged billing discrepancies and review of utility specifications.
- **Donation Review Committee** (representative of non-profit organization related to history of City) Meets quarterly, as needed, immediately following meetings of the Historic Preservation Advisory Board. Five member board. Three of the total five members will be appointed from the Historic Preservation Advisory Board membership. Reviews nonmonetary donations received by the City and recommends acceptance or rejection of same.
- **Firefighters' Pension Board** Meets quarterly and as called in Council Chambers. Five members two City residents, two firefighters and one at-large as appointed by the Board. Two year terms no maximum. Financial disclosure required. Charged with management of the Firefighters' Pension Fund.
- General Employees' Pension Board Meets quarterly and as called in Council Chambers. Five members – two City residents, two general employees and one at-large as appointed by the Board. Four year terms – no maximum. Financial disclosure required. Charged with management of the General Employees' Pension Fund.
- **Historic Preservation Advisory Board** (One regular and two alternates) Meets the fourth Thursday at 9:00 a.m. in City Council Chambers. Must be City resident. Seven member board with two alternate members. Two members must reside within the Historic District. Three year terms, maximum of three terms. Identifies for the City Council historically significant structures and sites that should be considered for designation as a "Local Historic Landmark" or be nominated for listing on the Florida Master Site File and the National Register of Historic Places. Makes recommendations of the policies for the protection of historically significant structures and sites. Makes recommendations to staff with regard to certificates of appropriateness for any demolition, variance, sign or relocation of structures. Promotes public awareness of historic preservation.
- **Burnt Store Isles Canal Advisory Committee** Meets the second Tuesday at 1:30 p.m. in City Council Chambers. Must be resident of Burnt Store Isles. Five member board. Three year terms maximum of three terms. Makes recommendations to City Council on effective maintenance of existing canals, waterways and navigable channels within the district, together with the maintenance and reconstruction of seawalls. Holds public hearings and makes final decision on petitions for special permit to the provisions of Section 6-6(c) of the City Code of Ordinances.
