City Manager

• **City Manager Column** – As we begin to cautiously emerge from the COVID-19 pandemic, the City of Punta Gorda is welcoming residents and visitors to participate in a variety of events that add to the charm of Punta Gorda. From arts and culture to preserving our historic, charming walkable downtown, March offers opportunities to be a part of the relaxed community that is Punta Gorda.

It is a big month for the Visual Arts Center (VAC) in Punta Gorda. Not only do they serve the community with three major galleries, six classrooms, jewelry, glass, pottery and technology studios, an extensive arts library, gift gallery and art and supply store. They also



provide the best art classes, instructors, and exhibit opportunities for the community in their 12,000 square foot facility located at 210 Maud Street.

The VAC also puts on one of the best art festivals in Florida. The Peace River National Art Festival is held March 20 and 21 from 9 a.m. to 4 p.m. in Laishley Park, at 120 Laishley Court on the waterfront of Punta Gorda. The Peace River National Art Festival is Charlotte County's premiere outdoor juried fine arts show. The two day event draws over 8,000 visitors. Nearly 100 nationally recognized juried artists represent various mediums including art glass, fiber arts, jewelry, leather goods, metalwork, oil paintings, photography, pottery, stone sculptures and watercolor. Live music, art demonstrations and an array of food and beverages complement the art show for an immersive cultural experience. Masks and full precautions are required and admission is \$5.00 per person to support the VAC.

Next week the city will host Code Framework Workshops. The first workshop will take place on March 23 from 6 p.m. to 7:30 p.m. at the Military Heritage Museum and via Zoom. Dover, Kohl and Partners (DKP) will define land development regulations and form-based codes (FBC) to help the public understand these processes. Discussion will also be held regarding the challenges with Punta Gorda's existing zoning regulations. The planning team will present some initial elements for the future FBC framework for the community to consider. Participants will be asked what building types are preferred and where they are appropriate as well where the most and least intense building forms should be permitted.

The second workshop will take place on March 30 from 6 p.m. until 7:30 p.m. at the Military Heritage Museum or available via Zoom. In the second part of this two-meeting workshop, DKP will recap the community input from part one and the technical meetings. The team will present an updated regulating plan that divides the FBC area into distinct zones that correspond to unique building form standards. Participants will have a chance to recommend revisions to the defined zones and be asked about specific architectural styles, building form standards, and frontage types that are appropriate for each zone. - Vehicle Burglaries and Thefts Over the past several years we have had multiple incidents of vehicles burglaries and vehicle thefts in Punta Gorda. Most of these are linked to well organized theft groups out of the St. Petersburg/Bradenton area. These groups arrive in small number in the middle of the night and quickly make their way through neighborhoods looking for unlocked vehicles and vehicles with keys left inside. In nearly every one of these instances, the vehicles that were buglarized were unlocked with valuables left inside and the vehicles that were stolen had the keys left inside. While we are certainly happy that our residents feel safe and secure in our community, those feelings of security that lead residents to leave their vehicles unlocked and what is causing our community to be targeted. Please remember to remove valuables and keys from your vehicle and lock your vehicles doors each night!

Code

- **Permits required** Staff would like to remind our residents and contractors that a Right-of-Way (ROW) permit is required prior to restoring or re-sodding any right-of-way, for all properties, developed or vacant. ROW permit applications must be submitted by a licensed contractor. The ROW permit will initiate a line and grade inspection to ensure that proper drainage is maintained as the property is restored.
- **Signs in the Right-of-way (ROW)** Code Compliance has resume the enforcement and removal of all signs placed *in a public ROW*, in all zoning districts, regardless of content, with the exception of approved special event signage.

The Code Framework Workshops have been designed to involve the community of Punta Gorda in establishing the building blocks of the new form-based code (FBC). In the second part of this two-meeting workshop, DKP, will summarize the community input from Part I, as well as input received during the technical meetings. The team will then present an updated Regulating Plan, which is a fine-grained version of a zoning map that divides the FBC area into distinct zones that correspond to unique building form standards. Participants will be asked if they agree or not with the zones defined in the plan and will have a chance to recommend revisions. To get into more detail about the character of development that is appropriate for each zone, participants will also be asked about specific architectural styles, building form standards, and frontage types.

Public Works

Canal Maintenance

- Seawall Replacement Projects The seawall replacement contractor has eight projects under construction and nine projects completed in Punta Gorda Isles. There are 26 seawall replacement projects scheduled for Punta Gorda Isles. All seawall replacement projects in Burnt Store Isles have been completed. A seawall project is not considered complete until the sod has been placed.
 - > Crews filled depressions at 12 locations.
 - > Crews patched/repaired 143' linear feet of seawall cap/seams.
 - > Crews removed one piling from the canal.
 - > Crews replaced several of the missing and/or damaged boards at the Burnt Store Isles Lock (inlet).

Engineering

- **Serenity Garden Sidewalk at Nature Park** The contractor has postponed the project to a future date due to technical issues. The project will be re-scheduled.
- City Wide Drainage Swale Regrading Work is complete on Santander Drive and Portofino Drive. Work will begin on Terin Court next week.
- **King Street Survey and Plan** The survey work continues.



- Adrienne Street Pier Beginning the week of Mar. 22 through Apr. 16 pending material delivery and weather permitting, construction is scheduled for rehabilitation to lift the Adrienne St. pier and place pile jackets. The pier will be closed to the public while work is being performed. It will re-open following completion. Pedestrians and cyclists are required to use extreme caution while workers are present in the right of way. - Madrid Boulevard Warranty Work Beginning the week of Mar. 29 through Apr. 2 (weather permitting), warranty work is scheduled to correct settlement dips on Madrid Blvd. near the Publix Plaza entrance. Single lane closures are to be anticipated while work is performed. Travelers are requested to use extreme caution while workers are present in the right of way and allow additional time for travel. Temporary delays are to be anticipated. - Palm Avenue between Chasteen Street to McGregor Street Road Closure Contractor has commenced with the excavation of existing materials. The following contracted scope of work is: some curb replacements, ADA ramps, crushed concrete road base, asphalt, sand and re-placement of historic street bricks. This work is anticipated to complete in May (weather permitting).



• **Board of Zoning Appeals** – (Two alternates) Meets the fourth Tuesday at 4 p.m. in City Council Chambers. City residency required. Seven member board with two alternate members. Three year terms, maximum of three terms. Financial disclosure required. Makes recommendations to City Council on variances to City Code.

- **Utility Advisory Board** Meets the fourth Monday at 9 a.m. in City Council Chambers. Must be City resident. Seven-member board. Three-year terms, maximum of two terms. Makes recommendations to City Council with regard to, but not limited to, revisions to the utility construction standards, alleged billing discrepancies and review of utility specifications.
- **Donation Review Committee** (representative of non-profit organization related to history of City) Meets quarterly, as needed, immediately following meetings of the Historic Preservation Advisory Board. Five member board. Three of the total five members will be appointed from the Historic Preservation Advisory Board membership. Reviews nonmonetary donations received by the City and recommends acceptance or rejection of same.
- **Firefighters' Pension Board** Meets quarterly and as called in Council Chambers. Five members two City residents, two firefighters and one at-large as appointed by the Board. Two year terms no maximum. Financial disclosure required. Charged with management of the Firefighters' Pension Fund.
- **General Employees' Pension Board** Meets quarterly and as called in Council Chambers. Five members two City residents, two general employees and one at-large as appointed by the Board. Four year terms no maximum. Financial disclosure required. Charged with management of the General Employees' Pension Fund.
- **Historic Preservation Advisory Board** (One regular and two alternates) Meets the fourth Thursday at 9:00 a.m. in City Council Chambers. Must be City resident. Seven member board with two alternate members. Two members must reside within the Historic District. Three year terms, maximum of three terms. Identifies for the City Council historically significant structures and sites that should be considered for designation as a "Local Historic Landmark" or be nominated for listing on the Florida Master Site File and the National Register of Historic Places. Makes recommendations of the policies for the protection of historically significant structures and sites. Makes recommendations to staff with regard to certificates of appropriateness for any demolition, variance, sign or relocation of structures. Promotes public awareness of historic preservation.
- **Burnt Store Isles Canal Advisory Committee** Meets the second Tuesday at 1:30 p.m. in City Council Chambers. Must be resident of Burnt Store Isles. Five member board. Three year terms maximum of three terms. Makes recommendations to City Council on effective maintenance of existing canals, waterways and navigable channels within the district, together with the maintenance and reconstruction of seawalls. Holds public hearings and makes final decision on petitions for special permit to the provisions of Section 6-6(c) of the City Code of Ordinances.
