

Weekly Highlights Report May 7, 2021

City Manager

• City Manager Column – April was a busy month for the City of Punta Gorda. The progress of the city continues to move forward with each passing month. I'll highlight a few of the projects that have been recently completed or are currently underway. The Punta Gorda Fire Department partnered with the residents of the Fountain Court community by assisting them with their annual smoke detector maintenance. They performed smoke detector services at a total of 25 units consisting of 107 smoke detector battery change outs. This a service that the fire department offers to its residents to help reduce fall risks for those who are not able to climb ladders.



This is just one of many programs our fire department offers to help keep our community the best place to live.

The Public Works division has had the street rebricking on Palm Avenue completed. This project restored the historic bricks between Chasteen Street to McGregor Street to maintain the high quality community character of the city. The division also had Madrid Boulevard warranty work completed including the placement of thermoplastic striping. Herald Court Center is looking a bit brighter at night due to the replacement of 28 light fixtures. Significant progress is also being made on the Historic District Infrastructure Project East of US 41. 71 lights are being converted to LED and 30 new LED lights are being installed.

The Utilities Division is seeking City Council approval of a developer's agreement with LP

Promotions, LLC for a Riverside Drive force main extension project. The force main extension is needed by the developer to construct a RV park named Palm Breeze Resort. The force main project is designed to provide wastewater service to the developer's project and also to 4 existing mobile home park communities along Riverside Drive currently using on-site treatment plants. There is considerable advantage to the City when a developer designs and constructs the facility, and the transfers it to the City upon completion. The agreement is seeking for the City to fund 75% of cost as the developer's flow is approximately 25% of the total project flows, with the developer also designing and installing the infrastructure.

The Urban Design Department is continuing to solicit stakeholder input regarding form based code implementation in the city. The presentations that were led by representatives of Dover, Kohl and Partners, LLC can be viewed at https://www.puntagordamasterplan.com/.

All of these projects and the many more that are currently underway reflect the values of the city including maintaining a culture of community engagement, teamwork, partnerships, transparency, respect, customer service and stewardship. This highlights the necessity of infrastructure maintenance and improvements as well as service enhancements as we move through our budget process. Supporting and promoting local businesses and creating a high level of openness for the fair and equitable treatment of all residents is an ultimate goal as we look forward to continuing to serve the residents of Punta Gorda.

- **Important Notice for Utility Customers** Effective Jun. 1, pre-Covid policies of assessing penalties for late payment and shutting off water service on past due account will resume. This will apply to all accounts with a past due balances. Payments made by credit card will incur the same processing fee that was in place before Covid concessions were granted.
- Comcast Update Comcast reports that most, if not all messy wires have been cleaned up. The City Manager and Mayor stated there are still several locations we feel need to be addressed, so we will do a drive around and take photos, noting addresses for them to come back to address. They also reported that they have now relocated all wires on duplicate poles in Burnt Store Isles, and there are approximately 27-30 poles still remaining to be done in Punta Gorda Isles. They estimate it will take approximately one month to finish moving those. We will now be going to email communications for updates, rather than video calls, and if additional calls are needed, we will schedule them.

Urban Design

- Gulf Coast Partnership Staff attended the Gulf Coast Partnership monthly meeting where legislative updates were reported. Although SB 2512 on affordable housing cuts the annual designated share from the housing trust funds by more than half, from at least \$423 million to \$209 million, locally it was a good Legislative Session: The local funding requests approved are as follows:
 - ✓ Homeless Staffing Grant was fully funded: \$3M
 - ✓ Homeless Challenge Grant was fully funded: \$3,181,500
 - ✓ Affordable Housing: \$209M (recurring at 9.70% of doc stamps moving forward)
 - ✓ ESG-CV1&2 back of the bill language adopted in final version of the budget bill
 - ✓ Additional American Rescue Plan Act funding for homeless children and youth wraparound services in response to COVID-19 provided in final budget

SB 2512 does include language intended to prevent future raids on the housing trust funds, maintaining next year's affordable housing funding as the new floor.

Public Works

Canal Maintenance

- **Mangrove Trimming** The City contractor has started the annual maintenance of trimming mangroves along the Punta Gorda Isles perimeter canal.
- Seawall Replacement Projects The seawall replacement contractor has seven projects under construction and 14 projects completed in Punta Gorda Isles. There are 26 seawall replacement projects scheduled for Punta Gorda Isles. All seawall replacement projects in Burnt Store Isles have been completed. A seawall project is not considered complete until the sod has been placed.
 - > Crews filled depressions at 18 locations
 - > Crews patched/repaired 108' linear feet of seawall cap/seams
 - > Crews removed one large board from the waterway.

Engineering

- Americans with Disabilities Act Ramp Improvements Staff and the contractor reviewed several ADA ramp locations for improvements. Pending is the estimated Statement of Work for processing.
- Adrienne Street Pier After further assessment, the pier will remain closed to the public for additional work.
- City Wide Drainage Swale Regrading Grading and sodding in Burnt Store Meadows on Allamanda Lane is complete. Grading work at the end of Almar Drove is underway and is anticipated to be complete on May 19.
- **King Street Survey and Plan** Engineering staff has received the CAD file and official City of Punta Gorda right of way, boundary and topography survey.

Police

- **Public Facing Policies** As part of our continuing effort to increase transparency with our community, the police department has made our Standard Operating Procedures (department policies) available to the public on our website. The police department has nearly 200 policies that cover everything from how and officer should wear their uniform to how they should handle resistance and firearms. Certain policies that contain confidential and exempt information are not available on the website, but may still be available with redactions through a public records request.
- **Police Officer Testing** The police department is currently accepting applications for the position of Police Officer. Testing will be held on Aug. 23 with oral board interviews scheduled on Aug. 24 and Aug. 25. Currently we are only accepting applications from candidates who are currently certified, Equivalency of Training (EOT) eligible, current law enforcement academy students, or those with prior experience in a law enforcement related field.
- **Public Safety Dispatcher Testing** The Punta Gorda Police Department is currently accepting applications for the position of Public Safety Dispatcher. Testing will be held on Aug. 30.
- Internship Program The police department is currently accepting internship applications for the Fall Semester of 2021 and Spring Semester 2022. Our internship program is open to college students and high school seniors interested in gaining educational experience in law enforcement, criminal justice, and small government administration. 

Only opposed candidate races will appear on the ballot. If more than two candidates seek election for any one district seat, a primary election must be held on Aug. 17 (11 weeks prior to the General Election).
