City Manager

• City Manager Column – Sanitation services have been making headlines across southwest Florida as municipalities and companies have been struggling to meet the needs of residents. We are fortunate in the City of Punta Gorda to have a Sanitation Department, led by Hope Petkus, that puts customer service and fiscal responsibility to our residents at the top of the priority list. These 19 individuals representing the Sanitation Department are critically important to maintaining safe living conditions in the city. Their work often goes unnoticed, unless there is a problem and the garbage is not picked up at the usual time. I'd like to thank each of our Sanitation employees for the work they do every single day.



I'm told that every couple of years or so the city gets asked what the cost savings would be if the city only provided garbage pick-up once per week rather than twice. The resulting analysis has consistently shown that is not significant savings because the amount of total garbage picked up is still the same. It is just spread differently.

Another good question about sanitation services recently posed was why the city is not buying "sidearm" trucks and cutting staff. Other than the cost of a single use vehicle and limitations of a single use business model the answer is actually fairly straightforward - service level. It has been discussed and decided many times before that people do not just want another commercial provider type truck coming down the street picking up a can. The service level we provide includes boxes beside the cans, cans that people can't get to the curb, miscellaneous types of refuse when residents come and go for the season, heavy material, bags that are out instead of cans, etc. We pick up what you put out. People don't like to be limited to a can. We also control our own services so that we do not have the types of incidents being experienced in other municipalities. Between the difference in cost of trucks and maintaining other levels of service delivery, we would essentially need to double our routes. One truck, one operator, one can at each location would certainly be easier, but service levels would drop dramatically. That is what people pay for, service level, and the rate is quite reasonable.

Sanitation services seemed to be a recurring theme last week. In exploring the house I have recently moved into in Punta Gorda Isles I discovered an in-ground vault outside. It was round, filled with water and about three feet deep. I removed as much of the water as I could but still couldn't read what the paper tag on the bottom of the vault said. As usual, I reached out to the Public Works Director, Rick Keeney, to see if he had any idea what the vault was used for. Sure enough it was used for garbage. Back in the day the city had side door garbage pick-up. The sanitation department used Cushman scooters and would empty the garbage from galvanized cans in the vault, to the scooter, to the mother ship. Talk about service!

We are proud of the service levels we offer residents of the city and take the responsibility of providing those services at the best value possible seriously. This is a special city that needs each and every one of our employees for us to be able to preserve and enhance

Punta Gorda's identity as a vibrant waterfront community, unique in character and history; and as a desirable place to live, work and visit.

- Important Notice for Utility Customers Effective Jun. 1, pre-Covid policies of assessing penalties for late payment and shutting off water service on past due account will resume. This will apply to all accounts with a past due balances. Payments made by credit card will incur the same processing fee that was in place before Covid concessions were granted.
- Florida Power and Light Update In the last two weeks, FPL has pulled 32 more vacated poles where wires were relocated to new poles. There are 252 double poles currently out there, and 164 of them are ready to be pulled, as wires have been relocated to the new poles. There are 88 additional poles that still have wires on them and they are awaiting Comcast and other utility companies to move the wires before they can schedule the poles for removal. Comcast is currently scheduled to relocate wires on 25 of those poles, and another 34 poles have wires that need to be relocated by other utility companies. To date, 286 old poles have been removed of the 538 locations where there new poles have been installed. The hardening project will continue to take place in different locations throughout the City well into next year. We will continue to hold bi-weekly update calls with both utility companies as this project progresses, to insure we keep things moving and all properties get restored after the new installations. If you see wooden stakes behind the poles around the City, those are locations that FPL plans to install new poles at in future months. Residents who will be affected by these installations will be contacted by their sub-contractors as they move around the City, so residents can stay informed of their scheduled dates. If you have a more than one pole in your front yard and an old pole that hasn't been taken down, if wires are hanging on the new pole or any other concern about this project, please email Mayor Matthews with your name, address and contact phone and email along with a photo, and send to <u>lmatthews@cityofpuntagordafl.com</u>. The City Manager and Mayor Matthews are sharing the emails with both companies so all properties get restored.

Canal Maintenance

• Channel Marker Inspections – The Peace River Sail and Power Squadron volunteered to inspect City maintained channel markers. There were two boats teams consisting of three people on each boat that shared the responsibility of handling the boat, collecting and recording waypoint data and taking photographs. Approximately 73 channels markers were inspected and located utilizing the Global Positioning System (GPS) coordinates (latitude and longitude). This data was then compared to the data with the United States Coast Guard Light List. A report with photos was submitted to the City indicating the channel markers were in good condition; however the GPS coordinates for a few markers were not consistent with United States Coast Guard Light List. This information will be followed up with staff. The data collection exercise was performed on Apr. 26. Post processing data and creating the report and work books was tedious and lengthy; this information was submitted to the City on May 9. The Canal Maintenance Division is grateful for all the work the volunteers from the Peace River Sail and Power Squadron performed and look forward to working with them in the future.



- Seawall Replacement Projects The seawall replacement contractor has eight projects under construction and 14 projects completed in Punta Gorda Isles. There are 26 seawall replacement projects scheduled for Punta Gorda Isles. All seawall replacement projects are completed for Burnt Store Isles this fiscal year. A seawall project is not considered complete until the sod has been placed.
 - > Crews filled depressions at 16 locations.
 - > Crews patched/repaired 37' linear feet of seawall cap/seams.
 - > Crews removed one large piling, one large tree from the waterway.
 - > Crews replaced two dock boards at Ponce De Leon Park.
- Americans with Disabilities Act (ADA) Ramp Improvements The City annually schedules sidewalk ramp intersection improvements at various locations for accessibility. Staff and the contractor are reviewing the estimated Statements of Work prior to processing.
- Adrienne Street Pier After further assessment, the pier will remain closed to the public for additional work.
- **City Wide Drainage Swale Regrading** Grading work at the end of Almar Drove is underway and is anticipated to be completed next week.
- **King Street Survey and Plan** The survey is complete and under City review for a street plan.

Emergency Medical Services Audit –The Fire Department received notification last week that the Florida Department of Health would be conducting a random audit of EMS operations for the Fire Department. The audit is specifically focused on EMS operations, personnel training and documentation as well as all advanced life support equipment. State administrative rules require the Bureau to conduct inspections of Emergency Medical Service Providers on a random basis. These


