

# Weekly Highlights Report June 18, 2021

# **City Manager**

• City Manager Column – Every year the City of Punta Gorda shares its priorities for the state budget with the Charlotte County Legislative Delegation. The Boca Grande area of the City of Punta Gorda has been a top priority for the city for a number of years. Fortunately, this year the project emerged as a priority that was supported state wide by legislators and by Governor DeSantis as well.



The City of Punta Gorda, with the assistance of the lobbying firm, Capitol Access has secured a one million dollar appropriation for the Boca Grande Boulevard area water quality improvement

project. The City offers a sincere thank you to Governor Ron DeSantis, State Representative Michael Grant, State Senator Ben Albritton and State Senator Joe Gruters for their support and work on this important initiative. The project also has substantial local support through the one percent sales tax program. The project will increase community resiliency and provide necessary flood control and water quality treatment of stormwater runoff from the city's Boca Grande neighborhood. The area experiences significant flooding and the current drainage conveyance does not provide a formal measure of water quality treatment. The drainage from this area ultimately outfalls to Charlotte Harbor. The harbor and surrounding coastal areas will benefit from the project's treatment of impairments. Design and property acquisition are almost complete and construction is anticipated to in fiscal 2022. start year

While the statewide budgeting process is complete for this fiscal year, the City of Punta Gorda budget process continues at the next City Council meeting. On June 16 at 9:00 a.m. at the Historic City Hall City Council considered the five year capital improvement project proforma including the General Construction Fund, 1% Sales Tax Fund, and Unfunded Construction Projects. They will also reviewed the Fiscal Year (FY) 2022 Burnt Store Isles (BSI) Canal Maintenance Assessment District Budget Status. The FY 2022 Punta Gorda Isles (PGI) Canal Maintenance Assessment District Budget Status was also presented.

Resident engagement is critical to the success of our small city. The City Council meetings have a dedicated time on the agenda for public comment and no longer reading comments received via email into the record. The City Council designates a public comment time to receive in-person comment from members of the public on agenda items

and other items of interest. Anyone wishing to address the Council on any item may do so at this time during the meeting. Those who choose to speak must state their name for the record. Each person will be allowed to speak once on each subject up to a maximum of three minutes. We welcome all residents to attend the City Council and other committee meetings to have their voices heard in the decision making processes for Florida's Harborside Hometown. # **Canal Maintenance**

• Bass and Snook Inlet Dredging — Beginning June 3 through June 18 (weather and equipment operation permitting), the Bass and Snook Inlet is scheduled to be dredged. The contractor will off load dredge material at the easterly end of Elizabeth Park and then the material will be transported to another location by dump trucks. Boaters are asked to please use caution in this area during construction.

• How to Find out If Your Seawall Is Scheduled for Replacement - Residents have been asking how they know when their seawall is scheduled for replacement and how the process works. Every year the City replaces approximately 7,000 lineal feet of seawall. By utilizing the Seawall Assessment Data, the seawall replacement program is planned a year in advance (unexpected seawall failures or seawalls that are inspected and found to be at extreme risk of failure are given top priority and may bump planned projects to the following year). - Seawall Replacement Projects The seawall replacement contractor has nine projects under construction and 17 projects completed in Punta Gorda Isles. There are 26 seawall replacement projects scheduled for Punta Gorda Isles. All seawall replacement projects are completed for Burnt Store Isles this fiscal year. A seawall project is not considered complete until the sod has been placed.
  - > Crews filled depressions at 10 locations.
  - > Crews patched/repaired 4' linear feet of seawall cap/seams.
  - > Crews manufactured (40) 10' feet seawall panels.

# **Engineering**

- Americans with Disabilities Act (ADA) Sidewalk Ramp Improvements The contractor has commenced with work at various locations throughout the City.
- Adrienne Street Pier The contractor has notified City staff that the materials ordered by the contractor are on back log for delivery due to increased demand. Work is to be scheduled accordingly upon delivery tentatively anticipated next month. The pier will remain closed to the public for additional work.
- **Boca Grande Drainage Improvements -** A project progress meeting is scheduled for June 18. 60% to 90% design work continues.
- City Wide Drainage Swale Regrading City staff is reviewing all work completed in 2021 by JRL Underground Utilities as part of the contract close out. City staff is in the process of reviewing bids for a new swale regrading contractor.
- Paving Program City staff has prepared a draft tentative 5 year paving program and provided to Finance Department to include in the presentation to City Council for the upcoming budget year recommending approval. - Taylor Street and West Charlotte Avenue Stop Sign A message board advising motorist of new signage is placed on Taylor Street at the intersection of West Charlotte Avenue. Stop signs will be installed with bags over them until June 21, when the intersection will become a four way stop. Drivers and pedestrians are requested to use extreme caution while drivers become aware of the new traffic control devices. - **Text to 9-1-1** Text to 9-1-1 is a system that allows cell phone users to send text messages to a 9-1-1 operator in situations where making a phone call would be dangerous or impossible. - **Police Officer Testing** The police department conducts new hire testing continually in order to be prepared for future openings. 
# Fire

Three-year terms. Maximum of three terms OR partial term plus two more terms. Financial disclosure required. Makes recommendations to City Council on variances.
- General Employees' Pension Board (Fifth member) Meets quarterly and as called in Council Chambers. Five members two City residents at-large, two general employees and one member appointed by the Board. Four-year terms no maximum. Financial disclosure required. Charged with management of the General Employees' Pension Fund.
- **Planning Commission** Meets the 4th Monday at 2 p.m. in City Council Chambers. Must be City resident. Seven member board with two alternate members. Three year terms maximum of three terms. Makes recommendations to City Council with regard to amending, extending or adding to the comprehensive plan for the physical development of the City, platting or subdividing land within the City and adopting and amending a zoning ordinance.
