

Weekly Highlights Report July 16, 2021

City Manager

• City Manager Column — The work of the City of Punta Gorda and the Charlotte County area has been recognized by the Milken Institute. The Milken Institute is a nonprofit, nonpartisan think tank that catalyzes practical, scalable solutions to global challenges. In collaboration with the Center for Regional Economics, the institute has issued the Best-Performing Cities 2021 Foundations for Growth and Recovery report. The report highlights cities driving economic growth nationwide, including those with businesses creating new jobs, and exhibit policy and investment choices that positively influence the community's economic



In the 2021 report, the Punta Gorda Metropolitan Statistical Area has improved from a 2020 rank of 39th to a 2021 rank of 11th in tier one small cities. The report cites one-year wage growth, short-term job growth, and a unique positive year-on-year job growth. These results are particularly impressive given that majority of jobs are in the service arena.

While those results are encouraging, the report also cites areas of opportunity. The region has room to grow in the area of high-tech industrial specializations. Although the area was 170th in high-tech gross domestic product (GDP) growth, this is an improving statistic as high tech GDP has grown 58.6 percent over the previous five years. The other area of opportunity noted is housing affordability. Low housing affordability is seen as a liability to the area. The authors noted the age distribution as being more even in Punta Gorda than other small cities from the outside looking in, citing a population of only 56 percent of the population aged 65 and older as a positive. Other positives include the investment in the City's recovery post-Hurricane Charley and the development of the tourist industry. They attribute the high local real estate demand to investments in amenities such as local parks and an improved downtown area due to careful planning.

Preservation of our City's unique assets and improvement in the availability of affordable housing are two large areas of current focus for the City. Progress is being made in affordable housing with the potential expansion of the Verandas III on Airport Road. I have also placed a new internal focus on forecasting the needs of the city departments and divisions to meet the goals and objectives of long-term plans, including maintaining the City's unique assets. This includes developing a clear understanding of operating impact for each Capital Improvement Project, staffing needs, and equipment needs for the City.

Careful planning also continues with the development of form-based codes to produce predictable built results and a high-quality public realm by using physical form (rather than separation of uses) as the organizing principle for the code to continue to preserve our small-town character while promoting diversity, economic development and sustainability. - Taskforce for Abandoned African-American Cemeteries Councilmember Cummings was just appointed by Secretary of State Laurel Lee to represent local government on the Taskforce for Abandoned African-American Cemeteries. This taskforce was created by the Florida Legislature this session through CS/CS/HB 37. His term begins immediately and will continue until the expiration of the task force in March 2022. He will be attending the inaugural meeting of the Task Force in Tallahassee on July 20.

 Planning Corner – New Law — As of July 1, Florida Statute Chapter 162 no longer permits anonymous violation complaints.

You must give your name and address before we can accept your complaint.

Florida Statute Chapter 162, 162.06 (1) (b); and 162.21 (3) (b): A Code Enforcement Officer may not initiate



enforcement proceedings for a potential violation of a duly enacted code or ordinance by way of an anonymous complaint. A person who reports a potential violation of a code or an ordinance must provide his or her name and address to the respective local government before an enforcement proceeding may occur.

If a complainant states that he or she has a substantial fear of retaliation or of status-based legal jeopardy; which must be expressed by the complainant, then: The complainant must be advised that if the claim is a false claim of fear of retaliation or of status-based legal jeopardy, then they are liable for all costs incurred by the City of Punta Gorda in investigating the claim of violation, including costs of personnel, equipment, testing, and reasonable costs and attorney fees if the City of Punta Gorda brings an action to prosecute the complainant or to collect amounts made payable.

Public Works

Canal Maintenance

- How to Find out If Your Seawall Is Scheduled for Replacement Residents have been asking how they know when their seawall is scheduled for replacement and how the process works. Every year the City replaces approximately 7,000 lineal feet of seawall. By utilizing the Seawall Assessment Data, the seawall replacement program is planned a year in advance (unexpected seawall failures or seawalls that are inspected and found to be at extreme risk of failure are given top priority and may bump planned projects to the following year). - Seawall Replacement Projects The seawall replacement contractor has nine projects under construction and 18 projects completed in Punta Gorda Isles. There are 26 seawall replacement projects scheduled for Punta Gorda Isles. All seawall replacement projects are completed for Burnt Store Isles this fiscal year. A seawall project is not considered complete until the sod has been placed.
 - Crews filled depressions at 43 locations.
 - > Crews patched/repaired (four linear feet) of seawall cap/seam.
 - > Crews conducted sonar depth reading for the Burnt Store Isles.

Engineering

- Americans with Disabilities Act (ADA) Sidewalk Ramp Improvements The contractor continues with demolition, construction and updates for (ADA) sidewalk ramps
- Adrienne Street Pier The contractor is tentatively scheduled to complete pile jacket installations this week, weather permitting. Work is also being completed on the decking and hand rails.
- **Boca Grande Drainage Improvements** Bi-weekly design project update meetings continue. The design is in process, with 60% to 90% plans complete.
- City Wide Drainage Swale Regrading The contractor has indicated that they will begin work on the punch list next week. A new swale contractor has been selected. Swale regrading will begin once everything has been finalized to commence work.
- **Henry Street Sidewalk** All surveying information has been received and the design will continue. We will begin coordination with FDOT on work within their drainage easement and the sidewalk connection at US41.

Police

- New Bicycle Laws Governor DeSantis signed into law a bill designed to improve bicycle safety. The Punta Gorda Police Department Volunteer Bike Unit will be out ensuring that the community is educated on these changes. The following changes went into effect on July 1,:
 - ➤ Vehicles who drive left of center in order to overtake a bicycle may do so even in a no-passing zone as long as the vehicle is able to provide the bicyclist three feet of clearance. If the vehicle cannot provide three feet of clearance they must wait until they can safely pass.
 - A vehicle turning right while passing a bicyclist can do so only if the bicyclist is at least 20 feet from the intersection and at a safe distance from the vehicle.
 - ➤ Bicyclists riding in groups must come to a complete stop at stop signs, but then may proceed through the intersection in groups of 10 or fewer. Motorists are required to let the group pass before proceeding through the intersection.
 - ➤ Bicyclists may temporarily ride two abreast on roadways with substandard-width lanes (the majority of roadways in Florida) to avoid hazards in the roadway or to overtake another bicyclist.
 - This bill also includes requirements for an educational and awareness campaign and requires that the State of Florida add bicycle safety questions to the bank of questions for driver's license exams.
- Police Officer Testing The police department conducts new hire testing continually in order to be prepared for future openings. We are currently accepting applications for the position of Police Officer. Testing will be held on August 23 and oral board interviews scheduled on Aug. 24 and 25. We are only accepting applications from candidates who are currently certified, Equivalency of Training (EOT) eligible, current law enforcement academy students, or those with prior experience in a law enforcement related field.

- **Public Safety Dispatcher Testing** The Punta Gorda Police Department is currently accepting applications for the position of Public Safety Dispatcher. Testing will be held August 30.
- Internship Program The police department is currently accepting internship applications for the Fall Semester of 2021 and Spring Semester 2022. Our internship program is open to college students and high school seniors interested in gaining educational experience in law enforcement, criminal justice, and small government administration. 
