

# Weekly Highlights Report Aug. 20, 2021

## **City Manager**

• City Manager Column – One of the first things that impressed me about the City of Punta Gorda was the quality of the staff and the attention given to customer service. Every week I am fortunate to hear from residents about their experiences with our city staff. I'll share a few of the stories of the people that deliver a high level of service to our residents.

This accolade comes in courtesy of Mr. Sabatini, "On Aug. 5, I called in a main water line rupture on Wren Court at 6 a.m. The city crews responded within an hour. But what was amazing was Troy and his team working on the leak. It was like



watching a team of surgeons work together. Each person was anticipating what the next step would be and would get a tool or piece of pipe or a valve ready. Hand it to the person doing the work and he could quickly move to the next step. The repair was done quickly and safely."

Last week a resident suffered a fire in their home at the Eagle Point Mobile Home Park. Mr. Gentry shared the following about events that transpired, "Yesterday I arrived at a patient's house to provide them with oxygen to find their home on fire. I had met the homeowner a handful of times previously and knew she had a few dogs inside. I'm writing to tell you how lucky you are to have the men and women on your team, particularly Mr. Lewandowski and a fire inspector whose name I was unable to catch due to the situation. I helped this particular gentleman (the fire inspector) try to revive the dogs that were pulled out of the house. The inspector worked tirelessly to revive the animal... he went above and beyond to show kindness and provide some dignity to someone's friend... Mr. Lewandowski is a top notch leader and stand up gentleman. I am proud that he works in such an important capacity for our City. His leadership skills are second to none. He remained calm and cool while coordinating his team's effort. And he talked to his men and women with utmost respect. I could tell he cares about each and every one of them by the way he spoke to them. I thank you and all the men and women in your fire stations."

The Public Works Department received a call regarding the sanitation services provided by John Giamanco and Rob Hemingway. Ms. Precorelli was impressed with the extra steps taken to make sure and place the empty garbage cart away from the flooded swale. This action allowed her to retrieve her cart without getting her feet wet. The attention to detail was an amazing surprise. Public Works also received a call regarding the impressive services provided by Canal Maintenance workers Michael Wessels and Gary Koska. Ms. Dickisson expressed her appreciation of their hard work and dedication and went on to say they did a tremendous job filling in the depressions around the seawall.

#### **Lot Mowing**

- The City has completed moving the following areas:
  - ➤ Downtown and Historic District (W Marion Ave, W Olympia Ave, Shreve St, and Harvey St).
  - ➤ The Historic District located East of and the area behind Dunkin Donuts (E Marion Ave, E Olympia Ave, Narranja St, E Henry St, Cooper St).
  - ➤ PGI (Magdalina Drive, Via Vento, W Henry St, Appian Drive, and Columbian Drive).
  - ➤ PGI Bird Section (Almar Drive, Albatross Drive, Whippoorwill Blvd, and Dove Blvd).
  - ➤ PGI (Bal Harbor Blvd, Deborah Drive, Ryan Blvd, Suzi St, and Casey Key Drive). There are several undeveloped lots throughout the City that are under water during the rainy season which are only able to be partially mowed. In an effort to avoid damaging the property and lot mowing equipment, mowers will not mow areas that are too wet or areas that are underwater. We understand that the properties can be an eyesore, but as soon as they are dry enough to mow without causing any damage to the property or equipment, the mowers will mow them.

## **Urban Design**

• Planning Corner – Federal Transportation Funds, Florida Department of Transportation, and Local Agency Program – Nationwide, approximately 75% of 2.9 million of the 3.9 million total miles of roadway are owned and operated by local public agencies. The Local Agency Program, or "LAP," provides towns, cities, and counties the opportunity to develop, design, and construct these vital transportation facilities with federal funds. The Florida Department of Transportation (FDOT) is the steward of the



federal transportation funds in Florida and is responsible for oversight of funded projects by the US Department of Transportation, including Federal highway Administration (FHWA), Federal Transit Administration (FTA), and Federal Aviation Administration. The local governments within Charlotte County, Charlotte County BOCC, City of Punta Gorda, and the Punta Gorda Airport prioritize and fund local projects through the Charlotte County – Punta Gorda Metropolitan Planning Organization. Local governments designated as LAP agencies are then eligible for reimbursement with federal funds of projects undertaken to improve the transportation network.



To become more eligible to directly oversee federally funded transportation projects, local governments must become LAP certified. The rigorous certification process ensures that the local agency has the sufficient qualifications and ability to "undertake and satisfactorily complete the work" funded with federal dollars. The certification provides proof that the local agency is able to comply with federal requirements in a

project and offers perspective to the level of oversight required by the FDOT and the local agencies over the life of a LAP project. The primary benefit of the LAP program to the FDOT is that the resources of LAP certified local governments provide a "force multiplier" effect, which permits the State of Florida to produce transportation projects more quickly and efficiently for the benefit of the traveling public. The local government LAP certification permits a higher degree of local decision-making control over project design and construction. This local control provides projects, which are generally more responsive to local conditions, culture, and needs. In order for local government to become LAP certified, it must demonstrate to the FDOT and to the federal officials of FHWA a minimum level of professional competency in financial controls, compliance with federal rules, and qualifications of personnel. Certification Elements include (but are not limited to):

- ➤ Local Agency Staff Qualifications
- ➤ Professional Services Procurement Procedures for fair, open, and competitive selection of qualified consultants
- > Sub-recipient Compliance for Title VI and related Non-Discrimination authorities
- ➤ Construction Contract Procurement
- Construction Contract Administration, including Construction Engineering and Inspection and Contract Compliance
- ➤ Materials Testing and Acceptance Quality Assurance Review

Full Certification is reserved for those agencies whose staff demonstrate the qualifications, capability, and achievement of performance expectations between certification cycles. As of Aug. 17, the City of Punta Gorda has just received full re-certification approval in the following functional areas and processes:

- ➤ Planning 1
- Design
- Construction
- Construction Administration

By maintaining LAP Certification since the early 2000's, the City has overseen millions of dollars' worth of federal and state transportation funded projects, including:

- ➤ US 41 Multi-Use Recreational Trail (Phases I, II, and III)
- ➤ Gilchrist Park Harborwalk West Area 1
- ➤ Alligator Creek Bridge

As a LAP Certified local government agency, the City of Punta Gorda will continue to work with the FDOT to ensure that projects funded with federal and state transportation dollars within the City are used in a manner consistent with local needs for mobility and safety for all roadway users.

#### **Public Works**

#### **Canal Maintenance**

- Seawall Replacement Projects There are 26 seawall replacement projects scheduled for Punta Gorda Isles. The seawall replacement contractor has three projects under construction and 23 projects completed in Punta Gorda Isles. There is one seawall replacement projects currently under construction and four projects completed in Burnt Store Isles. Four seawall replacement projects were originally scheduled for Burnt Store Isles this fiscal year; however another site was added due to a seawall failure. All seawall replacement projects are completed for Burnt Store Isles this fiscal year. A seawall project is not considered complete until the sod has been placed.
  - > Crews filled depressions at 42 locations.
  - Crews recovered broken Pompano channel marker #5 from Port Charlotte Beach.
- Seawall Replacement Schedule Wondering if you seawall is on the list to be replaced in the next fiscal year 2021/2022? Every year the City replaces approximately 8,000 lineal feet of seawall. By utilizing the Seawall Assessment Data, the seawall replacement program is planned a year in advance (unexpected seawall failures or seawalls that are inspected and found to be at extreme risk of failure are given top priority and may bump planned projects to the following year).

## **Engineering**

• Americans with Disabilities Act (ADA) Sidewalk Ramp Improvements — The contractor has recently completed sidewalk ramps at the following locations: Marion Ave. at Maude St. on all three quadrants. The contractor continues to work at: Aqui Esta Dr. at Socorro Dr. and the SE quadrant of Aqui Esta Dr. at Bal Harbor Blvd. Schedules are in the process of coordination for work to be performed at: E. Charlotte Ave. at Milus St. and E. Charlotte Ave. at Cooper St., weather dependent.

- Adrienne Street Pier The pier is partially open to the public at this time. The tee at the end of the pier remains closed until further repairs can be made. The City contractor is tentatively scheduled to mobilize in Sept. to make repairs to the end tee.
- **Boca Grande Drainage Improvements** Bi-weekly 60% to 90% design project update meetings continue. The next meeting is scheduled Aug. 27. The property acquisitions are in the final phase. Coordination with the permitting agencies continues as part of the design phase.
- City Wide Drainage Swale Regrading The contractor has indicated the punch list is complete. City staff will follow up with an inspection. A new swale contractor has been selected. Swale regrading will begin once everything has been finalized to commence work.
- The Historic District East of US 41 Lighting Project The conversion of 71 high pressure sodium street lights to LED lights has been completed. The installation of 30 new street lights on existing utility poles and four new decorative street lights on concrete poles has also been completed. 11 of 13 new LED street lights on new poles have been installed. The remaining two lights should be installed soon. City staff is in the process of verifying what has been completed as our updates have been coming from communication with FPL.
- **Henry Street Sidewalk** All Surveying information has been received and the design will continue. Coordination continues with FDOT on work within their drainage easement and the sidewalk connection at US41.

#### **Parks and Grounds**

- Laishley Park Interactive Fountain Closed Laishley Park Interactive Fountain will be closed until further notice for repairs
- Renovations of the old FGCU Campus Renovations of the 'old' FGCU campus at 117 Herald Court have begun. The space will house the Clerk and Finance Divisions during the renovation of the Historic City Hall building.

# Right-of-Way

• **Storm water Pipe Repairs** – Work continues to repair a failed storm water pipe at 109 Hibiscus Dr. Work is scheduled to be complete the week of Aug. 30 (weather permitting). Travelers are requested to use extreme caution while workers are present in the right-of-way and allow additional time for travel. Temporary delays are to be anticipated.


# **Fire**

• **Training** – The fire department conducted fire scenario evolution training this week. The training involved many scenarios which may occur very quickly on a fire scene such as; forcible entry, search and rescue in low/no visibility with victim removal, fire extinguishment and ventilation. The training was conducted at the fire training facility (old station-two) utilizing simulated smoke and various props. This type of training is extremely valuable to both new as well as experienced firefighters in that a fire scene is extremely dynamic and constantly changing so being prepared for the worst case scenario is essential.

- Hardness is a measurement of calcium and magnesium ions naturally occurring in the raw water. Currently "hard" – Grains of Hardness 7 ppm –Total hardness 120 ppm

#### **Wastewater Treatment**

• Maintenance – Florida Power and Light installed a new transformer at the plant after a suspected lightning strike caused a failure of one phase of the three phase system. The plant's



generator automatically supplied power for the essential machinery and remained in service for approximately 15 hours until standard power was restored. Maintenance crews continue to mow and trim the plant and remote station grounds. A crew member has started the process of spraying the hay fields with a selective weed killer. Fifty acres have been sprayed to date. The maintenance crew has performed preventive maintenance on several air compressors, grit pumps, effluent pumps, and hydro pumps.

• **Operations** – The average daily flow for the past week was 2.87 million gallons for a total of 20.12 million gallons of wastewater being treated this week.

Rain totals MPF = 0.37 Plant = 1.21
