City Manager

• City Manager Column – Patriot Day honors and remembers those who died in the Sept. 11 attacks of 2001. This year marks the 20th anniversary. The Punta Gorda City Council recognized the anniversary with an official proclamation at their Sept. 8 meeting. The proclamation conveys the reflection of sentiments felt across the country. "When the Twin Towers were struck and inflamed 20 years ago on Sept. 11. 2001, first responders rushed into the terror and tragedy to do what they do- risk their lives to save lives. Those first responders heroically, courageously, and tirelessly participated in an extraordinarily difficult and dangerous rescue and recovery effort, voluntarily putting their own well-being at risk for the



lives of others. Americans were struck with grief as devastation, and senseless loss of innocent human life unfolded with approximately 3,000 people losing their lives, including 343 firefighters and 60 police officers and nine paramedics."

Taking the time to reflect on the enormity of those losses is so important. This was a day that transformed everyone's lives in some way. Whether it was the loss of a loved one or the feeling of vulnerability, the events created a historic bonding of Americans. The country built off the strength of the rescue workers, firefighters and all first responders to unite our nation to stand strong.

The City of Punta Gorda proclaimed Sept. 11, 2021, as 9/11-20th Anniversary Day of Remembrance and Appreciation of our First Responders, and offer thanks for all first responders have done and continue to do. The efforts of the Punta Gorda Fire Department and Punta Gorda Police Department create a feeling of safety and security as we go about our daily lives. Today and every day, we are thankful to have these committed, talented individuals protecting the City of Punta Gorda.

Volunteers with the police and fire departments also enhance our residents' safety and security, and we are always recruiting new members. The Volunteers in Policing Program is an active and diverse volunteer program including vehicle patrol, bike patrol, marine patrol, community services, and more. • Planning Corner – City staff and the Dover, Kohl and Partners Consultant Team presented the first working draft of the new Form-Based Code in-person and online on Aug. 31 followed by an Open House on Sept. 1. In an effort to make the Proposed Form Based Code easier to understand, Urban Design staff has provided the Table below. The Table outlines the current and proposed building height for each respective regulating districts. In addition, the proposed Community Benefits are provided. Staff is in the process of scheduling a public workshop to be held in October to further explain the proposed changes.



Public Works

Canal Maintenance

- Seawall Replacement Projects There are 26 seawall replacement projects scheduled for Punta Gorda Isles this fiscal year; however another site was added due to a seawall failure. The seawall replacement contractor has one project under construction and 26 projects completed in Punta Gorda Isles. All seawall replacement projects are completed for Burnt Store Isles. A seawall project is not considered complete until the sod has been placed.
 - > Crews filled depressions at 13 locations.
 - > Crews patched/repaired 50' linear feet of seawall cap/seam.
 - > Crews completed Burnt Store Isles storm boom material replacement at 40 storm drain locations.
- Seawall Replacement Schedule Wondering if your seawall is on the list to be replaced in the next fiscal year? The annual Seawall Replacement Work Program can be found on the City of Punta Gorda website under Canal Maintenance https://www.ci.punta-gorda.fl.us/home/showpublisheddocument/12550/637643718591830000. Every year the City replaces approximately 8,000 lineal feet of seawall. By utilizing the Seawall Assessment Data, the seawall replacement program is planned a year in advance (unexpected seawall failures or seawalls that are inspected and found to be at extreme risk of failure are given top priority and may bump planned projects to the following year).

Engineering

- Adrienne Street Pier The pier is partially open to the public at this time. The tee at the end of the pier remains closed until further repairs can be made. The City contractor is tentatively scheduled to mobilize in Sept. to make repairs to the end tee.
- **Boca Grande Drainage Improvements** Bi-weekly 60% to 90% design project update meetings continue. The eminent domain process is in progress for the final acquisitions. Coordination with the permitting agencies continues as part of the design phase.
- **Henry Street Sidewalk** All Surveying information has been received and the design will continue. Coordination continues with FDOT on work within their drainage easement and the sidewalk connection at US41.

Parks and Grounds

• Laishley Park Interactive Fountain Closed – Laishley Park Interactive Fountain will be closed until further notice for repairs.

Right-of-Way

• **Stormwater Pipe Repairs** – The right-of-way department is relocating a storm drain at 1329 Osprey Drive to be within the existing easement. Travelers are requested to use extreme caution while workers are present in the right-of-way and allow additional time for travel. Temporary delays are to be anticipated.

Police

- **Police Officer Testing** The police department conducts new hire testing continually in order to be prepared for future openings. We are currently accepting applications for the position of Police Officer. We will be holding a virtual testing process in Oct. Applications must be received by Oct. 14. The written exam will be completed online anytime between Oct. 15 and Oct. 20, with a virtual oral board exam conducted via Zoom on Oct. 26. We are currently only accepting applications from candidates who are currently law enforcement certified or Equivalency of Training (EOT) eligible.
- **Public Safety Dispatcher Testing** The police department conducts new hire testing continually in order to be prepared for future openings. We are currently accepting applications for the position of Public Safety Dispatcher. Testing will be held on Jan. 31.
- **Internship Program** The police department is currently accepting internship applications for the Spring and Summer Semesters of 2022. Our internship program is open to college students and high school seniors interested in gaining educational experience in law enforcement, criminal justice, and small government administration. Spots fill up quickly and the selection process can be competitive, so we encourage potential interns to apply today! The deadline to apply for the Spring Semester of 2022 is Oct. 15.

Fire


20 Year Anniversary of Sept. 11 – This past Saturday marked the 20 Year Anniversary of the Sept. 11 terrorist attacks. At the site of World the Trade Center, 2,977 lives were lost that day including 343 firefighters, 23 police officers and 37 port authority officers as well as those aboard American Airlines Flight 11 and United Airlines Flight 175. At the Pentagon, 184



people were killed. 40 passengers aboard United Airlines Flight 93 perished in a field in Pennsylvania. We remember and honor the fallen every September, 11th so that the victims and heroes lost on that day will live forever. The fire departments Honor Guard team along with 2 members from PD were part of the ceremony at the Military Heritage Museum.

- Peace River Manasota Regional Water Supply Authority Emergency Interconnect Receiving 1,200 gallons per minute from the new Interconnect (Phase 1 Pipeline). Sending 1,250 gallons per minute from the tank on 17 (Phase 1A Pipeline).
- Rainfall Sept. 2020 8.10" and Sept. 2021 5.20"
- Hardness is a measurement of calcium and magnesium ions naturally occurring in the raw water. Currently "moderately hard" Grains of Hardness 7 ppm –Total hardness 132 ppm
- TDS Sept. 16 Current 266 ppm, Low 118 ppm, High 360 ppm, 12 Year Avg. 294 ppm

Wastewater Treatment

- Maintenance Maintenance crew drained the Digested Sludge Storage Units (DSSU) to the pond and are making repairs on the aeration system. The City's contracted vendor continues to work on the coating at the south tank at the Master Pumping Facility. Maintenance crews continue to mow and trim the plant and remote station
- **Operations** The average daily flow for the past week was 17.56 million gallons for a total of 17.56 million gallons of wastewater being treated this week.

 Rain totals MPF = 2.02" Plant = 1.87"

Makes recommendations to City Council on effective maintenance of existing canals, waterways and navigable channels within the district, together with maintenance and reconstruction of seawalls. Holds public hearings and makes final decision on petitions for special permit to provisions of Section 2-1(c) of Chapter 6, City Code of Ordinances.
