#### **City Manager**

**City Manager Column** – The City of Punta Gorda was honored to receive sixth place in the 2021 Digital Cities Survey hosted by the Center for Digital Government for cities up to 75,000 in population across the US. The second-highest ranking for any Florida city in this category. The survey recognizes cities using technology to tackle social challenges, enhance services, strengthen cybersecurity, and more. This is the seventh consecutive year that the city has placed in the top 10.



At the heart of all of our technology resources is the city's website. The website serves as a direct link to our residents.

Citizen engagement is shared across all levels and departments of the city. Each area is empowered to add content and develop new digital tools to drive citizen engagement and reach their intended audiences. Emergency communications regarding the health and safety of our residents is also a critical digital focus this year. The emergency public notification system Alert Punta Gorda continues to provide helpful alerts to residents that sign up. The service allows the City of Punta Gorda to contact the entire community or target specific areas in an emergency or urgent situation that requires the public's immediate attention. We continue to innovate and develop new ways to get residents the information needed and answer questions as quickly and efficiently as possible. This year the TextmyGov application was launched. TextmyGov allows communication with residents that use a mobile phone's regular messaging service. It is a way for residents to relay information to the city and get information about city services. 

# Does the new FBC completely replace the current zoning regulation?

Form Based Code (FBC) covers only a small geographic

area of the City. The major neighborhoods of Punta Gorda Isles, Burnt Store Isles, and Burnt Store Meadows will see no changes to the current development allowances and requirements. The map below illustrates the area that the proposed FBC would cover:





#### How is Building Height measured?


Current allowable building height in the "proposed Form Based Code (FBC)" is limited to between 35 to 60 feet by Zoning Classification. Building height is measured from based flood elevation (BFE) as to not penalize property owners for building flood resilient structures. Per Section 8.3, there are some permitted exclusions to building height. These exclusions are limited to 20% of the maximum height limitation. These exclusion area are not intended for human habitation and include elevator/stair towers, antennas, roof top pools and other similar features. Below is an example of how building height is measured.

# Public Works Canal Maintenance

- Canal Odor Don't be alarmed if you have noticed an odor floating up from your canals. The water in our canals and ponds is on the move vertically! The surface water, which was warmed by the hot summer sun, has been cooling down as the temperatures drop causing the water to 'flip' or 'turn'. This means that the bottom (including silt, decomposing plant material and miscellaneous debris) comes to the surface bringing with it a smell of stagnant water, while the surface water goes to the bottom. This is a natural occurrence and typically lasts approximately two weeks then returns to normal.
- Seawall Assessment City staff is currently be performing the Annual Seawall Assessment during low tide periods through March. City staff will be inspecting seawalls in the southerly half of Punta Gorda Isles and all of Burnt Store Isles (blue zone) from the waterside while traversing canals in a boat. Residents may see city staff in a boat close to their seawalls while inspecting the condition of seawalls.



- Seawall Replacement Projects Punta Gorda Isles has 42 seawall replacement projects scheduled for this fiscal year and the seawall replacement contractor has six projects under construction. Burnt Store Isles has seven seawall replacement projects scheduled for this fiscal year and at this time none are under construction. A seawall replacement project can consist of multiple properties. A seawall project is not considered complete until the sod has been placed.
  - > Crews filled depressions at 17 locations.
  - > Crews patched and repaired 155' linear feet of seawall cap/seam.

Every year the City replaces approximately 12,000 linear feet of seawall. By utilizing the Seawall Assessment Data, the seawall replacement program is planned a year in advance (unexpected seawall failures or seawalls that are inspected and found to be at extreme risk of failure are given top priority and may bump planned projects to the following year).

# **Engineering**

- **Boca Grande Drainage Improvements** Bi-weekly design is approaching 90 percent review. The engineer of record continues to prepare plans and application documents for the Environmental Resource Permit.
- **Henry Street Sidewalk** Final construction plan revisions and drainage calculations are being completed. Coordination will continue with FDOT on work within their drainage easement and the sidewalk connection at US41.
- Paving Program Street Resurfacing Harborside Ave. milling and resurfacing is complete. The contractors continue with paving on Almar Dr. and Muscovie Ct. • **Harbor Walk West End Lighting** – The installation of five additional decorative lights street between Shreve Street and the tidal bridge at the west end of Retta Esplanade is nearing completion. The lights have been installed and are operational. Final site cleanup will be completed by the end of next week.


#### **Fire**

#### **Water Treatment Plant Operations**

#### **Wastewater Treatment**

- Maintenance Team members have finished tightening the thousands of nuts and bolts on the new Filter Press building and the County inspectors are proceeding with all necessary inspections. The contracted vendor continues to remove the old interior coating from the North tank at the Master Pumping Facility. Team members were able to haul and inject 259000 gallons of bio-solids to field two this week. Maintenance staff has taken procession of a new 15 foot wide batwing mower and started the process of mowing fields 1, 3, and 5. A problem with the Plant's generator was found at the startup of its monthly exercising run. The contracted vendor was called in to order the parts needed and to make the repairs.
- **Operations** The average daily flow for the past week was 2.51 million gallons for a total of 17.56 million gallons of wastewater being treated this week.
