City Manager

• City Manager Column – The City of Punta Gorda is seeking employment applicants that desire to work in a city that truly feels like a hometown. We are a progressive, forward-thinking community with a commitment to economic success. Punta Gorda's historic ambiance and intimate feeling are the backdrop for what may be the state's most picturesque, enjoyable, and accessible waterfront destination. The City of Punta Gorda actively seeks qualified individuals to join our team.

Our Utilities Department is accepting applications for a Utilities Director. The successful candidate will be a professional responsible for directing, planning, managing, and reviewing the



activities and operations of the Utilities Department, including the Engineering, Utilities, Water Distribution, Waste Water Collection Divisions, and Treatment Plants; to coordinate assigned activities with other City departments, divisions, and outside agencies; and to provide highly responsible and complex administrative support to the City Manager. Utilities is also seeking a Utilities Maintenance Worker II. The individual selected for this position is responsible for maintaining and repairing wastewater treatment plant equipment and systems.

The Urban Design Department is seeking a Chief Building Official. This position is a professional administrative position responsible for directing the activities of the Building Department. Urban Design is also seeking either a Planner I or Planner II. If hired as a Planner I, the position is an entry-level planning position that assists in current and long-range urban planning efforts, including land development review and analysis, and planning studies supporting new and updated programs and regulations. Planner II is an advanced professional planning position responsible for researching and analyzing technical data in city planning. Performs professional and technical work developing, researching, data collection, mapping, and maintaining public planning studies and programs on land use, zoning, conservation, housing, transportation, population, coastal management, historic preservation, and other areas of comprehensive planning activities. The Lot Mowing Program Coordinator position under Urban Design will soon be available also. The skilled technical position is responsible for performing various inspections to ensure compliance with and identify violations of the city's lot mowing program.

Public Works is seeking Construction Engineering Inspector. This position provides construction inspection and project management for development projects from inception to completion to ensure the project meets specifications and expectations. Work is performed under the general supervision of the City Engineering Manager. The position is a full-time, temporary position with benefits lasting up to two years depending upon various projects' timelines. Canal Maintenance has an entry-level laborer position available responsible for maintaining, repairing, or replacing seawalls and related structures within the PGI and BSI canal maintenance districts. Also available is a Parks & Grounds Maintenance Worker I, an entry-level laborer responsible for daily maintenance of parks, medians, municipal properties, cul-de-sacs, and streetscape. A Right of Way Maintenance Worker is also available and is an entry-level labor responsible for labor specific tasks, and a wide variety of road construction maintenance operations work. Sanitation has an entry-level laborer and a laborer position open to work in solid waste collections.

In the Information Technology (IT) Department, an IT Operations Analyst position is open and is responsible for performing professional and complex technical duties related to technology asset management, budgeting, training, and support of Information & Technology business operations.

• The Planning Corner – The City of Punta Gorda FY 2022

Americans with Disabilities Act (ADA) Transition Plan Projects –

Section 37.5 of the Americans with Disabilities Act states: "No entity shall discriminate against an individual with a disability in conjunction with the provisions of public services" Title II of the ADA requires all State and Local Governments who have 50 or more employees have an ADA Transition Plan (Plan). The Plan is to identify physical obstacles, describe remediation, establish a schedule for completion and indicate the official responsible. The City's ADA Transition Plan is a living document that evaluates accessibility across all programs

and projects, highlighting compliance efforts and charting a course for improvements.

At the Feb. 2 City Council meeting the Urban Design Division provided an update to City Council highlighting the City's action and progress for the previous year (FY 2021) and the upcoming year (FY 2022). Some of the approved projects include:

- ➤ Construction of the Laishley Park Playground area with enhanced water play equipment that promotes accessibility and inclusion
- ➤ Design process for accessibility improvements in Nature Park includes resurfacing the nature trail entrances. Engineering and permitting will be necessary to replace the trail's platform bridge, observation deck, fishing pier, and site furnishings.

- Add interior Wayfinding Signage to Fire Station II, Fire Station III, and Cooper St. Recreational Center providing fully ADA compliant messaging for navigating City buildings using the City's current branding
- Construction of a pedestrian sidewalk along W William Street connecting a residential area to an adjacent shopping plaza

Administration

• Citizens' Academy Fire Department Session - The Fire Department session of 2022 Citizens' Academy was a huge success. The evening involved a presentation highlighting the resources and capabilities of the department. Participants were given some hands on education with fire/EMS tools and gear. Participants were also given the opportunity to put out a live fire! Another area of interest was the historic mural painted on the Firehouse wall. The highlight of the evening was a treat to "Fire House Chili" prepared by Fire Department staff.



Canal Maintenance

• Manatee Awareness — Canal Maintenance is reminding people on the water to slow down and look out for migrating manatees this time of year. As water temperatures drop manatees tend to travel to the internal canal systems in order to stay warm. Manatees depend on water generally warmer than 68 degrees Fahrenheit to survive the winter. Recently there have been several manatees spotted in the Sunset Lake area, which is the body of water located near Casey Key Dr.



and Surfbird Ct. So please go slow and look out below to allow them to swim safely.

- Seawall Assessment City staff is currently performing the Annual Seawall Assessment during low tide periods through Mar. City staff will be inspecting an estimated 303,868 lineal feet of seawalls in the southerly half of Punta Gorda Isles and all of Burnt Store Isles from the waterside while traversing canals in a boat. Residents may see city staff in a boat close to their seawalls while inspecting the condition of seawalls. To date staff has collected 3,656 points of data covering 250,378 lineal feet. The southerly half of Punta Gorda Isle has been completed and crews will be moving over to Burnt Store Isles next week.
- **Seawall Replacement Projects** Punta Gorda Isles has 44 seawall replacement projects scheduled for this fiscal year and the seawall replacement contractor has eight projects under construction and six projects completed. Burnt Store Isles has eight seawall replacement projects scheduled for this fiscal year and the seawall contractor has three projects under construction at this time. A seawall replacement project can consist of multiple properties. A seawall project is not considered complete until the sod has been placed.
 - > Crews filled depressions at two locations.
 - > Crews patched and repaired (41' linear feet) of seawall cap/seam.
 - > Crews manufactured 40 (10' foot) seawall panels.
- Seawall Replacement Schedule The annual Seawall Replacement Work Program can be found on the City of Punta Gorda website under Canal Maintenance https://www.ci.punta-gorda.fl.us/home/showpublisheddocument/12550/637643718591830000. Every year the City replaces approximately 12,000 linear feet of seawall. By utilizing the Seawall Assessment Data, the seawall replacement program is planned a year in advance (unexpected seawall failures or seawalls that are inspected and found to be at extreme risk of failure are given top priority and may bump planned projects to the following year).

Engineering

- **Boca Grande Drainage Improvements** The engineering consultant has received additional survey data for the project and is incorporating it into the project. The engineer of record anticipates submitting the Environmental Resource Permit application to the Southwest Florida Water Management District in Feb.
- **Henry Street Sidewalk** Final construction plan revisions and drainage calculations are being completed. Coordination will continue with FDOT on work within their drainage easement and the sidewalk connection at US41.

Parks and Grounds

• Christmas Tree and Decoration Removal – The areas outlined in red (see picture) at the intersection of Marion Avenue and Taylor Street will be blocked off to allow access for City crews and equipment to remove Christmas tree and decorations. Parking spaces along Marion Avenue and Taylor Street will be opened up in the evening and on the weekends. Crews began removal of the Christmas decorations on Jan. 31. Please take special care when driving in the City to be aware of Public Works employees removing holiday decorations.



Sanitation

• **President's Day holiday** – The government offices of the City of Punta Gorda will be closed on Feb. 21 for the President's Day holiday. Residents of the City of Punta Gorda will notice NO CHANGE in their trash, yard waste or recycling collections during this holiday. Commercial customers will notice NO CHANGE in collection service during this holiday. Police

- **Beware of Tax Scams** Tax season brings with it an increase of tax related scam cases. Here are a few tips to make sure that you don't become a victim:
 - ➤ The IRS does not use email, text messages, or social media to discuss personal tax issues involving bills or refunds. Do not engage with anyone claiming to be with the IRS using these methods.
 - The IRS does not accept tax payments using prepaid debit cards, gift cards, or wire transfers. If someone asks you to pay a tax bill using any of these methods they are not with the IRS.
 - Never call numbers or go to websites found in emails or letters. These can be used to trick you into call imposters or visiting fake websites. You should only use numbers and websites from legitimate sources. The IRS website is www.irs.gov.
 - Never provide any personal or tax information to anyone who contacted you. If you believe someone may actually be with the IRS, they will be happy to allow you to call back using a number you located on the official IRS website.

Open Positions

- Police Officer Testing The police department conducts new hire testing continually in order to be prepared for future openings. We are currently accepting applications for the position of Police Officer. We will be holding a virtual testing process in June. Applications must be received by May 25. The written exam will be completed online anytime between June 1, and June 9 with virtual oral board exams conducted via Zoom on June 20, and June 21. We are currently only accepting applications from candidates who are currently law enforcement certified or Equivalency of Training (EOT) eligible.
- **Public Safety Dispatcher Testing** The Punta Gorda Police Department will be testing for the position of Public Safety Dispatcher on Feb. 28 at 9 a.m. Our dispatchers handle 911 calls in the city and dispatch for both the police department and fire department. Previous dispatching experience is not needed. If you are a good communicator, are able to multi-task, and can remain calm under pressure, you may have what it takes to be one of the "unseen" heroes of public safety! 
Fire

- Maintenance The contracted vendor continues the work of repairing the walls of the North tank at the Master Pumping Facility. Team members were able to haul and inject 224,000 gallons of bio-solids to field seven this week.
- **Operations** The average daily flow for the past week was 2.67 million gallons for a total of 18.67 million gallons of wastewater being treated this week.

Charter Review Committee

• Review of the City's Charter, a process that occurs once every six years, is underway. Video of the Committee's meetings are available on the City's <u>Agendas and Meetings page</u> and <u>YouTube channel</u>. The Committee's next meeting will be held in Council Chambers at City Hall (326 West Marion Avenue) on Feb. 14 at 9:00 a.m. Topics for discussion at the next meeting include establishing how to stagger four-year terms, term limits, councilmember compensation and the candidate residency requirement. All meetings of the Charter Review Committee are open to the public and attendance is encouraged.

Current Board and Committee Vacancies (Volunteer Appointment Information Form)

- **Board of Zoning Appeals** (two alternate) Meets monthly on the fourth Tuesday at 4 p.m. in City Council Chambers. City residency is required. Seven-member board with two alternate members. Three-year terms, maximum of three terms or partial term plus two more terms. Financial disclosure required. Makes recommendations to City Council on variances to City Code.
- Code Enforcement (two alternate) Meets monthly on the fourth Wednesday at 9 a.m. in City Council Chambers. City residency required. Seven-member board with two alternate members. Three-year terms, maximum of three terms OR partial term plus two more terms. Financial disclosure required.
- Historic Preservation Advisory Board (one alternate) Meets monthly on the fourth Thursday at 9 a.m. in City Council Chambers. City residency required. Seven-member board with two alternate members. Two members must reside within the Historic District. Three year terms, maximum of three terms OR partial term plus two more terms. Identifies for the City Council historically significant structures and sites that should be considered for designation as a "Local Historic Landmark" or be nominated for listing on the Florida Master Site File and the National Register of Historic Places. Makes recommendations of the policies for the protection of historically significant structures and sites. Makes recommendations to staff with regard to certificates of appropriateness for any demolition, variance, sign or relocation of structures. Promotes public awareness of historic archaeological preservation and its community benefits.
- **Police Officers' Pension Board** (one City resident member). Meets quarterly and as called in City Council Chambers. Five members two City residents at-large, two general employees and one member appointed by the Board. Four-year terms, no maximum. Financial disclosure required. Charged with management of the General Employees' Pension Fund.
