# **City Manager**

• City Manager Column – Great things are happening in Punta Gorda! At the last City Council meeting, Council approved moving forward with acquiring a therapy dog. The acquisition of the new therapy dog and the training are being funded through generous donations from area residents. We have also had local groups interested in sponsoring ongoing expenses for the program. The Punta Gorda Police Department (PGPD) believes in doing everything possible to help address the mental health of our citizens, visitors, and employees. In an effort to help comfort those affected by emotional distress, the Police Department is proposing the creation of a



therapy dog program. There are a number of police agencies throughout the country that have developed therapy dog programs and have found them to be very successful in helping to reduce anxiety, anger, and symptoms of Post-Traumatic Stress Disorder. The PGPD Veterans Crisis Assistance Team (VCAT) was established in December 2020. Adding a therapy dog as a resource for the team will enhance our ability to assist the veterans in the community.

Additionally, the therapy dog will be utilized after critical incidents to help affected community members cope with stress. The dog will also be used to improve employee morale and for outreach at community events. The PGPD will utilize the American Kennel Club Recognized Therapy Dog organization, Brevard County Sheriff's Office "Paws and Stripes College" to facilitate the selection of the dog (which is a rescue). The therapy dog will enter a 12-week training course that teams up the dog with an inmate to prepare the dog for its handler and a 40-hour training course that the handler will attend. The training sessions are a free program for law enforcement agencies. Upon graduation, the canine team will be tested for a certification from the United K9s Therapy K9 Certification course. The certification is nationally recognized and will be valid for two years. We are looking forward to welcoming our new addition to the department.

Also, this past week the city received the excellent news that the City of Punta Gorda Finance Department is being recognized for its professionalism and skill once again. The city was recently notified that the annual comprehensive financial report for the fiscal year ended Sept. 30, has met the requirements to be awarded GFOA's Certificate of Achievement for Excellence in Financial Reporting. The GFOA established the Certificate of Achievement for Excellence in Financial Reporting Program (Certificate Program) in 1945 to encourage and assist state and local governments to go beyond the minimum requirements of generally accepted accounting principles to prepare annual comprehensive financial reports that evidence the spirit of transparency and full disclosure and then to recognize individual governments that succeed in achieving that goal. Unlike many other areas of Punta Gorda, this older community doesn't have a master drainage plan. The existing drainage consists of a haphazard network of roadside swales..

- FPL/Comcast Update Beginning the week of Feb. 15 (weather permitting), a Florida Power and Light contractor will be installing a new utility pole near the corner of Aqui Esta Dr. and Coronado Dr. Aqui Esta Dr. will be closed to thru traffic from Bal Harbor Blvd. to Coronado Dr. Only local traffic will be allowed on Aqui Esta Dr. from Bal Harbor Blvd. to La Salina Ct. Traffic on Aqui Esta Dr. will not have access to Coronado Dr.; and traffic on Coronado Dr. will not be able to access Aqui Esta Dr. due to Aqui Esta Dr. being closed from Coronado Dr. to La Salina Ct. The contractor will install temporary traffic control signs to help citizens navigate the construction area. The project is estimated to take about four hours to be completed. - **Text My Gov** Need information about the City? Try Text My Gov. The service uses a mobile phone's regular text messaging service to allow people to quickly find links, documents or text that answers their questions. No app download is needed. It allows our residents and visitors to report issues such as code violations or report issues with city infrastructure twenty four hours a day, seven days a week. A picture can also be added when reporting an issue or violation and the service sends the information immediately to city staff to have the issue resolved. To use the service simply text "hi" to (941) 347-0747. Answers to common questions are available 24/7 through website searches and preprogrammed responses. Don't have an immediate answer? The question will go to a designated mailbox to insure you get a timely response.

# **Public Works**

#### **Canal Maintenance**

Manatee Awareness – Canal Maintenance is reminding people on the water to slow down and look out for migrating manatees this time of year. As water temperatures drop manatees tend to travel to the internal canal systems in order to stay warm. Manatees depend on water generally warmer than 68 degrees Fahrenheit to survive the winter. Recently there have been several manatees spotted in the Sunset Lake area, which is the body of water located near Casey Key Dr. and Surfbird Ct. So please go slow and look out below to allow them to swim safely.



- **Seawall Assessment** City staff is currently performing the Annual Seawall Assessment during low tide periods through Mar. City staff will be inspecting an estimated 303,868 lineal feet of seawalls in the southerly half of Punta Gorda Isles and all of Burnt Store Isles from the waterside while traversing canals in a boat. Residents may see city staff in a boat close to their seawalls while inspecting the condition of seawalls. To date staff has collected 3,723 points of data covering 255,658 lineal feet. The southerly half of Punta Gorda Isle has been completed and crews will be moving over to Burnt Store Isles next week.
- Seawall Replacement Projects Punta Gorda Isles has 44 seawall replacement projects scheduled for this fiscal year and the seawall replacement contractor has eight projects under construction and six projects completed. Burnt Store Isles has eight seawall replacement projects scheduled for this fiscal year and the seawall contractor has three projects under construction at this time. A seawall replacement project can consist of multiple properties. A seawall project is not considered complete until the sod has been placed.
  - Crews installed channel markers #10 mirror in Ponce De Leon inlet.
  - > Crews manufactured 50 (10' foot) seawall panels.
- Seawall Replacement Schedule The annual Seawall Replacement Work Program can be found on the City of Punta Gorda website under Canal Maintenance https://www.ci.puntagorda.fl.us/home/showpublisheddocument/12550/637643718591830000. Every year the City replaces approximately 12,000 linear feet of seawall. By utilizing the Seawall Assessment Data, the seawall replacement program is planned a year in advance (unexpected seawall failures or seawalls that are inspected and found to be at extreme risk of failure are given top priority and may bump planned projects to the following year).

# **Engineering**

- **Boca Grande Drainage Improvements** The engineering consultant has received additional survey data for the project and is incorporating it into the project. The engineer of record anticipates submitting the Environmental Resource Permit application to the Southwest Florida Water Management District in Feb.
- **Henry Street Sidewalk** Final construction plan revisions and drainage calculations are being completed. Coordination will continue with FDOT on work within their drainage easement and the sidewalk connection at US41.
- Wayfinding Signage Foundation bases for the proposed way finding signs have been completed. Installation of new signs will follow completion of manufacturing and concrete curing.



• **Training** – The fire department has been training this week with a new piece of equipment. The BlitzFire Nozzle is a portable master stream device capable of flowing up to 500 gallons a minute and can cover up to 200 feet! This appliance can be set up at the scene of a structure fire and left unmanned allowing personnel to work on other tasks while having a constant stream of water assisting to mitigate the emergency.

Maintenance – The contracted vendor continues the work of repairing the walls of the North tank
at the Master Pumping Facility. Team members were able to haul and inject 126,000 gallons of
bio-solids to field seven this week.

#### **Charter Review Committee**

• Review of the City's Charter, a process that occurs once every six years, is underway. Video of the Committee's meetings are available on the City's <u>Agendas and Meetings page</u> and <u>YouTube channel</u>. The Committee's next meeting will be held in Council Chambers at City Hall (326 West Marion Avenue) on Feb. 14 at 9:00 a.m. Topics for discussion at the next meeting include establishing how to stagger four-year terms, term limits, councilmember compensation and the candidate residency requirement. All meetings of the Charter Review Committee are open to the public and attendance is encouraged.

# **Current Board and Committee Vacancies (Volunteer Appointment Information Form)**

- **Board of Zoning Appeals** (two alternate) Meets monthly on the fourth Tuesday at 4 p.m. in City Council Chambers. City residency is required. Seven-member board with two alternate members. Three-year terms, maximum of three terms or partial term plus two more terms. Financial disclosure required. Makes recommendations to City Council on variances to City Code.
- Code Enforcement (two alternate) Meets monthly on the fourth Wednesday at 9 a.m. in City Council Chambers. City residency required. Seven-member board with two alternate members. Three-year terms, maximum of three terms OR partial term plus two more terms. Financial disclosure required.
- Historic Preservation Advisory Board (one regular and one alternate) Meets monthly on the fourth Thursday at 9 a.m. in City Council Chambers. City residency required. Seven-member board with two alternate members. Two members must reside within the Historic District. Three year terms, maximum of three terms OR partial term plus two more terms. Identifies for the City Council historically significant structures and sites that should be considered for designation as a "Local Historic Landmark" or be nominated for listing on the Florida Master Site File and the National Register of Historic Places. Makes recommendations of the policies for the protection of historically significant structures and sites. Makes recommendations to staff with regard to certificates of appropriateness for any demolition, variance, sign or relocation of structures. Promotes public awareness of historic archaeological preservation and its community benefits.
- **Police Officers' Pension Board** (one City resident member). Meets quarterly and as called in City Council Chambers. Five members two City residents at-large, two general employees and one member appointed by the Board. Four-year terms, no maximum. Financial disclosure required. Charged with management of the General Employees' Pension Fund.
