- Of the 94 permitted slips and 42 moorings, there are:
  - 3 43 annual contracts
  - 3 10 semi-annual contracts
  - 6 monthly contracts
  - 3 14 commercial contracts
  - **8** moorings

(13 free public side tie, 1 pump out dock, 4 slips for PGPD, CCSO, FWC & marina work boat)

- ™ Marina is 97% occupied.
- Including moorings, 14 renters are staying on their boats in the marina.

### Pumpout Vessel

- SS Clearhead activity as of September 29, 2015:
  - 54 pump-outs (all Florida registered vessels)
  - **3** 1,290 gallons
  - 3 Boat traveled approximately 164 miles

## Marina Building Improvements

- Repair inside of Marina Building Pressure test showed normal air pressure in the building. Smoke test revealed the suspected area was leaking. Window installer to make one last attempt to seal the leaks at no cost to the City otherwise, windows will need to be removed and new flashing installed.
- Installation of Perimeter Railing Section of fencing and handrail along the pavement still pending installation; handrails delivered were powder coated in incorrect color and are being returned.
