




Map #1 - Punta Gorda Generalized Existing Land Uses as of 2020




Map #2 - Conservation & Recreation Land Use Categories




Map #3 - Residential Land Use Categories









Map #7 - Historic Districts & Contributing Structures within the City of Punta Gorda




Map #8 - Overlay Areas




Map #9 - Future Land Use Changes from 1988 to 2020




Map #10 - City of Punta Gorda Soils




Map #11 - City of Punta Gorda Topography




Map #12 - Charlotte County Watershed Overlay District




Map #13 - Dredge Spoil Site Location






Map #16 - Special Flood Hazard Area (SFHA)


Map #18 - City of Punta Gorda Drainage Basins






Map #20 - Peace River Drainage Basin




Map #21 - Charlotte Harbor Water Quality Monitoring Stations




Map #22 - Prairie and Shell Creeks




Map #23 - Charlotte County's Watershed Overlay District




Map #24 - Alligator Creek Drainage Basin




Map #25 - The City of Punta Gorda's Major Soil Classifications




Map #27 - Florida Land Use, Cover, and Forms Classification System (FLUCCS)




Map #27 - Florida Natural Areas Inventory (FNAI)




Map #28 - Natural Resource Sites Affecting the City of Punta Gorda


Map #30 - Publically Managed Lands and Potential Wildlife Linkages




Map #31 - Seagrass Areas along the City's Boundaries




Map #32 - Smalltooth Sawfish Areas along the City's Boundaries




Map #33 - Water Access Areas and Facilities




Map #34 - Utility Infrastructure in the Hurricane Vulnerability Zone




Map #35 - Transportation Infrastructure in the Hurricane Vulnerability Zone




Map #36 - Punta Gorda Hurricane Evacuation Routes






Map #40 - Mobile Home Parks Affecting the City of Punta Gorda


Map #43 - Punta Gorda City Parks and Recreational Facilities




Map #44 - Punta Gorda Pathways




Map #45 - Existing Punta Gorda Park Level of Service




Map #46 - Punta Gorda Park Level of Service - 2045






Map #48 - City of Punta Gorda Fire Stations






Map #50 - Punta Gorda Existing Sidewalk Network




Map #51 - Punta Gorda Existing Sidewalk network and Future Needs




Map #52 - 2019 Citywide Master Plan Recommended Trail Network




Map #53 - Punta Gorda Existing Bicycle Facilities




Map #54 - Punta Gorda Existing Bicycle Facilities and Future Needs




Map #55 - Intermodal Facilities - Parking, Marina, Rail, and Airport




Map #56 - Punta Gorda Existing Street Network




Map #57 - Punta Gorda Proposed Street Network




Map #58 - Punta Gorda Constrained Corridors




Map #59 - Punta Gorda Existing and Committed Street Network Level of Service - 2045




Map #60 - 2045 Transportation Plan Cost Feasible Needs




Map #61 - City of Punta Gorda Recommended Context Classifications


