


WEEKLY HIGHLIGHTS REPORT June 28, 2024





- **Fireworks Safety** Summer is synonymous with barbecues, parades and fireworks. Every year, thousands of people are injured badly enough to require medical treatment after fireworks-related incidents, with many of the injuries to children and young adults. While the majority of these incidents are due to amateurs attempting to use professional-grade,
 - homemade or other illegal fireworks or explosives, less powerful devices like small firecrackers and sparklers can also cause significant injury. Additionally, fireworks start an average of 19,000 fires each year. If consumer fireworks are legal to buy where you live and you choose to use them, be sure to follow the following safety tips:
 - Never allow young children to handle fireworks
 - ➤ Older children should use them only under close adult supervision
 - Never use fireworks while impaired by drugs or alcohol



- > Never hold lighted fireworks in your hands
- ➤ Never light them indoors
- ➤ Only use them away from people, houses and flammable material
- ➤ Never point or throw fireworks at another person
- > Only light one device at a time and maintain a safe distance after lighting
- ➤ Never ignite devices in a container
- ➤ Do not try to re-light or handle malfunctioning fireworks
- > Soak both spent and unused fireworks in water for a few hours before discarding
- ➤ Keep a bucket of water nearby to fully extinguish fireworks that don't go off or in case of fire
- Never use illegal fireworks Better yet, grab a blanket and a patch of lawn, kick back and let the experts handle the fireworks show.



Sparklers Are Dangerous

- Every year, young children can be found along parade routes and at festivals with sparklers in hand, but sparklers are a lot more dangerous than most people think.
- ➤ Sparklers burn at about 2,000 degrees hot enough to melt some metals. Sparklers can quickly ignite clothing, and children have received severe burns from dropping sparklers on their feet. According to the National Fire Protection Association, sparklers alone account for more than 25% of emergency room visits for fireworks injuries. For children under five years of age, sparklers accounted for nearly half of the total estimated injuries.
- Consider using <u>safer alternatives</u>, such as glow sticks, confetti poppers or colored streamers.



Planning Corner

• From June 7 - 9, Urban Design staff attended the All-America City Award Event in Denver, Colorado with other staff and community members from the City of Punta Gorda. The event included workshops and panel discussions with a focus on strengthening civic

engagement. One workshop, titled "Interactive Demo of the Theatrical Production, City Council Meeting", taught attendees how tools from live theater can produce better public meetings and more creative organizing. City staff engaged in participatory theater work and a facilitated discussion that demonstrated how creative spaces can be an entry point for meaningful civic engagement. The facilitator emphasized the importance of getting individuals to



create maps of their daily experiences where they live and work. Those maps are then used to tell stories that can then inform and affect the work of city planners as they design communities, and elected officials as they make decisions impacting the community. The workshop also discussed ways in which the public can and should have access to city staff and leaders, both at and outside of public meetings. Public Works

- Canal Maintenance Production Crews filled depressions at 51 at single-family homes and condominium complexes. Crews manufactured 72 seawall panels and patched seawall caps and seams at four locations.
- **Dockside Dredging** Property owners that are listed on the Hurricane Ian Seawall Damage list will not be allowed to have dockside dredging performed adjacent to the seawall until the seawall has been repaired. Any dredging along the damaged seawall may cause damage.




- **Stabilizing Erosion** Just a friendly reminder for property owners to regularly check the condition of their tarps or plastic that is protecting the eroded areas. Tarps and plastic tend to become brittle in the sun and may start falling apart. Utilizing plastic during a rain event will help keep the soil in place preventing further erosion.
- Canal Maintenance Seawall Failure Update Construction schedules have been updated and are posted on the Canal Maintenance website for the next six months look ahead. There are 18 projects in Punta Gorda Isles under construction with 93 projects completed, and six projects under construction with 21 completed in Burnt Store Isles. - **Establishing sod after seawall replacement** Placing the sod is the final phase of seawall replacement construction. As per the City ordinance, property owners are responsible for establishing the sod after it has been placed and the City will not reimburse the owners for their water usage.
- Vessel Speeds Canal Maintenance is asking people to be mindful of the current situation in the canals with seawalls being damaged. City code states that the operation of vessels in the canals shall be Slow Speed Minimum Wake in the waterways within the City limits. The speed and operation in the Ponce Inlet, Pompano Inlet, Bass, and Snook Inlet are Idle Speed and No Wake. Wakes from watercraft can cause additional erosion and damage to seawalls already compromised.
- **Dock Match Program** The Punta Gorda and Charlotte Harbor Boaters Alliance has created a program that connects boat owners who need a temporary relocation of their boats with owners that have available dock space. This information can be found at Punta Gorda Boaters Alliance (boat2puntagorda.org) click on the Dock Match button for information.

Engineering

- Swale Regrading The swale contractor has completed Don Quixote Dr., Brazilia Ct., Darin Dr., Padre Island Dr., Casey Key Dr. (SW), Ussepa Ct., Casey Key Dr. (SE) Turtle Dove Cir which have been finalized and turned over to the homeowner. The contractor will be watering the sod for the next 30 days weather permitting at Sea Horse Ct., Sea Fan Dr., and Grebe Dr. The contractor has begun to excavate Orange St., W. McKenzie St., Lemon St., and McGregor St. this week, and will be excavating approximately 12,000 SF. Once they have the grades established, new sod will be installed. The swale contractor has excavated approximately 73,000 SF this fiscal year.
- City Hall Annex The contractor has begun the interior work on the third floor where the Urban Design, Code Enforcement, and Zoning offices were. The contractors started to
 - replace all the ceiling tiles this week throughout the third floor and the new flooring in the Urban Design, Code Enforcement, and Zoning. They have completed painting the (NW) stairwell from the first floor to the third floor. Next week, the contractor will install the baseboards, and complete a deep clean on the areas that have been completed.
- Laishley Splash Pad Construction at the Interactive Fountain area in Laishley Park. This work includes rehabilitation and upgrades to the splash pad/play area. The pump and water treatment equipment skid have been plumbed. The seating wall caps and column caps were installed this week.



Please use extra caution while driving or walking through the park due to construction personnel and equipment. To the highest extent possible the restroom facilities will remain open to the public. The access to the restrooms will be from the marina side of the building. There will be periodic temporary sidewalk closures immediately adjacent to the construction area as required for public safety. The construction area will be closed to the public at all times during this period. The enhanced fountain area is scheduled to reopen in late 2024. 


• Fiber Optic Internet Network -The fiber optic

internet provider HyperFiber has been issued permits for a portion of the construction project to install a citywide fiber optic internet network within the city right of ways. This

project will be under construction during the next several months as they install the network citywide. They are in currently working the areas highlighted in red below. The green areas are where the work is completed and their permit has been inspected for final by the engineering department. Additional areas are scheduled to be final in the next several weeks. The blue areas are where the installation will be taking place as the project progresses.

Initially you will see utility markings within the city right of way, followed by the directional drilling of the fiber optic conduit. Fiber optic boxes will be installed in the right of



way or easement at the edge of your property. Once the installation of the underground and service points has been completed for the entire sector, crews will then return to individual locations for the restoration of sod. This will take place at the end of construction in each sector. Please be patient and allow time for the restoration. The city engineering department will be performing spot inspections during construction as well as a final inspection when restoration is complete to ensure the contractor's restoration meets the city's requirements.

Right of Way

- Crews have completed the reconstruction of the Monaco Dr decorator light pedestal.
- Preparing for a safe Fourth of July celebration to be held on June 29 at Laishley Park
- The crews have filled over 16 potholes throughout the city.
- The Laishley Marina Gazebo point has been completed.





Sanitation

- **Improper Disposal of Batteries** Batteries, like the ones found in many rechargeable electronic devices, computers, and cell phones are prohibited from being placed inside the
 - trash, recycling, or dumpster containers. These batteries easily rupture, catch fire, and cause the trash to smolder when compacted in the refuse truck hopper. The toxic fumes, smoke, and fire impose a huge safety risk for the sanitation workers.
- Improper Disposal of Paint Please do NOT place paint inside of your trash, recycling cart, or dumpster for collection. If hazardous waste is discarded with your regular trash or recycling, there can be dangerous implications for the environment and sanitation workers. Oil-based paints and related products are often flammable



- or combustible and can create unsightly spills and messes when compacted in garbage trucks. Sometimes this paint can leak from the garbage truck and end up splattered all over a residential street and into storm drains or bodies of water. Eventually, the paint could contaminate the groundwater.
- Hazardous Products A product is considered hazardous if it is corrosive, toxic, flammable, or reacts or explodes when mixed with other substances. Watch out for signal words on labels such as poison, danger, warning, and caution. These include everyday items such as paint, insecticides, cleaners, automotive products, and unused medications. Please do not place it inside the trash, recycling, or dumpster containers. These items must be disposed of properly.

• Improper Disposal Dangers – Hazardous products must be disposed of in the proper way to reduce environmental impact and any safety hazards. Toxic products tossed in the trash, may injure sanitation workers, damage collection vehicles, or leak into the environment. Dumping or illicit discarding household hazardous waste down the drain, on the ground, or in stormwater drains will cause water pollution, and damage plumbing, and septic systems.



• How to Properly Dispose of Hazardous Products – See the complete list and instructions Household Hazardous Waste | Charlotte County, FL (charlottecountyfl.gov). Residents can bring their household hazardous waste to the Mini-Transfer & Recycling Facilities | Charlotte County, FL (charlottecountyfl.gov) residents are allowed 12 free visits per fiscal year (Oct. 1-Sept. 30). Recycling and household hazardous waste do not count towards the 12 visits. Proof of county residency is required. Residents need to bring a valid form of identification to include name, photo, and local address. Photo identification from other areas must be accompanied by a current utility bill or document showing proof of residency at a Charlotte County residential address. P.O. Box addresses are not accepted as proof of residency.

Police

• 2024 Freedom Festival and Fireworks Traffic The Freedom Festival and Fireworks are back this year on June 29. To ensure you can plan a safe and enjoyable evening, please look at the traffic changes that evening after the fireworks display. Remember that thousands of people come into Punta Gorda for the fireworks display, and everyone wants to leave simultaneously. These traffic changes are meant to minimize traffic congestion, but there will be substantial traffic delays, so please plan accordingly.



- Traffic leaving from the areas east of Tamiami Trail (US-41 North) Including Laishley Park,
 - will be directed south to East Olympia Avenue (US-17 East) and then east to I-75. Traffic can then go north or south on the interstate. Traffic leaving this area will be unable to access Tamiami Trail (US-41).
- Traffic leaving from the areas west of Tamiami Trail (US-41 North) Except as specified below, will be directed to Cross Street (US-41 South). Traffic may then continue south toward Fort Myers or be allowed to turn east onto Carmalita Street, north on Cooper Street, and east on East Olympia Avenue (US-17 East) toward I-75. Traffic can then go north or south on the interstate.
- Traffic leaving from City Market Place Will be directed north onto Tamiami Trail (US-41 North) toward Port Charlotte.

- Traffic leaving the Herald Court Center parking garage Cannot turn right toward Tamiami Trail (US-41 North). Traffic will need to turn left towards Taylor Street and will be directed one of two ways, depending on traffic congestion. Traffic may be directed to West Olympia Avenue (US-17 East) toward I-75, where traffic may go north or south on the interstate. Traffic may also be directed to West Marion Avenue (US-17 East) toward Cross Street (US-41 South), where traffic may then continue south toward Fort Myers or will be allowed to turn east onto Carmalita Street, north on Cooper Street, and east on East Olympia Avenue (US-17 East) toward I-75.
- Laishley boat ramp In addition to the traffic changes, the Laishley boat ramp will be closed beginning 30 minutes before the fireworks display. However, the Ponce Park boat ramp will remain open until 11 p.m. to provide boat ramp access to residents and visitors.



Lawn Watering

Management District's (District) Governing Board declared a <u>Phase I Water Shortage</u> for the District's central and southern regions, which include Charlotte, DeSoto, Hardee, Highlands, Hillsborough, Manatee, Pasco, Pinellas and Sarasota counties. The primary purpose for a Phase I water shortage is to alert the public that watering restrictions could be forthcoming. The order also requires local utilities to review and



implement procedures for enforcing year-round water conservation measures and water

shortage restrictions, including reporting enforcement activity to the District. A Phase I water shortage order does not change allowable watering schedules, however it does prohibit "wasteful and unnecessary" water use. Water Restrictions | City of Punta Gorda, FL

• Lawn Watering Schedule/Times – Lawn watering is limited to twice per week (if needed) by property address. Before 10 a.m. or after 4 p.m. Hand watering and micro-irrigation of plants (other than lawns) can be done on any day and at any time using a shut-off nozzle on their hose, so water isn't wasted.

- ➤ Building Board (one consumer advocate, one contractor, and one alternate) Meets the fourth Tues., at 9 a.m. in Council Chambers. Seven-member board with two alternate members. Three-year terms maximum of three terms OR partial term plus two more terms. Reviews enforcement of all codes related to construction standards and acts as condemnation board in matters of violation of minimum standards. Hears alleged complaints against contractors.
- ➤ Code Enforcement Board (one regular and one alternate) Meets the fourth Wednesday at 9 a.m. in Council Chambers. Seven-member board with two alternate members. Three-year terms maximum of three terms OR partial term plus two more terms. Financial disclosure required. Hears and decides alleged violations of the City Code of Ordinances.

- ➤ Donation Review Committee (one historic non-profit representative) Meets at 10 a.m. in City Council Chambers on the fourth Thurs., of Jan., April, July and Oct., or as needed, immediately following the meeting of the Historic Preservation Advisory Board. Charged with review of all non-monetary gift donation proposals/letters of intent received by the City, in accordance with the review process and established criteria identified in the Non-Monetary Donation Policy. Makes recommendations to the City Council for the acceptance or rejection of non-monetary gift donations.
- ▶ Historic Preservation Advisory Board (one alternate) Meets the fourth Thurs., at 9 a.m. in City Council Chambers. Seven-member board with two alternate members. Three-year terms maximum of three terms OR partial term plus two more terms. Identifies for the Council historically significant structures and sites that should be considered for designation as a "Local Historic Landmark" or be nominated for listing on the Florida Master Site File and the National Register of Historic Places. Makes recommendations of the policies for the protection of historically significant structures and sites. Makes recommendations to staff with regard to certificates of appropriateness for any demolition, variance, sign, or relocation of structures. Promotes public awareness of historic archaeological preservation and its community benefits.
- ➤ Planning Commission (one regular) Meets the fourth Monday at 2 p.m. in City Council Chambers. Must be City resident. Seven-member board with two alternate members. Three-year terms maximum of three terms. Makes recommendations to City Council with regard to amending, extending or adding to the comprehensive plan for the physical development of the City, platting or subdividing land within the City and adopting and amending a zoning ordinance.
- ➤ Utility Advisory Board (two regular) Meets the fourth Mon., at 9 a.m. in City Council Chambers. Seven-member board. Three-year terms maximum of three terms. Makes recommendations to City Council with regard to revisions to the utility construction standards, alleged billing discrepancies, and review of utility drawings and specifications.
