Municipal Marina



- ☞ Of the 94 permitted slips and 42 moorings, there are:
 - ☞ 48 annual contracts
 - ☞ 11 semi-annual contracts
 - ☞ 7 monthly contracts
 - ☞ 1 transients
 - ☞ 14 commercial contracts
 - ☞ 15 moorings

(13 free public side tie, 1 pump out dock, 4 slips for PGPD, CCSO, FWC & marina work boat)

- ☞ Including moorings, there are 16 liveaboards.
- ☞ Community Room had 13 bookings in February and currently has 7 reservations for March.

Marina Building Improvements



- ❧ RFP closed 2/5/16; 1 qualified response received.
- ❧ On 2/23/16, the Evaluation and Selection Committee met regarding scope and cost development to repair/replace the 5 bay windows and complete the interior build out. Revisions are underway.

Harborwalk Projects



- ❧ **US 41 South Bridge Underpass** – bids to be let in July with anticipated construction in September 2016.
- ❧ **Harborwalk West Area 1** – Awaiting FDOT release of funding after July 1, 2016.
- ❧ **Gilchrist Park Playground** – Community meetings & survey completed; results on today's Council agenda.
- ❧ **Harborwalk West Seawall** – Due to storm damage, final completion has been extended again. Due to wet sod fields, sod placement and grading to take place in 2-3 weeks.

☞ **Laishley Park Municipal Marina** – Construction is underway. Underground electrical conduit has been placed and bases for lighted bollards have been poured.



Vietnam Veterans Memorial Wall

- Work continues at the site; concrete footings for wall have been formed and poured.
