7 AD: Today's date is August 9th, 2016. The time now is
8 approximately 9:23 p.m. Myself, Special Agent
9 Alberto Diaz with the Florida Department of Law
10 Enforcement. I'm located inside the Fire Prevention
11 office at, uh, Punta Gorda Fire Department at 1410
12 Tamiami Trail in Punta Gorda, Station 1. Um, I will
13 be speaking to Mr. Chesley William McLeod. Um, all
14 right. Mr. McLeod, if you could, uh, please, um --
15 what's your date of birth?

16 CM: 08/18/76, sir.

17 AD: Okay. All right. And do you know what perjury is?

18 CM: Yes, sir.

19 AD: All right. What it is in your own words?

20 CM: Lying under oath, sir.

21 AD: Okay. Will you please raise your right hand?

22 CM: Yes, sir.

23 AD: Do you swear or affirm that the statement you're
24 about to give will be the truth, the whole truth and
25 nothing but the truth?

26 CM: Yes, sir.

1 AD: Okay. Uh, if you could just please tell me what --
2 what happened tonight, what you observed, did, saw -
3 -

4 CM: Okay.

5 AD: -- heard.

6 CM: Approximately 6:45, uh, we were in our chairs out
7 front. Actually just sat down from cleaning up and
8 everything. Uh, we had an officer come to the door,
9 uh, that worked with, uh, Punta Gorda Police
10 Department. And it was Officer Kelvin. Come to the
11 door and he said, "We have a lady down outside. We
12 need you guys." Uh, we kind of all looked at him or
13 whatever. I was kind of like startled or whatever.
14 I didn't know actually what was going on. Kind of
15 took us by surprise or whatever. We thought it was
16 kind of like a joke or whatever, and he looked at us
17 and he told us, he said, "Look, I'm serious. Let's
18 go. There's somebody down."

19 And we all immediately got up. Uh, there was
20 two of us, um, me and my Lieutenant Tyler, uh,
21 Canfield. And, um, we had a volunteer working with
22 us today. And our other medic for Rescue 32, Mike
23 Keeney, and, uh, um, Maxfield. He's the EMT of the
24 rig or Rescue 32. We all went out to, uh, the
25 truck. We grabbed our cardiac monitor, um, our life

1 pack and, uh, grabbed our med box. Um, it was kind
2 of -- kind of like a chaotic thing because we really
3 didn't know what was going on. We were -- they told
4 us that a lady had fell.

5 AD: Okay.

6 CM: Well --

7 AD: According to the officer -- officer -- what was his
8 name?

9 CM: Officer Kelvin.

10 AD: Kelvin? Okay.

11 CM: Yeah. We were instructed -- what we heard was a
12 lady had fell.

13 AD: Okay.

14 CM: Okay. So went went. We got the med box and cardiac
15 monitor. Uh, we were approaching what appeared to
16 be a [REDACTED]

17 [REDACTED].

18 [REDACTED].
19 Um, seen an officer which as we approach the scene
20 was Chief Tom Lewis and, uh, Becky. Uh, Becky was
21 actually holding, uh, on the patient here, and, uh,
22 as we got there, Becky had started CPR. And he
23 says, uh -- we asked what was going on or what
24 happened. Really didn't know anything at that
25 point, what had happened.

1 And, uh, my lieutenant was -- I heard him
2 question him or whatever, "What's -- you know, what
3 happened? What's going on?" you know? We didn't --

4 AD: To Becky or the chief?

5 CM: Uh, to Chief Lewis. He was, uh -- you know stated,
6 you know, "What's -- what's going on? What
7 happened?" You know, that's usually what we do
8 anyway when we find out --

9 AD: Yeah.

10 CM: -- what -- what's going on.

11 AD: What's going on, so --

12 CM: Get the story. You know, that way we can work on
13 what we have to work on. Um, didn't hear anything
14 about -- you know, there was communication in the
15 background like a gunshot. Because we didn't know
16 they were doing like a scenario thing for the public
17 or anything like that.

18 AD: Okay.

19 CM: So we immediately took over. Um, Becky didn't have
20 any PP on, which is the personal protective
21 equipment for gloves.

22 AD: What -- what was -- what was the chief doing and
23 what -- you said Becky had something
24 (unintelligible)?

25 CM: Uh, she -- Chief Tom Lewis was, um, standing -- uh,

1 sitting, uh, kind of hunched over beside Becky --

2 AD: Okay.

3 CM: -- uh, which would've been the patient's right side

4 --

5 AD: Okay.

6 CM: -- [REDACTED]. Uh, Becky
7 was on her left side. And when I approached her she
8 was [REDACTED] -- it's gonna
9 be her left side, left abdominal, lower -- you know,
10 upper quadrant on her left side.

11 AD: Okay.

12 CM: So we were really kind of stunned at that matter
13 because we really didn't know what's on, because I
14 seen a little bit of blood on her left side from her
15 sleeve. And then we didn't really have a clue still
16 what was going on. And then it was a couple minutes
17 later we kind of took over everything, and Becky's
18 like, [REDACTED] So I was like holding
19 pressure. I was like, "I'll take over 'cause you
20 don't have any gloves on." Um, my lieutenant come
[REDACTED] up and automatically they said, [REDACTED] [REDACTED]

know who stated or whatever, "Oh, my God, we shot

her."

AD: You heard that? Okay.

CM: I was like, Okay. Well, now -- now we kind of -- in

my mind I'm thinking we have -- we have some -- I

mean, we have some knowledge right now she was shot.

Um, from the --

AD: How old was the -- the lady you're -- the -- the one

that you're helping? How old -- about how old was

she?

CM: Um, I -- I believe approximately 70 -- 70 to 73.

Seventy-two I believe was her -- I'm stating that

because I think heard she was 72, so --

AD: All right.

CM: -- from the patient.

AD: Do -- do you remember what she was wearing?

CM: Uh, the patient was wearing blue. It was almost

like BDUs, like hospital, um, pants. Um, actually

I'll -- I'll get on my story or whatever too on

that. But she was wearing, uh, hospital pants.

1 Basically they were very thin material. It was
2 almost like, uh, the stuff they wear for that. Uh,
3 she, uh -- I didn't see what she was wearing on the
4 outside, like a sleeve or whatever -- she had a
5 sleeve, but I couldn't tell you what it was because
6 her bra was exposed, uh, basically. And when we got
7 her from that point, uh -- if I go back to where we
8 took over -- and we got her, we picked her up at
9 that point and placed her on the stretcher. Once we
10 -- go ahead.

11 AD: I'm sorry. Did you see anything around her?

12 CM: Um, when I -- when I walked up to the patient, uh,
13 when I went around her to go around, I noticed that
14 there was a, uh, play -- looked like the play guns
15 or whatever that they use in defensive tactics --

16 AD: Okay.

17 CM: -- or whatever. Uh, that -- I noticed that to my
18 side. So basically I took that they were just --
19 you know, and the crowd of people that was to the
20 left-hand side, you know? And then I saw that, I
21 was like, Okay, they're doing scenarios or whatever.
22 So --

23 AD: Okay. Okay.

24 CM: Took us all by surprise 'cause we didn't hear
25 anything, you know, from here. So at that point,

1 uh, we -- [REDACTED] We had --
2 we had, um -- [REDACTED]
3 [REDACTED]. Uh, so it did I don't even know
4 [REDACTED] [REDACTED]
5 [REDACTED]. I had that turned around. So we
6 were actually loading her up. We try to -- placed
7 her on the side. I felt on her back side. I

14 -- once you guys got there, what happened there?

15 CM: Um, we went inside. [REDACTED]
16 [REDACTED] Um, we pretty much backed out. We
17 got her on the table and, uh, that was it. We --

18 AD: Okay.

19 CM: -- we transferred over care. Mike, uh, Medic Keeney
20 [REDACTED]

24 So we kind of backed up. And, um, that was it. And
25 the only thing that I can, you know --

1 AD: Do you know who the doctor was?

2 CM: No, sir, I don't.

4 CM: Yes, sir, I did. Uh, we had one of the, uh -- one
5 of the, uh, police officers escort us from the rear,
6 followed us to, uh, Lee Memorial.

7 AD: Do you know who that was?

8 CM: Uh, Kennedy.

9 AD: Okay.

10 CM: Yes, sir.

11 AD: All right. And then, um -- then what? You guys --
12 after you transfer care of her to the hospital, then
13 what?

14 CM: Um -- um, basically I went outside. Um, me and the
15 volunteer. I took the volunteer out with me. And
16 we went out and, uh, helped clean the Rescue up. ■

19 Basically cleaned up, wiped the whole Rescue and
20 everything down, got it ready to come back in
21 service, which wasn't gonna be ready for service
22 until they got here and then they got their
23 materials and stuff to get back in.

24 AD: Okay.

25 CM: So --

23 or --

24 CM: Okay. Yeah. Absolutely. When I, uh -- when we
25 were actually picking her up, um, I do remember

1 looking up at her husband -- was up -- up in the
2 front when we lifted her up. He was standing in
3 front of her. Um, he was along with one of the, uh,
4 Punta Gorda PD officers, and I don't know who that
5 would be. And, uh, he -- you know, the Punta Gorda
6 police officer told him, he said, "They're doing the
7 -- they're doing all they can for her." Um, he was,
8 of course, in an emotional state.

9 AD: Did he say anything to you?

10 CM: Uh, he didn't say anything at all.

11 AD: Okay.

12 CM: Um, they, you know, tried to escort him over or
13 whatever and they did a great job, though. They're
14 just, you know, trying to be helpful to him with all
15 that happened, so it just --

16 AD: Okay.

17 CM: And that's the only thing I can think of.

18 AD: Okay. Is there anything else? Anything else
19 (unintelligible)?

20 CM: I'm trying to remember if there was anything stated.

21 If I'm -- you know, give me time to -- I was --

22 AD: (Unintelligible).

23 CM: -- trying to go through it out there and --

24 AD: When -- when you guys went out there was, uh -- was
25 it -- how was the weather? Do you remember?

1 CM: Uh, it was -- it was cloudy outside.

2 AD: Okay.

3 CM: Uh, we -- we haven't -- you know, it started, uh,
4 sprinkling a little bit. Um, other than that, the
5 weather was just coming in, actually, and it --

6 AD: Okay.

7 CM: -- was just sprinkling a little bit.

8 AD: Okay.

9 CM: Um, I'm trying to think, you know, Becky being
10 there. Chief Tom Lewis was on the, uh, patient's
11 right side laying down.

12 AD: Okay. And --

13 CM: Saw the, uh -- the toy thing there. It was just
14 kind of -- it -- it just didn't come together.

15 AD: Was, uh -- was the toy -- was it, uh -- I don't know
16 if you know what the gun -- how it looks like -- was
17 the slide back or --

18 CM: It wasn't a slide back that I can, you know -- by
19 looking at it.

20 AD: Yeah.

21 CM: It just looked like it was just one of those
22 replicas --

23 AD: Okay.

24 CM: -- uh, basically just like you use in DT or whatever
25 from, you know, taking away or whatever.

1 AD: What's side of that --

2 CM: Disarm.

3 AD: -- what side of that -- was it on her, um --

4 CM: That would've been in front of her, uh, when she was

5 laying -- she was laying east and west, sort of --

6 AD: Uh-huh.

7 CM: -- from me.

8 AD: From your perspective?

9 CM: Yeah. From my perspective, east and west, and it

10 would've been on her east side of the patient --

11 AD: Okay.

12 CM: -- to where she was laying down.

13 AD: Okay.

14 CM: It was at her feet basically, approximately five

15 feet away from her --

16 AD: Okay.

17 CM: -- like down to the right-hand side.

18 AD: Okay.

19 CM: So --

20 AD: All right.

21 CM: -- kind of at an angle with the patient. So --

22 AD: Okay.

23 CM: -- um, someone had, you know -- as we were there and

24 stuff, all I said "Oh, my --" someone stated it at

25 that time and I don't know from the crowd who did,

1 "Oh, my God, we -- we shot her."

2 AD: When -- when someone said that, did they -- were
3 they yelling it, saying it at the top of their lungs
4 --

5 CM: No. No.

6 AD: -- or it was kind of quiet?

7 CM: It was just kind of quiet.

8 AD: Okay.

9 CM: And it -- it just -- from me, when we were, like,
10 picking her up, they're just like, "Oh, my God, we
11 killed her." I'm like --

12 AD: Okay.

13 CM: "We shot her." I'm like --

14 AD: Okay.

15 CM: And as we're walking to the Rescue I heard that and
16 I'm like, Oh, gosh.

17 AD: Okay. All right.

18 CM: So --

19 AD: Is -- is there anything else that you can think of
20 that I haven't asked you?

21 CM: I don't think so, Alberto. That's -- that was the
22 thing that come up.

23 AD: Okay.

24 CM: And that was it basically.

25 AD: All right. We'll this concludes, uh --

1 CM: Um --

2 AD: -- the interview. The ending time now is 9:39 p.m.

6 JC = Lieutenant James Tyler Canfield

7 AD: Today's date is August 9th, 2016. The time now is
8 approximately 8:52 p.m. Myself, Special Agent
9 Alberto Diaz with Florida Department of Law
10 Enforcement. I'm currently at the Punta Gorda Fire
11 Department, Station 1, located at 1410 Tamiami Trail
12 in Punta Gorda. Uh, I'm -- I am -- with me is Mr.
13 James Canfield. Uh, we are currently two inside of
14 the Fire Prevention office. Mr. Canfield, if you
15 could please state your -- your name and, uh, your
16 date of birth?

17 JC: Uh, name is James Tyler Canfield. I go by Tyler.
18 Um, date of birth is January 25th, 1987.

19 AD: Okay. And, um, do you know what perjury is?

20 JC: Yes, sir.

21 AD: All right. What is it in your own words?

22 JC: Um, falsifying information, misleading information,
23 something like that.

24 AD: Okay. What I need to do, just procedure-wise, I
25 just have to --

26 JC: Sure.

1 AD: -- swear you in. Okay?

2 JC: Okay.

3 AD: Please raise your right hand. Do you swear or
4 affirm that the statement you're about to give is
5 the truth, the whole truth and nothing but the
6 truth?

7 JC: I do.

8 AD: Okay. Uh, just basically tell me what occurred
9 tonight or what started --

10 JC: Okay.

11 AD: -- what you saw.

12 JC: So from start to finish, I guess, you know, um, we
13 were in -- in quarters in our station and a police
14 officer opened up our main front door and yelled,
15 "Somebody's down. We need some help." Um, we all
16 proceeded to go out there and he directed us towards
17 the back of our station, um, over by the gym area
18 where we saw a large crowd of people. Um, and there
19 was a few police officers down with somebody on the
20 ground. And as we were walking up we were told
21 that, uh, somebody had passed out and they needed
22 EMS. We walked over there with our stuff because it
23 was in the back of our station.

24 Um, we grabbed our medical equipment and walked
25 over to the back of the station where we found a,

1 um, female patient lying on the ground. Uh, she had
2 blood, you know, on her shirt. Um, when we were --
3 we were met and they said that, um, they think she
4 got scared and fell, um, and was hurt, and they
5 really weren't sure what quite all was going on. So
6 we began doing our assessment. We arrived on scene
7 with Rescue 32. Um, we began doing our assessment.

10 asked about, you know, what happened, they weren't
11 sure at that point if she had fell and landed on
12 something. Um, you know, it was still kind of hazy.
13 Everybody was kind of, you know, in a hectic

25 Um, we had the stretcher come out. We moved

1 her to the a backboard, put her onto the stretcher,
2 um, moved her in to that time -- um, it was stated
3 at that time that, um, they think that somebody --
4 she might've accidentally been shot. Um --

5 AD: Who -- who said that?

6 JC: Um, I'm not sure. I was focused on the patient when
7 I heard somebody saying that. When we walked up we
8 saw the -- one of those little blue guns on the
9 ground, a simulation training, so we were -- there
10 was talkin the scene area about simulation training.
11 Um, they thought the noise scared her is what they
12 thought scared her when she got -- when she fell.
13 Um, so as we were loading her up somebody said that
14 she may have been shot. Um, I'm unaware of who --
15 at that time we were -- again, we were focused -- I
16 was doing CPR myself, personally.

17 Um, we load her up, went into the back of the
18 ambulance. Um, we called for a trauma alert. Um,
19 we then began -- me and my crew, um, of, myself, um,
20 my partner who was the paramedic for the day, and
21 then also a volunteer, along with the two people
22 from Charlotte County, um --

23 AD: Who were they? Do you --

24 JC: Those -- uh, the Charlotte County was, um, uh,
25 Firefighter EMT Zach Maxfield and the firefighter

1 paramedic for the county was Michael Keeney. Um,
2 and then my partner was, uh, Firefighter Paramedic
3 C.W. McLeod.

4 AD: Okay.

5 JC: And a volunteer that we had, his name was Tyler
6 Goula [phonetic], I believe his last name is.

7 AD: Okay.

8 JC: Um, so we -- all three of us Punta Gorda guys,
9 myself, C.W. and Tyler, uh, Goula, all rode in the
10 back with Michael Keeney. Um, Zach drove to Lee
11 Memorial. Um, we call for a helicopter, they were
12 unable to fly, so it decided we were gonna ground
13 transport the patient. [REDACTED]

1 Um, I'm unclear of exactly what all they were, you
2 know, doing. At that point we kind of just -- just
3 kind of backed out and took our equipment out. Um,
4 and then once we were pretty much done there with
5 Lee Memorial, we kind of just decon'd, um, the
6 Rescue and stretcher like we would normally do, and
7 came back.

8 AD: Okay. What, um -- all right. Let's -- let's go
9 back --

10 JC: Sure.

11 AD: -- all the way to the beginning. Who was the, um --
12 do you know the officer that came out and came to
13 (unintelligible)?

14 JC: And got -- it was, uh, Officer Kelvin Jimenez, is
15 the one that came into the room to get us.

16 AD: All right. Officer Kelvin Jimenez?

17 JC: I think it's K-E-L-V-I-N.

18 AD: Okay. And then he said -- so he came to the back of
19 the fire station.

20 JC: He came through -- through our side door and kind
21 of, you know, slammed the door open and said, "Hey,
22 we need EMS out here quick." Somebody, um, passed
23 out or a person down, something of that nature. Um,
24 and while we were walking out there with our gear it
25 was said that, you know, she passed out and fell on

1 the ground.

2 AD: Okay. And then -- so, um -- so you and the other
3 four walked out there or ran out there?

4 JC: Yeah.

5 AD: Okay. And then what did you see when you walked up?

6 JC: As we -- as we approached the scene, again, there
7 was a large crowd out there. Um, I'm unaware
8 whether it was -- it seemed to be like some public
9 demonstration, education event, maybe, of some kind.
10 Um, there was a group of, uh, just people. Um --

11 AD: How many you think?

12 JC: Forty-ish, maybe. Um, it was a large group.

13 AD: Okay.

14 JC: There was a couple officers that were with that
15 group, kind of separated from where the actual call
16 was.

17 AD: Uh-huh.

16 JC: No, I think that's pretty much, you know, kind of a
17 -- a basic start to finish, you know, without
18 getting in-depth with, you know, medical procedures

20 what we heard, um --

22 JC: So that's a pretty accurate description, I believe,
23 from start to finish.

25 police officer saying, "This is a possible gunshot

1 wound."

2 AD: Okay.

3 TG: Um --

4 AD: All right.

5 TG: -- and I -- I -- that's all I can remember about
6 that.

7 AD: Okay.

8 TG: That's pretty much it.

9 AD: Is there anything that I haven't asked that -- which
10 we didn't cover or think of?

11 TG: I mean, not off the top of my head. No, sir. Not
12 that I can think of.

13 AD: Okay. All right.

14 TG: I think -- I think I've covered it to the best of my
15 ability.

16 AD: All right. Well, this concludes the interview. The
17 time now is, uh, 10 p.m.
