OTHERS PRESENT: Marian Pace (MP)

Meeting began at 10:01 a.m.

Roll Call

MP advised the meeting was being recorded, no public input will be allowed and all member agreements were received.

MP asked the committee members if they have been contacted by an Offeror regarding this solicitation. All members responded they have not. MP advised all committee member agreements have been received.

Public Comment – MP advised public comment is allowed but may not have discussion with the committee members. MP asked for public comment 3 times.

HM nominated DD to chair the committee, LF seconded, DD accepted, all are in favor.

MP reviewed Procurement's pre-qualification efforts:

- Discuss Procurement Pre-Qualification Efforts
 - 2 submittal packages were rejected:
 - SunTrust Did not meet the minimum qualification requirement for courier services for pickup of deposits
 - Wells Fargo Did not complete the City's proposal schedule R2016108E1 They submitted in their own format. There were also other sections that were required but not submitted.
- Submittal Packages deemed responsive for evaluation: Bank United, Centennial and FL Community Bank

MP reviewed the evaluation process.

- All independently evaluated
- Based on member discussion members may adjust their scoring
- Member may motion to accept the short list as presented or;
- Member has the right to request reranking either by applying ordinal scores or group consensus

Committee discussed each Offeror's submittal package. MP requested any additional comments. MP asked if any member wants to change their independent scores based on discussion. LF requested to change a score. MP updated LF score to reflect the change.

MP read into the record the ordinal scores of the offerors for each member, the committee ordinals scores for each offeror and ranking of offerors.
