Roll Call

AH advised the meeting was being recorded, no public input will be allowed and all member agreements were received.

AH asked the committee members if they have been contacted by an Offeror regarding this solicitation. All members responded they have not.

JL nominated JH to chair the committee, LD seconded, JH accepted, all are in favor.

AH reviewed Procurement's pre-qualification efforts and reported all Offerors were responsive, met minimum qualification requirements and were qualified for evaluation. AH reviewed the evaluation process.

Committee discussed each Offeror's submittal package. AH requested any additional comments. AH asked if any member wants to change their independent scores based on discussion and they did not.
