

# WEEKLY HIGHLIGHTS REPORT JULY 26, 2019

# City Manager

- Seawall Restoration Reimbursement The City received an additional \$800,000 in reimbursement from FEMA and the State of Florida for work completed in restoring seawalls damaged during Hurricane Irma. This brings the total reimbursement to-date at \$20.4 million.
- County Commission Community Redevelopment Area Update City Manager provided the Charlotte County Commission with an overview of the Punta Gorda Community Redevelopment Area (CRA) financial position and multi-year fiscal forecast. The Commission focused on property tax revenue, debt payments for Laishley Park and Herald Court Centre and when the debt will be retired. Per agreement with the County Commission, the Punta Gorda CRA will sunset once property tax revenue from both the County and City are sufficient to make the final debt payment, which is currently projected to be around 2028.
- Citywide Master Plan Draft Presentation Aug. 21 at 5 pm Dover Kohl & Partners will present the Draft Citywide Master Plan to the community at the Charlotte Harbor Events Center. Registration is not required and Punta Gorda stakeholders are welcome.
- Strategic Planning City Council and staff will host a strategic planning session on Aug. 28 at 5 pm at the Punta Gorda Isles Civic Association to gather stakeholder input for the FY2020 Strategic Plan. All community stakeholders are welcome to participate.
- 1% Sales Tax Committee The committee met on Jul. 19 to begin discussions about project recommendations for future sales tax revenues. Conversations focused on necessary project information and format the committee needs information to be presented in to make informed decisions. Beginning discussion about creating a process for introducing additional project suggestions for consideration also took place. Staff is putting together the requested information regarding sales tax projects, already in progress, in advance of the Sept. meeting.
- Waffle House On Monday, the Building division issued a permit for the Waffle House restaurant to be constructed at the corner of US41 and E. McKenzie Street (1228 Tamiami Trail). This project was brought to the Development Review Committee and approved in the fall of 2016.
- Buckley's Pass Payments totaling \$1,886,192.24 have been received through and including
  Jul. 25. The City will process a change order on the contract due to supply sourcing delay. The
  new completion date is estimated to be early Feb. Project updates can be found at

- **Pavement Rejuvenation** Beginning the week of Aug. 1 through Aug. 8 (weather and equipment operations permitting) Pavement rejuvenation application is scheduled on the following roadways:
  - 1. Cooper St. from Airport Rd. to Taylor Rd.
  - 2. Marion Ave. from Tropicana to DiVinci Dr.
  - 3. Trieste Dr. from Palermo to the cul-de-sac
  - 4. Portofino Dr. from Monaco Dr. to the cul-de-sac
  - 5. Palermo Dr. from Portofino Dr. to the cul-de-sac
  - 6. Henry St. from Shreve St. to Garvin Dr.
  - 7. St. Girons Ct. from St. Girons Dr. to the cul-de-sac
  - 8. St. Girons Dr. from Madrid Blvd. to the cul-de-sac
  - 9. San Pietro Ct. from Madrid Blvd. to the cul-de-sac
  - 10. Licata Ct. from Monaco Dr. to the cul-de-sac
- Alligator Creek pedestrian bridges along US41 NB-FDOT Right of Way The Media Release has been prepared notifying the public that the US 41 Multi-use trail will be closed for the contractors work starting Aug. 5, until further notice. The work area will be north and south of the north fork Alligator Creek Bridge. Pedestrians are requested to seek alternate routes. The next Bi-weekly meeting is scheduled on Aug. 12 at 10 a.m.
- Citywide Drainage Swale Regrading To date JRL Underground has completed work at 442 properties totaling 326,750 square feet of grading/sodding. Sodding was completed this week at 123-137 Acalypha, 7417-7447 S. Blue Sage and 335 W. William, Excavation and grading is underway at 7131-7191 N. Plum Tree and will then move to locations on Schefflera in Burnt Store Meadows.
- Harborwalk at Justice Center boardwalk & Pier at Adrienne St. Five pilings will be repaired at Adrienne St. pier. Sixteen pilings will be repaired on the boardwalk near the justice center. Work is expected to take 30 days. Users may experience intermittent closures.
- Goldstein Street Bricking between Marion and Olympia Ave. The contractors schedule has been impacted due to: weather, high water table and equipment break down. Pending is an updated schedule for work to resume.
- **ADA Interior Signage & Wayfinding** Staff attended a pre-submittal meeting on Jul 23. Submittals are due Aug. 5.


#### Canal Maintenance

• An estimated 52,936 feet of seawall was damaged during Hurricane Irma. There has been a 4.5% length increase of replaced seawall due to unforeseen damage. The additional damage brings the estimated total up to 55,335 feet. To date, 99.5% of this seawall has been replaced with new wall; 94.7% of the project has been closed out with grading and sod complete. The current combined pace (three month average) of the contractors is 1,770 feet per month. Crews also filled 36 depressions in PGI and three seawall caps. Table 1 represents the progress made in each of the zones. ## **Water Safety**

According to the USA Swimming Foundation (USASF), Florida leads the nation with the most child drownings in 2017 with 51 fatal child drownings in pools or spas. Drowning is considered the leading cause of unintentional death for children between ages 1 and 4 nationwide. So how do we decrease the chances of child drownings?

The following safety tips offer recommendations to keep children safe:

- USASF states swimming lessons can reduce the likelihood of drowning by 88% but other safety precautions should also be taken
- Never take your eyes off your children while in or around water even if they are wearing a life vest, water wings (inflated arm rings) or using innertubes.
- Properly fitted life vests should be worn by children when boating
- Never become distracted by cell phones, computers or books
- If you have a child who can't swim, keep them within arms reach when in the water
- Ensure pools are properly secured with a fence or cover so children cannot wander into the pool unintentionally.
- Empty all tubs, buckets, and kiddie pools immediately after use
- Learn CPR by reaching out to the Punta Gorda Fire Department at 941-575-5529, where classes are offered quarterly at no cost

### **Water Treatment Plant Operations**

- 41.7 MG of water was delivered to the distribution system with a 5.9 MG daily average
- Peace River Manasota regional Water Supply Authority Emergency Interconnect Sending water at a rate of .5 million gallons per day, started Jul. 16.
- Rainfall in Jul. 2018 6.80" and Jul. 2019 7.8"
- Hardness is a measurement of calcium and magnesium ions naturally occurring in the raw water. Current Condition "hard" – Grains of Hardness 10 ppm – Total hardness 171 ppm
- TDS for Jul. 25 Current 363 ppm, Low 220 ppm, High 512 ppm, Year Avg. 380 ppm
- Reservoir Jul. 25 Current 5.52', Record Low 4.99', Record High 6.63', Year Avg. 5.49'

#### **Water Distribution**

• City of Punta Gorda Water Distribution Division forces have taken over completion of the AMI meter change out program. Last week crews changed out 16 meters with the new AMI meters. Of the 13,204 total water meters in the city, only 24 remain (residential and approximately 8 large commercial meters) to complete the project. The project is 99% complete.

#### Current Board & Committee Vacancies (Volunteer Appointment Information Form)

- Historic Preservation Advisory Board (One alternate vacancy) Meets the 4th Thursday at 9 a.m. in City Council Chambers. Must be City resident. Seven member board with two alternate members. Three year terms maximum of three terms. Identifies for the City Council historically significant structures and sites that should be considered for designation as a "Local Historic Landmark" or be nominated for listing on the Florida Master Site File and the National Register of Historic Places. Makes recommendations of the policies for the protection of historically significant structures and sites. Makes recommendations to staff with regard to certificates of appropriateness for any demolition, variance, sign or relocation of structures. Promotes public awareness of historic archaeological preservation and its community benefits.
- Punta Gorda Housing Authority (One resident Commissioner vacancy) Meets the third Thursday at 8:30 a.m. at the PGHA Community Room, 340 Gulf Breeze Avenue, Punta Gorda. Must be a resident of Charlotte County. At least one commissioner shall reside within the Housing Authority's jurisdiction and receive rent subsidy through a program administered by the Authority. Seven member board. Four-year terms no maximum. Financial disclosure required. The mission of the Housing Authority is to provide decent, safe and sanitary affordable housing.
- Utility Advisory Board (One vacancy) Meets the fourth Monday at 9 a.m. in City Council Chambers. Must be City resident. Seven member board. Three-year terms, maximum of two terms. Makes recommendations to City Council with regard to, but not limited to, revisions to the utility construction standards, alleged billing discrepancies and review of utility drawings.
- Board of Zoning Appeals (One vacancy) Meets the 4th Tuesday at 4 p.m. in City Council Chambers. City residency required. Seven member board with two alternate members. Three year terms maximum of three terms. Financial disclosure required. Makes recommendations to City Council on variances to City Code.
- Code Enforcement Board (Two vacancies) Meets the 4th Wednesday at 9 a.m. in City Council Chambers. Must be City resident. Seven member board with two alternate members. Three year terms maximum of three terms. Hears and decides alleged violations of the City Code of Ordinances.
